The SEC recently approved amendments to Regulation Crowdfunding in which the fundraising limit for crowdfunding issuers will be increased from \$1.07 million during a 12-month period to \$5 million during a 12-month period. These amendments will take effect 60 days after the publication in the Federal Register. The Company reserves the right to increase the Maximum Fundraise Target once such amendments take effect. If the Company increases the Maximum Fundraising Target, investments made prior to such limit increase may be diluted accordingly.

Availability of raw material is a risk. If we are unable to procure raw materials in a timely manner, this would impede our ability to meet customer demand.

We face geopolitical risk--tariffs, political trade restrictions, and changes in currency exchange rates may negatively affect our margins or our supply chain.

New competitors, especially bigger companies with that are well capitalized, could enter the market and reduce our marketshare.

Shipping industry changes can negatively impact us, which could reduce our margins or ability to ship timely to our customers.

There are different and changing IP laws within countries and territories that we operate, which may affect our marketshare in these areas.

If we are unable to execute as planned on our goals and new initiatives, we will not be able to meet our projections.

While we have insurance, if customers are hurt using our product, we may face lawsuits. These lawsuits, even if they're not substantiated, could negatively affect our public image.

Customer sentiment is a risk. Market demands can change related to fitness and resistance training, which would impede our customer acquisition.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our

business.

Investors in the first \$250,000.16 of the offering will receive units at a price per share of \$13.01, and a pre-money valuation of \$13,010,000.00

The campaign maximum is \$1,069,987.46 and the campaign minimum is \$500,014.76.

Investor Rights; Additional Rights of All Investors.

(a) Confidentiality. Anything in this Agreement to the contrary notwithstanding, no Major Investor ("Major Investor" is any person or entity which has invested \$100,000.00 or more) by reason of this Agreement shall have access to any trade secrets or confidential information of the Company. The Company shall not be required to comply with any information rights in respect of any Major Investor whom the Company reasonably determines to be a competitor or an officer, employee, director or holder of one percent (1%) or more of Preferred or Common Units, stock, stock options or warrants of a competitor. Each Major Investor agrees that such Major Investor will keep confidential and will not

disclose, divulge, or use for any purpose (other than to monitor its investment in the Company) any confidential information obtained from the Company pursuant to the terms of this Agreement other than to any of the Major Investor's attorneys, accountants, consultants, and other professionals, to the extent necessary to obtain their services in connection with monitoring the Major Investor's investment in the Company.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those

rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. Overview

We help people live better lives through health and fitness. Founded and headquartered in Hawaii, we have expanded our footprint to three other countries and have another 7 on our roadmap.

In 5 years we hope to be established in 10 countries, sharing our brand of health and fitness through the lens of Hawaiian culture. These projections cannot be guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Hele Fitness LLC was incorporated in the State of Hawaii in December 2016.

Since then, we have:

- Over 400% Revenue Growth and Profitable since 2017.
- The 'At Home Fitness' movement was accelerated by COVID, established as the new preferred
- A booming market expected to \$25B by 2025
- Growing Global Footprint - Currently established in 4 Countries and Expanding
- Founding Team comprised of former college/pro athletes, coaches, and fitness professionals.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2019, the Company had revenues of \$536,058 compared to the year ended December 31, 2018, when the Company had revenues of \$322,067. Our gross margin was 26.95% in fiscal year 2020, compared to 17.46% in 2019.
- *Assets.* As of December 31, 2019, the Company had total assets of \$98,407, including \$53,037 in cash. As of December 31, 2018, the Company had \$37,388 in total assets, including \$13,809 in cash.
- *Net Income.* The Company has had net income of \$47,101 and net income of \$22,201 for the fiscal years ended December 31, 2019 and December 31, 2018, respectively.
- *Liabilities.* The Company's liabilities totaled \$171,784 for the fiscal year ended December 31, 2019 and \$48,628 for the fiscal year ended December 31, 2018.

Liquidity & Capital Resources

To date, the company has been financed with a \$100k revolving line of credit.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Hele Fitness LLC cash in hand is \$450,000, as of March 2021. Over the last three months, revenues have averaged \$330,000/month, cost of goods sold has averaged \$171,600/month, and operational expenses have averaged \$56,100/month, for an average net margin of \$102,300 per month. We are currently profitable.

Since the date of our financials, we have won Hawaii's fastest growing company, with a over 400% growth rate; as of October 2020, we have generated more profit than the revenue in 2019.

In 6 months, we hope our monthly revenues to remain at about \$330k/month and expenses will be \$200k/month, although this cannot be guaranteed.

Outside of the funds raised in this Offering, we can rely on the profits of our business since we have been profitable for 3 years. Additionally, we have \$500,000 in manufacturing credit and another \$100,000 line of credit we can rely upon.
