The company does its best to DD (due diligence) dealerships and regional lenders before letting them join the network. However, if despite best efforts, they do submit fraudulent paperwork such as selling cars that they don't actually have on their inventory and taking out loans on such cars, then there will be adverse impact on the ecosystem.

Growing the ecosystem depends on success with key partnerships: maintaining partnerships such as with incubating partner Signal Auto, growing partnerships with 10x and its financial network, and securing strategic partnerships with other stakeholders such as floor planning companies and Dealer Management Systems (DMS). Should these partnerships not work out, then they can have varying impact on our growth.

Being able to secure access to capital, both as takeout for the auto paper originated through the platform by dealers, as we all for the platform's Revenue Share / Loan Participation program (for short-term loan warehousing/aging) is a key component of revenue growth. While we already have an existing network of takeout partners and continue to add more to our network, should there be a sudden drop in liquidity, then Automatic revenues will be impacted.

As we facilitate loans through our platform, we get access and store many sensitive consumer data, including SSN and proof of income. We only contract with the top tier vendors (such as Amazon) to protect this data, periodically conduct penetration / compliance tests, and will pursue compliance with

additional security standards. However, in the event of an unlikely data breach, then confidence in platform will be negatively impacted.

CV19 and its impact on consumer spending habits, the transformation of the independent dealer space, and general auto industry is still a fluid situation. While we have made every attempt to model these changes and see these changes as both supportive and a driving force of adoption for our platform, there can be unforeseen tail-risk changes. For example, independent dealers may struggle to adapt and consolidate / go out of business. Consumers may no longer purchase used cars due to incentives from the majors (GM, Toyota, Honda, etc.) or due to ridesharing services.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

We connect borrowers and lenders in the \$1.3 trillion used car space. Our FinTech platform brings together many different tools and features in one easy-to-use app, drastically improving the customer experience for both the used car buyer and the finance and insurance manager.

In 5 years, we expect to have a significant amount of the loan volume for pre-owned vehicles coming through our platform. At that point, we should be the preferred platform by which independent dealers get their loans, approvals, and ancillary products. We also expect to have far surpassed the product offerings, as well as user and customer experience of any platform originating loans in the market.

Milestones

Loan Automatic, LLC was incorporated in the State of Delaware in January 2020.

Since then, we have:

- FinTech platform with 965+ dealership partnerships, growing at 40% MoM despite COVID19.
- Developed with licensed lender (Signal Auto Group): 13 yrs of experience, 1.7k dealers in 13 states.
- Answering a clear need in a \$1.3 trillion industry that stopped evolving in 2004.
- Automatic translates to an 87.5% approval time reduction & 75% data entry time reduction.
- Team has over 80 years of combined experience in FinTech, lending, and the auto industry.
- Auto loans make up nearly 10% of all household debt, behind only mortgages and student loans.

Historical Results of Operations

Our company was organized in January 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$40,798 compared to the year ended December 31, 2020, when the Company had revenues of \$32,808.

- *Assets.* As of December 31, 2021, the Company had total assets of \$879,721, including \$11,845 in cash. As of December 31, 2020, the Company had \$695,184 in total assets, including \$382,108 in cash.

- *Net Loss.* The Company has had net losses of \$940,207 and net losses of \$53,088 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.

- *Liabilities.* The Company's liabilities totaled \$1,810,351 for the fiscal year ended December 31, 2021 and \$685,607 for the fiscal year ended December 31, 2020.

Liquidity & Capital Resources

To-date, the company has been financed with \$600,099 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 36 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Loan Automatic, LLC cash in hand is \$155,263, as of June 2022. Over the last three months, revenues have averaged \$25,000/month, cost of goods sold has averaged \$1/month, and operational expenses have averaged \$27,600/month, for an average burn rate of \$2,601 per month. Our intent is to be profitable in 6 months.

There are no material change in operations. The expenses are pretty much spot on as of 06/30/22.

We are in the midst of a 2.5 Million dollar Seed Round that will allow us to activate large scale relationships. We are confident we will achieve profitability due to the conclusion of the Seed Round and activating these partnerships.

No, we are not profitable. Revenues has been increasing strongly as we just had our highest revenue generating month ever in March 2022. We expect to become Profitable by Q2 of 2023 due to the activation of large counterparty relationships.

The founders and their resources can be activated given the proper incentives; furthermore, financial institutions LOCs can be activated.

Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team. As compensation for its voting services, each Investor authorizes XX Investments to distribute to XX Team 10% of any distributions the investor would otherwise receive from the Company. The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities.
