Natural disasters and other events beyond our control could materially affect us.

Natural disasters or other catastrophic events may cause damage or disruption to our operations, international commerce and the global economy, and thus could have a strong negative effect on us. Our business operations are subject to interruption by natural disasters, fire, power shortages, pandemics and other events beyond our control and could make it difficult or impossible for us to deliver our services to our customers and could decrease demand for our services. Our business model involves the marketing of entertainment, including movies and other content. To the extent, the entertainment industry is impacted by either the ability to create new content (e.g., the halting of productions) or the ability to monetize the content (e.g., theater sales), our business prospects could be severely hampered.

In addition, as an early stage startup, we rely on investments to fund our operations. To the extent our investment flow is interrupted by disasters and/or the effect the have on the economy, our ability to maintain operations could be severely hampered.

In December 2019, a novel strain of coronavirus, COVID-19, was reported in Wuhan, China. The World Health Organization has since declared the outbreak to constitute a pandemic. The extent of the impact of COVID-19 on our operational and financial performance will depend on certain developments, including the duration and spread of the outbreak, its impact on the global economy as well as the impact on our current and potential investors, customers, employees, vendors, and industry events, all of which are uncertain and cannot be predicted. At this point, the extent to which COVID-19 may impact our financial condition or results of operations is uncertain. If the COVID-19 outbreak continues to spread, we may need to further limit operations and/or substantially modify our business practices.

Immortal Studios is a new company with little history to evaluate.

Immortal Studios was incorporated in June 2020. It is a startup company. Some of our operating processes are still being defined including our content and distribution operations. We are currently not a profitable company. Operating models and revenue models are subject to change.

We anticipate needing to raise more money in the future

Even if the Company raises the entire round successfully, we may need to raise more money in the future that may result in your investment being worth less because of the terms of future rounds.

Entertainment is a highly competitive market and success is unpredictable

Our success depends on very subjective criteria. Viewer tastes, trends, preferences, and behavior frequently change and are difficult to predict. The entertainment industry is highly competitive and consumers have many choices. We compete with top Hollywood studios and other creators of premium content. While our content offering is unique, there are no inherent barriers to other competitors competing in our space. We may not be able to develop projects that become profitable. Similarly, entertainment projects are inherently hard to predict and sometimes run over budget. Even successful projects sometimes take a long time to realize profits.

Our business model is largely reliant upon third-party partners whose business

practices we do not control.

Our success in developing, producing, and monetizing content relies heavily on third-party partners. If these partners have unforeseen circumstances of change in business practice, operations, terms, etc. we might be forced to change our own plans and assurances. These partners include crowdfunding partners like Kickstarter, distribution partners like Comixology and Webtoon and other technology, distribution, manufacturing and operation partners.

We depend on a small team and may need to hire more people to be successful.

Our business is dependent upon hiring talented individuals both in full-time capacities and on a contract basis. For the foreseeable future, our creative teams will be comprised of contract hires and their availability is subject to uncertainty. It is sometimes the case that the hiring of creative talent is a very difficult process and requires multiple iterations. As currently comprised, our team is very small and the loss of any single individual could hamper, delay or alter our current strategy and practices.

We may not be able to protect our intellectual property

Our profitability may depend in part on our ability to effectively protect our intellectual property including our trademark and logo, original entertainment content in our projects and our ability to operate without inadvertently infringing on the proprietary rights of others. Theft of our original entertainment content prior to release could adversely affect our revenue. Policing and protecting our intellectual property against piracy and unauthorized use by third parties is time-consuming and expensive and certain countries may not even recognize our intellectual property rights. Any litigation protecting our intellectual property and defending our original content could have a material adverse effect on our business, operating results and financial condition regardless of the outcome of such litigation.

The company intends to use a significant portion of the proceeds from the offering for unspecified working capital.

The offering proceeds will be used by the Company in the ways management deems most effective towards the Company's goals. This means that although we definitely have plans for the proceeds (focused on sales, marketing, and product development) the Company will have ultimate discretion to use the proceeds as it sees fit and the Company has chosen not to limit the Company's use of the funds to specific uses that investors could evaluate. Such portion of the proceeds from this offering will be used for the purpose that the company's management deems to be in its best interest in order to address changed circumstances or opportunities. As a result of the foregoing, the Company's success will be substantially dependent upon its discretion and judgement with respect to application and allocation of such portion of the proceeds of this Offering.

Equity crowdfunding is new.

Existing funding and future fundraising plans (including this round) are reliant on equity crowdfunding and provisions of the JOBS Act which have been in effect for a short period of time. Secondary markets don't exist yet, and may not exist for some time (or ever), which hampers the ability for investors to sell their shares. The laws are complex, and interpretation by governing bodies doesn't exist in some cases and may change over time in others. Changes to the laws (or interpretation of the laws) could impact our ability to raise money as well as your ability to trade your shares.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Use of Proceeds: 30% to content production (including development) to launch additional comic book titles and digital video content; 25% to marketing and business development, including Kickstarter campaigns and fees, opening sales channels through book stores and digital platforms; 24.5% to convert part-time employees to full-time employees and hire additional staff; 13% to technology initiatives; 7.5% to WeFunder

THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving Preferred Stock, investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

1. the total value of the investor's investment, divided by
 1. the price of Preferred Stock issued to new investors multiplied by
 2. the discount rate (80%), or
2. if the valuation for the company is more than \$18,000,000.00 (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the discount rate (80%), or

2. the total amount of the Company's capitalization at that time;
3. for investors up to the first \$100,000.00 of the securities, investors will receive a valuation cap of \$15,000,000.00 and a discount rate of 80.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive proceeds equal to the greater of

1. the Purchase Amount (the "Cash-Out Amount") or
2. the amount payable on the number of shares of **Common Stock** equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating **Preferred Stock**. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred **Preferred Stock**, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred **Preferred Stock**, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred **Preferred Stock** in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

Peter Shiao owns 63% of the common shares directly, and also has effective control of the two other shareholders, Immortal Studios Limited which owns 18% of the Company, and Orb Media Holdings which owns 9% of the company. We hope to have an active comics first hub with over 50 titles published and a robust subscription-based business there, and to have successfully delivered multiple episodics, films, and immersive content that is now driving us into lifestyle and other related verticals. These are forward looking projections and are not guaranteed. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$21,000/month, for an average burn rate of \$21,000 per month. Our intent is to be profitable in 30 months.

Since June 23, 2020, Immortal Studios Ltd. (a Hong Kong company) loaned the Company an additional \$87,718 to fund the company's operating needs. Since then, the company has spent ~\$60,000 of that financing on operating the business and IP development.

In the next 6 months, we hope to achieve revenues of \$70K to \$100K in total, deriving from two additional Kickstarter campaigns in which we sell our product. We anticipate expenses of around \$126K in total, with average monthly expenses of \$21K. We are already operational and can begin generating significant revenue with \$50K in total.

We've done a Kickstarter campaign with revenues of \$35K. Those funds have just recently been disbursed to us. We will be conducting another Kickstarter campaign in the next few weeks, and hope to run 2 in total over the next 6 months. Throughout the Wefunder campaign, we will continue funding ourselves with the Kickstarter funds and, if necessary, a loan from an existing shareholder. Bank financing and/or any other related SBA programs are also possibilities.
