Marketing is an unpredictable beast. We are a marketing-based company and plan to offset that risk by delving into wholesale B2B sales with the funds from this raise, however, marketing is incredibly fluid at this time and it presents risk as well as reward, particularly during COVID. With that said, we have seen our business deemed an essential business during COVID and that bodes well.

COVID itself is a risk. We see the potential for problems all around and we acknowledge that we must stay ahead of changes so we ensure maximum available output for the company.

We need to constantly ensure we remain aware of shipping regulations involving alcohol. It is an ever-shifting landscape and running up against those risks is a reality we work hard to remain on top of.

A very real risk we've felt since our founding is moving too slowly for the pace of the market we're in. If we can move quickly enough, we can capture a massive win as the market is opening up, but we are not the only ones in our space. We must act before other companies can take our traction. Our company is the only one like it in the deodorant space and we need to capitalize on our uniqueness so we can make the biggest waves. For that, we need expediency.

Growth is difficult for companies, as we grow, we are being mindful of our culture and aware of the fact that growth is hard on company culture. We want to alleviate those risks with guidance from those who've gone before us and we're working with TrueSpace to ensure we can make the most of the growth potential we have.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have

no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

1. the total value of the Investor's investment, divided by
 1. the price of Preferred Stock issued to new Investors multiplied by
 2. the discount rate (90%), or
2. if the valuation for the company is more than \$5,800,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company's capitalization at that time.
3. for investors up to the first \$450,000.00 of the securities, investors will receive a valuation cap of \$4,250,000.00 and a discount rate of 90.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Stock, Investors will receive proceeds equal to the greater of

1. the Purchase Amount (the "Cash-Out Amount") or
2. the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and

2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

- b. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations

or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. For example, the **shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The **shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The **shareholders** have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional stock, an Investor's interest will typically also be diluted.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

Overview

Pit Liquor, a brand by Distilled Body, is a deodorant made from whiskey and vodka. Most "natural" deodorant companies aren't actually natural. These stinkin' liars covertly add in chemicals, shame you with detoxing myths, and give you a load of BS BO excuses. We decided to do things differently, refreshing the way natural deodorant should be with revolutionary, stink-fighting formulas. In 5 years we plan to have sold the company. Since before our formation, we wanted to hit the exact trajectory we've leveled these past three years, and we look forward to crushing our goals going forward. We plan to exit for \$100M in 3 years. We are beginning to work with TrueSpace and investment banking teams to get those relationships set up correctly early and to stay on our game for scaling.

Milestones

Distilled Bath and Body, Inc. was incorporated in the State of Delaware in

November 2020. The company was originally organized as an LLC in 2017.

Since then, we have:

- 3x year-over-year growth in revenue since 2017.
- 86% profit margin = built for scaling.
- Wholesale partners include Nordstrom, Urban Outfitters, Faire, Alossa on Amazon, and more.
- \$6B US deodorant market, 12% CAGR for natural which overtakes traditional deodorant.
- 100% natural, eco-conscious, food-based.

Historical Results of Operations

Our company was organized in November 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2019, the Company had revenues of \$287,521. For the period ended December 31, 2018 the Company had revenues of \$84,654. Our gross margin was 66.64% and 39.9% respectively.
- *Assets.* As of December 31, 2019, the Company had total assets of \$12,896, including \$5,074 in cash. As of December 31, 2018, the Company had total assets of \$16,044, including \$14,726 of cash.
- *Net Loss.* The Company has had net loss of \$110,202 for 2019 and \$50,712 for 2018.
- *Liabilities.* The Company's liabilities totaled \$230,298 for 2019 and \$61,327 for 2018.

Liquidity & Capital Resources

To-date, the company has been financed with \$191,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Distilled Bath and Body, Inc. cash in hand is \$60,000, as of November 2020. Over the last three months, revenues have averaged \$63,568/month, cost of goods sold has averaged \$25,306.24/month, and operational expenses have averaged \$56,113.67/month, for an average burn rate of \$17,851.91 per month. Our intent is to be profitable in 6 months.

In the second half of 2020, we have seen a dip in sales because of election ad buying that hurt all online businesses, and since the election, we have seen recovery. We hired Raindrop Marketing and their marketing has been profitable.

Our financials cover our entire history, however, we have made massive changes to our accounting this year due to finally having enough revenue to improve our accounting practices. Former accounting was done by the cheapest accountant we could find, but often there were errors and frustration. In June 2020, we began a relationship with Simple Startup for our accounting and have been working with them to get more accurate financials.

2021: Q1 Anticipated (not guaranteed) revenue: \$500K

2021: Q2 Anticipated (not guaranteed) revenue: \$712K

I hope to grow at a rate of 20% MOM for the next year, implementing new marketing tactics through Raindrop and implementing outside sales strategies for the first time ever in our history.

Expenses are expected to skyrocket at the outset of funding as we take on new people and make bold moves, but within six months, those expenses will hopefully be covered by our growth.

We will take on new employees immediately upon funding and we will crank up ad spend once the algorithms are able to create fully profitable churn on ads. Right now, our ads are growing and preparing to scale. We will be well positioned to expand rapidly as soon as funding is obtained

We see strong growth when we are able to channel money into marketing. We are getting positive traction, but we also are making some changes to our team in-house. So in short, there are vast changes, and we are making fast moves now to lean into profitability

I expect to be able to pay off all expensive loans when we close funding and we will take on some new employees. We will crank up ad spend once the algorithms are able to create fully profitable churn on ads, and from there, we expect (but cannot guarantee that) trajectory will be highly positive. We were profitable for the majority of this year, and with growth, we hope to be there again. The election-caused retraction hit our profitability, but it is recoverable. In the next year, we hope to hiring a CFO to help manage cash-positive financials as we are reaching a place of desperate need for such services. These future looking projections cannot be guaranteed.

In terms of other available capital, we have a loan we can take from Shopify for

\$98K, but it is a rough loan with a payout of 17% daily revenue until it is paid back, so we're exploring all other options and keeping spend as low as possible in the meantime. We're excited to accelerate ad spend and bring on new team members with this funding round!

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf.
