8. Discuss the material factors that make an investment in the issuer speculative or risky:

Pandemic - Restaurants are struggling to recover from the pandemic as patrons begin to return, although those with an established delivery/to-go capability like Soul Slice have had an advantage. Due to concerns about the Delta variant, these conditions are likely to continue through 2021.

Startup - Although we've created successful restaurants and startups before, Soul Slice commenced operations on in June, 2021, and has a limited track record of operations. The first location is not yet at breakeven, but, at the current sales growth rate, is projected to cross over to breakeven in August, 2021. The sales growth rate could slow, causing a delay in reaching and surpassing breakeven.

Key man liability - Karter Louis is the architect of our unique approach to sourcing, menu, brand experience, employee skills and wealth building, and of the replicability of the model. As such, Soul Slice has engaged two advisers who have the background and experience to ensure that the plan can be fully implemented in his absence if every needed. Manager level staff members in the first location are learning the system, and will be an asset in that event as well.

Recruiting - We compete within the food service market and the quick service restaurant sector not only for customers, but also for employees. Our full-time salaries and benefits are a draw relative to competing QSR jobs, however tight labor markets could affect our ability to grow.

Training - Our model has a strong training and personal development component which could make personnel costs higher than other fast casual restaurants.

We are an emerging growth company, and, for as long as we continue to be an emerging growth company, we may choose to take advantage of exemptions from various reporting requirements applicable to other public companies but not to "emerging growth companies," including: not being required to have our independent registered public accounting firm audit our internal control over financial reporting under Section 404 of the Sarbanes-Oxley Act; reduced disclosure obligations regarding executive compensation in our periodic reports and annual report on Form 10-K; and exemptions from the requirements of holding nonbinding advisory votes on executive compensation and stockholder approval of any golden parachute payments not previously approved. We can continue to be an emerging growth company, as defined in the JOBS Act, for up to five years following our IPO.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Carla Dearing is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority

Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common stock;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;
10. the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
11. industry trends and competitive environment;
12. trends in consumer spending, including consumer confidence;
13. overall economic indicators, including gross domestic product, employment, inflation and interest rates; and

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

We are committed to paying our employees a livable salary while providing access to personal and professional development to support long-term career success. Soul Slice nourishes our employees, who nourish our customers. We are eager to serve communities throughout America. Our assertive "turn-key" growth plan leverages the abundance of abandoned premium restaurant spaces for quick expansion and build-out at pandemic pricing. With our flagship location launching in Oakland, future targets include Atlanta, Harlem, Chicago, Houston, and Los Angeles. We hope to expand up to 20 locations by 2026, with annual revenues over \$25 million. These projections cannot be guaranteed.

Milestones

Soul Slice BC was incorporated in the State of California in December 2020.

Since then, we have:

- First-to-market soul food toppings on a biscuit crust created by renowned restaurateur, Karter Louis
- B Corp: 100% full-time salaried positions, benefits, profit-sharing, and ownership opportunities
- \$8.2 billion gourmet pizza market performs with continued high margins during the pandemic
- Soft launch of flagship location in Oakland, CA with Grand Opening on Juneteenth (6.19.21)
- Rapid expansion plan: 20 locations with hope of recap/buyout for returns to early investors in Yr 5 (not guaranteed)

Historical Results of Operations

Our company was organized in December 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$0.
- *Assets.* As of December 31, 2020, the Company had total assets of \$0, including \$0 in cash.

Liquidity & Capital Resources

To date, the company has been financed with \$182,175 in equity.

After the conclusion of this offering, should we hit our minimum funding target, our projected runway is 60 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Soul Slice BC cash in hand is \$15,838, as of July 2021. Over the last three months, revenues have averaged \$12,000/month, cost of goods sold has averaged \$2,133/month, and operational expenses have averaged \$25,000/month, for an average burn rate of \$15,133 per month. Our intent is to be profitable in 2 months.

We completed the asset purchase of the restaurant assets in our leased location on San Pablo Ave in Oakland, CA, installed additional equipment, established vendors, received regulatory approvals, hired employees and commenced operations on June 19, 2021. Delivery went live on 7/23. Menu and kitchen systems have been refined for efficiency and profitability. Technology is largely functioning as hoped, and we will continue to get efficiency gains from our extensive use of the Toast P.O.S. suite.

We have served 487 orders (as of 7/26/21) at an average of \$49.87 per order. (Note: our model proforma is based on \$53.00/order, so we are in line with one of the key drivers of our overall business model and plan.)

Because our employees are full-time salaried, our monthly costs are nearly fixed, so growing food and beverage sales bring us closer to break even every day, and will be higher margin when we cross over. Monthly sales based on the last week is \$24,000 as of 7/26/21, and breakeven sales is approximately \$35,000. Consequently we may be at break even as early as August. In the meantime, our CEO is keeping costs low to support cash flow needs.

In 3-6 months, we expect monthly revenues of \$35,000 - \$50,000 and to cross over to break even at \$35,000. These projections cannot be guaranteed.

We are able to access loans from shareholder owners to cover cash flow short falls. We are relying on new funds raised, however, to execute our 5-year growth plan.
