The allergy relief marketplace has highly competitive players. Many big pharmaceutical companies provide remedies for symptom relief. A startup, with a revolutionary solution but limited resources, may find it is a challenge too great to overcome.

AllerPops takes a completely novel approach to help people get allergy relief by correct the cause of allergy. It will take time for society to accept the ultimate solution. An extensive education campaign is needed but may take more capital than the company can afford.

A clinical trial to confirm what the company has observed among five thousand customers is important for our market expansion in the next stage. However, this third party experiment, though being carefully planned, may fail due to many unforeseeable reasons.

FDA approval of AllerPops as an allergy remedy will help the marketing and branding of AllerPops greatly. The process may take a longer time than expected. FDA may require the company to provide more data from a bigger study.

The AllerPops manufacturer in China has been producing excellent products according to the company's request. Due to the instability of the trading relationship between US-China, the current supply chain may not fulfill the need in the future and the company may not find a replacement on time.

COVID-19 can materially impact our business.

It is unclear how long the COVID-19 pandemic will last and to what degree it could hurt our ability to generate revenues.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common stock;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;

10. the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
11. industry trends and competitive environment;
12. trends in consumer spending, including consumer confidence;
13. overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
14. the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. ### Milestones

AllerPops Corp was incorporated in the State of New Mexico in April 2016.

Since then, we have:

- 🧬 Three years of allergy suffering and research identified two bacteria causing his allergies.
- 🔍 Two pieces of AllerPops reinforced his probiotics and returned life to normal.

- 😊 Five thousand customers are satisfied with the efficacy of 94.5%.
- 💰 The product has generated more than \$120K revenue since its inception.

### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2019, the Company had revenues of \$58,360 compared to the year ended December 31, 2018, when the Company had revenues of \$20,549. Our gross margin was 85.73% in fiscal year 2019, compared to 80.36% in 2018.
- *Assets.* As of December 31, 2019, the Company had total assets of \$204,095, including \$64,089 in cash. As of December 31, 2018, the Company had \$84,579 in total assets, including \$4,916 in cash.
- *Net Loss.* The Company has had net losses of \$136,665 and net losses of \$163,330 for the fiscal years ended December 31, 2019 and December 31, 2018, respectively.
- *Liabilities.* The Company's liabilities totaled \$216,473 for the fiscal year ended December 31, 2019 and \$4,496 for the fiscal year ended December 31, 2018.

### Liquidity & Capital Resources

To-date, the company has been financed with \$203,700 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 11 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### Runway & Short/Mid Term Expenses

AllerPops Corp cash in hand is \$87,000, as of January 2021. Over the last three months, revenues have averaged \$1,709/month, cost of goods sold has averaged \$111/month, and operational expenses have averaged \$14,285/month, for an average burn rate of \$12,687 per month. Our intent is to be profitable in 9 months.

In 2020, we continued our market study and invested our efforts to improve the performance of AllerPops according to customer feedback. We have been improving our website for a better visitor experience and a higher conversion rate. However, due to the pandemic, response to our marketing effort has dropped significantly. The revenue in 2020 is expected to be lower than that in 2019.

We expect the sales this spring and summer will increase from that of last year and likely be higher than that in 2019. The real increase will happen after we

publish the clinical trial results that confirm AllerPops' efficacy on allergies. In 6 months, we expect (though don't guarantee) to have generated \$80K with accompanying expenses of \$16K in total.

We need to raise the Wefunder fundraise minimum of \$50K in order to reach a break-even point. We have been working with investor.com and funded.com to attract investors and generated a list of investors who might be willing to invest in us. We will continue to nurture those relationships as we grow.

The owner can continue to invest in the company as needed.
