In order to respond to market changes, the Company's management may from time to time make changes to the business of the Company. There are certain risks associated with such changes. As a strategic response to changes in the competitive environment, the Company may from time to time make certain pricing, service or marketing decisions or business combinations that could have a material adverse effect on the Company's business, results of operations and financial condition.

Companies in the beverage alcohol industry are, from time to time, exposed to class action or other litigation relating to alcohol advertising, product liability, alcohol abuse problems or health consequences from the misuse of alcohol. It is also possible that governments could assert that the use of alcohol has significantly increased government funded health care costs. Litigation or assertions of this type have adversely affected companies in the tobacco industry, and it is possible that we, as well as our suppliers, could be named in litigation of this type.

We may provide certain projected results of operations to prospective investors in connection with this offering. Projections are hypothetical and based upon present factors thought by management to influence our operations. Projections do not, and cannot, take into account such factors as market fluctuations, unforeseeable events such as natural disasters, the terms and conditions of any possible financing, and other possible occurrences that are beyond our ability to control or even to predict. While management believes that the projections reflect the possible outcome of our operation and performance, results depicted in the projections cannot be guaranteed.

An increase in the cost of raw materials or energy could affect the Company's profitability. Commodity and other price changes may result in unexpected increases in the cost of products and packaging materials. The Company may also be adversely affected by shortages of product or packaging materials. In addition, energy cost increases could result in higher transportation, freight and other operating costs. The Company may not be able to increase its prices to offset these increased costs without suffering reduced volume, sales and operating profit, and this could have an adverse effect on your investment.

The Company is an early stage company incorporated on July 13, 2020. Accordingly, the Company's operations are subject to all the risks inherent in the establishment of a new business enterprise, including potential operating losses. Any investment in the Company must be considered in light of the risks, expenses and difficulties frequently encountered by companies in an early stage of development in new and rapidly evolving markets. These risks include the Company's substantial dependence on acceptance into a highly competitive marketplace surrounded by better funded and more established companies, our need to conduct product development, and our need to expand our sales and support organizations, respond to competition, manage changing operations, develop strategic relationships, control costs and expenses, maintain and enhance our brand, expand our product and service offerings, improve function and benefits, attract, integrate, retain and motivate qualified personnel, and rely upon acceptance and growth in our targeted markets.

Due to the unpredictable market created by COVID-19, the Company may experience fluctuations in demand and or supply.

The SEC recently approved amendments to Regulation Crowdfunding in which the fundraising limit for crowdfunding issuers will be increased from \$1.07million during a 12-month period to \$5 million during a 12-month period. These amendments take effect 60 days after the publication in the Federal Register. The Company reserves the right to increase the Maximum Fundraise Target once such amendments take effect. If the Company increases the Maximum Fundraising Target, investments made prior to such limit increase may be diluted accordingly.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be

left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. Notwithstanding any other provision of this Note, the Holder does not intend to charge, and the Company shall not be required to pay, any interest or other fees or shares in excess of the maximum permitted by applicable law; any payments in excess of such maximum shall be refunded to the Company or credited to reduce principal hereunder.

Conversion and Repayment

Mandatory Conversion Upon the Occurrence of a Financing. If, after the date hereof and prior to the Maturity Date, the Company consummates a preferred stock equity financing from an investor or group of investors of at least \$1,500,000 (excluding any amounts payable under the Notes converted into equity or any other indebtedness of the Company converted into equity) (a "Financing"), all outstanding principal and accrued and unpaid interest on this Note shall, effective on the date of such Financing, automatically convert into a number of shares of the preferred stock issued in such Financing equal to the quotient obtained by dividing the outstanding principal and accrued and unpaid interest on this Note by the lower of: (a) the product of (i) 0.85 times (ii) the price actually paid by investors participating in the Financing; and (b) the quotient (the "Conversion Cap") obtained by dividing (i) \$7,000,000 by (ii) the number of shares of outstanding common stock of the Company immediately prior to the closing of the Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options issued and granted under the Company's stock option plans and warrants to purchase common stock, but excluding, for this purpose, the conversion of the Notes contemplated by Section 2.1 of the attached convertible note and shares available for grant under the Company's stock option plans). Notwithstanding the above, if the conversion price of the Notes as determined pursuant to Section 2.1 of the attached convertible note (the "Conversion Price") is less than the price per share of the

preferred stock issued in such Financing, then the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as the preferred stock issued in the Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share dividend, which will be the same percentage of the Conversion Price as applied to determine the per share dividends of the Investors in the Financing relative to the purchase price paid by the Investors.

Repayment or Conversion upon the Occurrence of a Change of Control. If at any time after the date hereof and prior to the Maturity Date, the Company shall effect a Change of Control (as defined herein), at the election of the Requisite Investors, either (a) all outstanding principal and accrued and unpaid interest on this Note shall be converted into a number of shares of Class A common stock equal to the quotient obtained by dividing (i) the outstanding principal and accrued and unpaid interest on this Note by (ii) the Conversion Cap or (b) the Holder shall be paid an amount equal to one and one half times (1.5x) all outstanding principal and accrued and unpaid interest on this Note.

A "Change of Control" shall mean (x) a merger or consolidation of the Company or a wholly-owned subsidiary of the Company with or into another corporation or entity immediately after which the holders of a majority in interest of the outstanding voting securities of the Company do not continue to hold at least a majority in interest of the outstanding voting securities of the surviving company in such merger or consolidation (whether or not the Company is the surviving entity) or (y) a transaction or series of related transactions that result in the acquisition of either (1) all or substantially all of the business or assets of the Company by a third party or third parties or (2) at least a majority of the outstanding voting power of the Company by a third party or third parties. For the avoidance of doubt, in no event shall (i) an equity financing for capital raising purposes be deemed to be a Change of Control or (ii) a transaction constitute a Change of Control if its sole purpose is to change the state of the Company's incorporation or to create a holding company that will be owned in substantially the same proportions by the persons who held the Company's securities immediately prior to such transaction. **Conversion Procedure:** If this Note is converted into equity securities pursuant to Section 2 of the attached convertible note, the following terms shall govern such conversion.

Notice of Conversion. With respect to a conversion pursuant to Section 2.1 in the agreement attached below, the Company shall, on or before the closing date of such Financing, deliver written notice to the Holder of this Note at the address shown on the records of the Company for the Holder, notifying the Holder of the conversion to be effected, specifying the shares of preferred stock into which this Note shall be converted, the principal amount of the Note to be converted, the amount of accrued interest to be converted and the date on which such conversion will occur.

Mechanics and Effect of Conversion. No fractional shares of preferred stock shall be issued upon conversion of this Note. In lieu of the Company issuing any fractional shares to the Holder upon the conversion of this Note, the Company shall pay to the Holder in cash the amount of outstanding principal and accrued and unpaid interest that is not so converted. The Holder shall surrender this Note, duly endorsed, at the principal office of the Company after full conversion of this Note. Upon full conversion of this Note, the Company shall be forever released from all its obligations and liabilities under this Note. In connection with any conversion, the Holder shall become a party to and shall execute all related Financing documentation, and the preferred stock issued in connection with such conversion will have legends thereon, and be subject to the restrictions on transfer, set forth in such documentation.

Authorization of Securities. The Company shall take all necessary action to authorize the issuance of all equity securities as may be necessary to effect the provisions of this Section 2 in the agreement attached below.

Interest. Interest shall accrue on the outstanding principal balance of this Note at the rate of 8.0% per annum, on the basis of actual days elapsed in a 365- or 366-day year, as appropriate, and shall be payable at maturity. Notwithstanding any other provision of this Note, the Holder does not intend to charge, and the Company shall not be required to pay, any interest or other fees or charges in excess of the maximum permitted by applicable law; any payments in excess of such maximum shall be refunded to the Company or credited to reduce principal hereunder.

Senior Indebtedness The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of (i) the purchase price of the securities, and (ii) the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control (as defined in the Company's Investment Agreement) or dissolution.

We serve small-batch makers an an innovative and alternative Direct-to-Consumer online channel acting as a bridge connecting suppliers to the massive buying power of the corporate audience.

We want "Host a Vin Social!" to be every corporate event planner and CRO's go-to solution when they want to grow valuable relationships. We aim to be THE leading brand in this new virtual hospitality category. Our long term goal is to achieve a \$1B valuation. These projections cannot be guaranteed.

Milestones

Vin Social Corporation was incorporated in the State of California in July 2020. A migratory merger of the corporation to Delaware was completed in January 2021.

Since then, we have:

- Generated \$650K+ in revenue since launch in July 2020.
- We're on track to double revenue in 2021.
- CLTV:CAC of 3.4—our primary source of revenue is renewals from current clients.
- #1 source of new business is from companies who were guests at an event.
- Each event generates 1.5 referrals on average.
- Clients include: Salesforce, Cisco, Adweek, Verizon, Univision, and IBM and many more.
- We are the first-movers in a new, fast growing \$77 Billion industry.
- We are a woman-founded and led company that is committed to supporting and prioritizing diversity.

Historical Results of Operations

Our company was organized in July 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$512,737. Our gross margin was 57.56%.
- *Assets.* As of December 31, 2020, the Company had total assets of \$37,074, including \$16,811 in cash.
- *Net Loss.* As of December 31, 2020, the Company has had net losses of \$213,409 for 2020.
- *Liabilities.* The Company's liabilities totaled \$249,483 for 2020.

Liquidity & Capital Resources

To-date, the company has been financed with \$140,000 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we would need to evaluate raising further capital for expansion.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise additional capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Vin Social Corporation cash in hand is \$40,894, as of January 2021. Over the last three months, revenues have averaged \$148,803/month, cost of goods sold has averaged \$53,476/month, and operational expenses have averaged \$110,762/month, for an average burn rate of \$15,435 per month. Our intent is to be profitable in 12 months.

After the date that our financials cover, on January 20th, 2021, we took additional financing, borrowing \$70k as referenced in Q24.

At our current rate of growth we expect our revenues to be \$1M from Jan - Jun 2021 and our operating/COGS expenses to be \$750,000. These projections cannot be guaranteed.

We've trimmed operating expenses while increasing revenue per month, enabling us to extend our runway during our raise. Other sources of capital on which we can rely are revenues, primarily. We also have relationships and a proven track record of early repayment with high quality merchant cash advance lenders as well as a \$200K line of credit

- (2) such further material information, if any, as may be necessary to make the required statements, in the light of the circumstances under which they are made, not misleading.

The Company is using the services of XX as part of its offering. XX is comprised of XX Investments, LLC, XX Team LLC, and the Lead Investors who provide services on behalf of XX Team LLC. The services of XX are available to companies that offer securities through Wefunder Portal LLC and to investors who invest in such companies through Wefunder Portal, but XX is not affiliated with Wefunder Portal or its affiliates.

XX Investments is the Company's transfer agent and also acts as custodian, paying agent, and proxy agent on behalf of all investors that enter into the Custodial and Voting Agreement with XX Investments through the Wefunder Portal website ("Investors"). XX Investments holds legal title to the securities the Company issues through Wefunder Portal (which are uncertificated) on behalf of Investors. Investors, in turn, hold the beneficial interests in the Company's securities. XX Investments keeps track of each Investor's beneficial ownership interest and makes any distributions to the Investors (or other parties, as directed by the Investors).

In addition to the above services, at the direction of XX Team, XX Investments votes the securities and take any other actions in connection with such voting on behalf of the Investors. XX Investments acts at the direction of XX Team, because XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. XX Investments will not charge Investors for its services. XX Investments does charge the Company \$1,000/year for services; however, those fees may be paid by Wefunder Inc. on behalf of the Company.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team. As compensation for its voting services, each Investor authorizes XX Investments to distribute to XX Team 10% of any distributions the Investor would otherwise receive from the Company. XX Team will share its compensation with our Lead Investor. XX Team, through our Lead Investor, may also provide consulting services to the Company and may be compensated for these services by the Company; although, fees owed by the Company may be paid by Wefunder Inc. XX Team will share its consulting compensation with our Lead Investor.

The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities. Investors will receive disclosure regarding all fees that may be received by the Lead Investor.
