While Coffee Shift Inc believes that there will be significant customer demand for its products/services, there is no assurance that there will be broad market acceptance of the Coffee Shift's offerings. There also may not be broad market acceptance of the Coffee Shift's offerings if its competitors offer products/services which are preferred by prospective customers. In such event, there may be a material adverse effect on the Coffee Shift's results of operations and financial condition, and the Coffee Shift Inc may not be able to achieve its goals.

Coffee Shift Inc faces competition from other companies, some of which might have received more funding than Coffee Shift has. One or more of the Coffee Shift's competitors could offer services similar to those offered by the Coffee Shift Inc at significantly lower prices, which would cause downward pressure on the prices the Company would be able to charge for its services. If Coffee Shift is not able to charge the prices it anticipates charging for its services, there may be a material adverse effect on the Coffee Shift's results of operations and financial condition. In addition, while Coffee Shift believes it is well-positioned to be the market leader in its industry, the emergence of one of its existing or future competitors as a market leader may limit Coffee Shift's ability to achieve national brand recognition, which could also have a material adverse effect on the Coffee Shift's results of operations and financial condition.

Coffee Shift is still in an early phase, and is just beginning to implement its business plan. There can be no assurance that it will ever operate profitably. The likelihood of its success should be considered in light of the problems, expenses, difficulties, complications and delays usually encountered by companies in their early stages of development, with low barriers to entry. Coffee Shift Inc may not be successful in attaining the objectives necessary for it to overcome these risks and uncertainties.

Coffee Shift's founder(s), director(s) and executive officer(s) own or control a significant percentage of the Company.

Additionally, the holdings of the Company's directors and executive officers may increase in the future upon vesting or other maturation of exercise rights under any of the options or warrants they may hold or in the future be granted or if they otherwise acquire additional interest in the Company. The interests of such persons may differ from the interests of the Company's other stockholders, including purchasers of securities in the offering. As a result, in addition to their board seats and offices, such persons will have significant influence over and control all corporate actions requiring stockholder approval, irrespective of how the Company's other stockholders, including purchasers in the offering, may vote, including the following actions:

- to elect or defeat the election of the Company's directors;
- to amend or prevent amendment of the Company's Certificate of Incorporation or By-laws;
- to effect or prevent a merger, sale of assets or other corporate transaction; and
- to control the outcome of any other matter submitted to the Company's stockholders for vote.

Such persons' ownership may discourage a potential acquirer from making a tender offer or otherwise attempting to obtain control of the Company, which in turn could reduce the Company's stock price or prevent the Company's stockholders from realizing a premium over the Company's stock price.

This offering is being conducted on an expedited basis due to circumstances relating to COVID-19 and pursuant to Reg. CF Temporary Rule 201(z)(3), which provides temporary relief from certain financial information requirements by allowing issuers to provide financial information certified by the principal executive officer of the issuer instead of financial statements reviewed by a public accountant that is independent of the issuer.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Tyler Pinckard is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

## USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Use of Proceeds: 30% towards marketing (social media advertising), 20% towards hiring one part-time local order fulfiller, 15% towards order fulfillment infrastructure, 27.5% to blockchain development, 7.5% towards Wefunder fees

If we raise: **\$250,000**

Use of Proceeds: 25% towards marketing (social media advertising), 10% towards hiring one full-time local order fulfiller, 20% establishment of a warehouse/fulfillment center, 25% blockchain development, 12.5% hiring one-fulltime operations manager, 7.5% towards Wefunder fees

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

1. the total value of the Investor's investment, divided by
  1. the price of Preferred Stock issued to new Investors multiplied by
  2. the **discount rate (80%)**, or
2. If the valuation for the company is more than **\$4,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.
3. for investors up to the **first \$60,000.00** of the securities, investors will receive a **valuation cap of \$3,000,000.00** and a **discount rate of 70.0%**.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Stock, Investors will receive proceeds equal to the greater of

1. the Purchase Amount (the "Cash-Out Amount") or
2. the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

*Irrevocable Proxy.* The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through [wefunder.com](#), and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities; and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

*Repurchase.* If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities; and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

b. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (i):

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

### Management's Discussion and Analysis of Financial Condition and Results of Operations

#### Overview

We import Colombian coffee directly from the growers and sell direct-to-consumers and small businesses.

In 5 years, we hope to: increase direct and subscription customers, continue to increase the number of growers supplying coffee and using our payment rails beyond our existing 300 farmers cooperative, and continue to develop additional special edition coffees. We also hope to be generating 10M+ Annual Revenues. These projections are not guaranteed.

#### Milestones

Coffee Shift Inc was incorporated in the State of Delaware in April 2018.

Since then, we have:

- Sustainable production & sourcing + marketing & distribution of direct-trade specialty coffee from Colombian farmers.
- 34% YoY growth for 2020 from our e-commerce revenue, this doesn't include external business deals.
- Coffee is a \$13.6B market opportunity, in the US alone.
- Founded by Former US Army Intelligence Officer, who is a Silicon Valley Vet, FinTech Expert & Blockchain architect.
- International payment remittance using blockchain cryptocurrency technology.
- Full traceability of data in food supply chain with blockchain technology: data-driven smart farming.
- Via our eCommerce we offer all the diversity of flavors of the coffees produced in Colombia.

#### Historical Results of Operations

Our company was organized in April 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$7,467 compared to the year ended December 31, 2019, when the Company had revenues of \$3,238. Our gross margin was 55.48% in fiscal year 2020, compared to 54.48% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$17,342, including \$1,814 in cash. As of December 31, 2019, the Company had \$13,281 in total assets, including \$927 in cash.
- *Net Loss.* The Company has had net losses of \$5,058 and net losses of \$10,132 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$17,155 for the fiscal year ended December 31, 2020 and \$17,135 for the fiscal year ended December 31, 2019.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$1,974 in debt and \$15,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Coffee Shift Inc cash in hand is \$2,068, as of February 2021. Over the last three months, revenues have averaged \$1,400/month, cost of goods sold has averaged \$900/month, and operational expenses have averaged \$900/month, for an average burn rate of \$400 per month. Our intent is to be profitable in 6 months.

In 3 to 6 months, we expect to be generating revenues of \$3K per month with accompanying expenses of \$8K per month (blockchain development/ ops manager salary).

We currently have 5 subscriptions, and we expect the business to become profitable at 50. Assuming that we can close those additional 45 weekly/bi-weekly subscription customers with digital advertising, and that spending \$2K/month on ads will achieve 5 additional subscribers, we expect to achieve profitability with \$18K in funding over the next 6-9 months.

The basics of the business as it exists today is buying coffee ~\$2-3 per bag from the farmer and reselling to consumers at \$7-12 per bag. Legacy (old-style) sales to the coffee federation net the farmer around \$0.133333 - \$0.2 per kilo for unroasted, green dried coffee. This is how we're paying the farmers more (buying from them direct) and in turn they give us their best coffee from their harvest. Separate from the direct to consumer coffee play, we're pursuing additional opportunities via the payment rails that we're building for direct farmer payments. We haven't yet factored in this portion of the opportunity into our number crunching, but believe it will be the most exciting part of the business once it's developed.

The CEO has been funding the operation of this company from his personal funds to this point. As CEO, he is ultimately responsible for the success of Coffee Shift, and will use personal funds in the future if necessary to cover short-term burn.

The Company is using the services of XX as part of its offering. XX is comprised of XX Investments, LLC, XX Team LLC, and the Lead Investors who provide services on behalf of XX Team LLC. The services of XX are available to companies that offer securities through Wefunder Portal LLC and to investors who invest in such companies through Wefunder Portal, but XX is not affiliated with Wefunder Portal or its affiliates.

XX Investments is the Company's transfer agent and also acts as custodian, paying agent, and proxy agent on behalf of all investors that enter into the Custodial and Voting Agreement with XX Investments through the Wefunder Portal website ("Investors"). XX Investments holds legal title to the securities the Company issues through Wefunder Portal (which are uncertificated) on behalf of Investors. Investors, in turn, hold the beneficial interests in the Company's securities. XX Investments keeps track of each Investor's beneficial ownership interest and makes any distributions to the Investors (or other parties, as directed by the Investors).

In addition to the above services, at the direction of XX Team, XX Investments votes the securities and take any other actions in connection with such voting on behalf of the Investors. XX Investments acts at the direction of XX Team, because XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. XX Investments will not charge Investors for its services. XX Investments does charge the Company \$1,000/year for services; however, those fees may be paid by Wefunder Inc. on behalf of the Company.

As noted, XX Team holds a power of attorney from each investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team. As compensation for its voting services, each Investor authorizes XX Investments to distribute to XX Team 10% of any distributions the Investor would otherwise receive from the Company. XX Team will share its compensation with our Lead Investor. XX Team, through our Lead Investor, may also provide consulting services to the Company and may be compensated for these services by the Company; although, fees owed by the Company may be paid by Wefunder Inc. XX Team will share its consulting compensation with our Lead Investor.

The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities. Investors will receive disclosure regarding all fees that may be received by the Lead Investor. In addition to the fees
