**If PredictSys' forecasting and supply chain automation solutions fail to perform as expected, PredictSys ability to develop, market and sell its automation solutions could be harmed:** PredictSys' Artificial Intelligence (AI) based forecasting and supply chain automation solutions may contain defects in design and development that may cause them not to perform as expected or not have the desired accuracy. This may require further investments to detect and fix the root causes. PredictSys' solutions may not perform consistent with customers' expectations or consistent with other solutions which may become available. Any product defects or any other failure of PredictSys' solutions and software to perform as expected could harm PredictSys' reputation and result in adverse publicity, lost revenue



harm PredictSys' reputation and result in adverse publicity, lost revenue, product liability claims and significant warranty and other expenses and could have a material adverse impact on PredictSys' business, prospects, financial condition and operating results.

**If PredictSys is unable to successfully expand functionality of its automation solutions, its business will be harmed:** There are scenarios where PredictSys could be unable to expand the functionality of its current minimum viable product (MVP). PredictSys' providers of data might either not have the data needed or refuse to provide the data to support new functionality. PredictSys' proprietary software might not be able to support the extended functionality required. Though this is not very likely, it might require significant more expenses than planned to rework the software

**PredictSys' future growth is dependent upon the Retail and Fashion Industries' willingness to adopt automation solutions:** PredictSys' growth is dependent upon the adoption of forecasting and supply chain automation solutions by Retailers and Fashion Brands. If the market for forecasting and supply chain automation solutions does not develop at the rate or in the manner or to the extent that PredictSys expects, or if critical assumptions PredictSys has made regarding the impact of its solutions are incorrect or incomplete, PredictSys' business, prospects, financial condition and operating results will be harmed.

**PredictSys' business practices with respect to data could give rise to operational interruption, liabilities or reputational harm as a result of governmental regulation, legal requirements or industry standards relating to privacy and data protection:** PredictSys' automation solutions rely heavily on Big Data from a range of sources including demographic and customer data. As regulatory focus on privacy issues continues to increase and worldwide laws and regulations concerning the handling of personal information expand and become more complex, potential risks related to data collection and use within PredictSys' business will intensify. In addition, U.S. and foreign governments have enacted or are considering enacting legislation or regulations, or may in the near future interpret existing legislation or regulations, in a manner that could significantly impact PredictSys' ability, as well as the ability of PredictSys' customers, partners and data providers, to collect, augment, analyze, use, transfer and share personal and other information that is integral to services PredictSys provides.

**PredictSys' intellectual property applications for registration may not issue or be registered, which may have a material adverse effect on PredictSys' ability to prevent others from commercially exploiting solutions similar to PredictSys':** PredictSys plans to file patents to protect the intellectual property and innovation inherent in its automation solutions. However, PredictSys cannot be certain that it is the first inventor of the subject matter to which it plans to file a particular patent application, or if it will be the first party to file such a patent application. If another party has filed a patent application to the same subject matter as PredictSys has, PredictSys may not be entitled to the protection sought by the patent application. PredictSys also cannot be certain whether the claims included in a patent application will ultimately be allowed in the applicable issued patent. Further, the scope of protection of issued patent claims is often difficult to determine. As a result, PredictSys cannot be certain that the patent applications that it files will issue, or that its issued patents will afford protection against competitors with similar technology. In addition, PredictSys' competitors may design around PredictSys' issued patents, which may adversely affect PredictSys' business, prospects, financial condition and operating results.

**PredictSys' business may be adversely affected if it is unable to protect its intellectual property rights from unauthorized use by third parties:** Failure to adequately protect PredictSys' intellectual property rights could result in PredictSys' competitors offering similar products, potentially resulting in the loss of some of PredictSys' competitive advantage and a decrease in its revenue, which would adversely affect PredictSys' business, prospects, financial condition and operating results. PredictSys' success depends, at least in part, on its ability to protect its core technology and intellectual property. To accomplish this, PredictSys will rely on a combination of patents, trade secrets (including know-how), employee and third-party nondisclosure agreements, copyrights, trademarks, intellectual property licenses and other contractual rights to establish and protect PredictSys' rights in its technology.

The protection of PredictSys' intellectual property rights will be important to its future business opportunities. However, the measures PredictSys

takes to protect its intellectual property from unauthorized use by others may not be effective for various reasons, including the following:

- a. any patent applications PredictSys submits may not result in the issuance of patents;
- b. PredictSys' issued patents may be challenged or invalidated by its competitors;
- c. PredictSys' employees or business partners may breach their confidentiality, non-disclosure and non-use obligations to PredictSys;
- d. third-parties may independently develop technologies that are the same or similar to PredictSys';
- e. the costs associated with enforcing patents, confidentiality and invention agreements or other intellectual property rights may make enforcement impracticable; and
- f. current and future competitors may circumvent PredictSys' intellectual property

Patent, trademark, copyright and trade secret laws vary throughout the world. Some foreign countries do not protect intellectual property rights to the same extent as do the laws of the U.S. Further, policing the unauthorized use of PredictSys' intellectual property in foreign jurisdictions may be difficult. Therefore, PredictSys' intellectual property rights may not be as strong or as easily enforced outside of the U.S.

**PredictSys may in the future experience additional competition in current and potential future markets:** PredictSys' AI driven forecasting and supply chain automation solution uses data from multiple sources including client's ERP systems and external data providers. While the use of AI to drive automation in Retail and Fashion supply chain is expected to continue to grow, PredictSys could face increased competition in the future. For example ERP solutions providers or external data providers or any other types of software company may decide to enter the forecasting and supply chain automation software for the Retail and Fashion markets. New competitors may be able to deploy greater resources to the design, development, distribution, promotion, sales, marketing and support of their solutions. Additionally, such competitors may have greater name recognition, longer operating histories, larger sales forces, broader customer and industry relationships and other resources than PredictSys does. PredictSys may experience competition with respect to recruiting and retaining qualified research and development, data science, sales, marketing and management personnel, as well as further competition in acquiring technologies complementary to, or necessary for, PredictSys' solutions. There are no assurances that customers will choose PredictSys' automation solutions over those of its competitors, and future competition could have a material adverse effect on PredictSys' business, financial condition and results of operation.

**If Predictsys fails to manage its growth effectively, include failing to attract and integrate qualified personnel, it may not be able to develop, produce, market and sell its automation solutions successfully:** Any failure to manage PredictSys' growth effectively could materially and adversely affect PredictSys' business, prospects, operating results and financial condition. PredictSys intends to expand its operations. PredictSys expects its future expansion to include:

- a. Hiring and training new personnel
- b. Expanding the management and sales team
- c. Implementing and enhancing administrative infrastructure, systems and processes
- d. Controlling expenses and investments in anticipation of expanded operations

PredictSys intends to continue to hire a number of additional personnel, including data scientists, data engineers, full stack developers and cloud engineers to expand the functionality of its software and integrate and deploy our solutions at clients. Experienced and highly skilled employees in the software development space are highly demanded and scarce. PredictSys

the above-mentioned areas are in high demand and competition for these employees can be intense, and PredictSys' ability to hire, attract and retain them depends on its ability to provide competitive compensation. PredictSys may not be able to attract, assimilate, develop or retain qualified personnel required. The failure to attract, integrate, train, motivate and retain these additional employees could seriously harm PredictSys' business, prospects, financial condition and operating results.

**PredictSys is an early stage company with a history of losses, and expects to incur expenses and continuing losses:** PredictSys incurred a net loss of approximately \$50K in both 2019 and 2020. PredictSys believes that it will continue to incur operating and net losses until at least such time as it has completed its pilot at a Beta client and deployed its solution at 10+ paying customers. This is estimated to occur in 2023, and may occur later or not at all.

**PredictSys may require continued capital investment:** Although PredictSys anticipates that the successful close of crowd-funding campaign on WeFunder.com will provide sufficient capital, to fund the pilot at Beta client, PredictSys may require additional capital investment in the future to fund operations, expand sales effort, continue research and development and improve infrastructure. There can be no assurance that PredictSys will have access to the capital it needs on favorable terms when required or at all. If PredictSys cannot raise additional funds when it needs them, PredictSys' financial condition and business could be materially adversely affected.

**PredictSys has been, and may in the future be, adversely affected by the global COVID-19 pandemic, the duration and economic, governmental and social impact of which is difficult to predict, which may significantly harm PredictSys' business, prospects, financial condition and operating results:** There has been a widespread worldwide impact from the COVID-19 pandemic, and PredictSys has been, and may in the future be, adversely affected as a result. Numerous government regulations and public advisories, as well as shifting social behaviors, have temporarily limited or closed non-essential business activities and person-to-person interactions, and the duration of such trends is difficult to predict. Temporary shut-downs of non-essential retail including Fashion retailers has negatively affected the sales and profitability of PredictSys' potential customers. This negative impact on PredictSys' customers has created both a long-term tailwind and a short-term headwind. COVID-19 has shown Retailers the need for increased forecasting and supply chain automation to respond quickly to changing environment and increase profitability. However, in the short-term, the reduced revenues and profits have deterred Retailers from making investments in increasing automation. Given the uncertain nature of the path forward in the short-term, PredictSys' operations and timelines may also be affected.

**PredictSys' business model requires further market penetration to drive growth and failure to expand would have a material adverse effect on its operating results and business and could result in substantial liabilities that exceed its resources:** It is difficult to predict PredictSys' future revenues and appropriately budget for its expenses, and PredictSys has limited insight into trends that may emerge and affect its business. In the event that actual results differ from PredictSys' estimates or PredictSys adjusts its estimates in future periods, PredictSys' operating results and financial position could be materially affected. PredictSys will continue to encounter risks and difficulties frequently experienced by early stage companies, including scaling up its infrastructure and headcount, and may encounter unforeseen expenses, difficulties or delays in connection with its growth. In addition, as a result of the capital-intensive nature of PredictSys' business, PredictSys can be expected to continue to sustain substantial operating expenses without generating sufficient revenues to cover expenditures. Any investment in PredictSys is therefore highly speculative and could result in the loss of your entire investment.

**PredictSys' future success depends on the efforts of a small management team.** The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. Because there will likely be no public market for our securities prior to an initial public offering or similar liquidity event, the price of the **Preferred Stock** that Investors will receive, and/or the total value of the Company's capitalization, will be determined by our **board of directors**. Among the factors we may consider in determining the price of **Preferred Stock** are prevailing market conditions, our financial information, market valuations of

other companies that we believe to be comparable to us, estimates of our business potential, the present state of our development and other factors deemed relevant.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. Issuer repurchases of securities. ### **Management's Discussion and Analysis of Financial Condition and Results of Operations**

#### **Overview**

PredictSys uses Artificial Intelligence and Big Data to forecast fashion trends and demand at product/size level with high accuracy. We use our highly accurate forecasts, in conjunction with client data, to generate actionable supply chain, profit and customer experience improvement recommendations in a fully automated way!

Our solution better matches customer needs and demand with production and supply reducing the \$210 Billion supply-demand mismatch in the fashion supply chain.

In five years, we want to be the leading provider of automated forecasting and increased automation solutions in the \$1.7 Trillion global fashion supply chain for all product categories like Jeans, Dresses, Shoes etc. In addition we want to expand our offering to categories like beauty, toys, home, which have an element of fashion in them. These categories represent another \$1.4 Trillion in sales in just US alone. These projections cannot be guaranteed. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

#### **Milestones**

PredictSys Inc. was incorporated in the State of Delaware in February 2019.

Since then, we have:

- Addresses \$210 Billion supply-demand mismatch problem for Fashion products

- Proven business & tech team with top tier talent from McKinsey, Amazon Fashion and AWS
- MVP that generates recommendations with 90%+ accuracy
- Multiple client discussions underway to launch pilot

#### **Historical Results of Operations**

Our company was organized in February 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2019, the Company had revenues of \$0.
- *Assets.* As of December 31, 2019, the Company had total assets of \$3,599, including \$3,599 in cash.
- *Net Loss.* The Company had a net loss of \$52,509 for the fiscal year ending December 31, 2019.
- *Liabilities.* The Company's liabilities totaled \$10,230 for the fiscal year ended December 31, 2019.

#### **Liquidity & Capital Resources**

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

PredictSys Inc. cash in hand is \$4,500, as of January 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$3,000/month, for an average burn rate of \$3,000 per month. Our intent is to be profitable in 24 months. We have the ability to self-fund till at least we finish the campaign on Wefunder.

There have been no material changes or trends in our finances since 12/31/2019. For 2020, our total expenses are expected to be \$38,021, slightly lower than our 2019 expenses of \$52,509. The decrease is driven by two factors: (1) Additional start-up costs we incurred in 2019 and (2) Reduced travel due to COVID-19 in 2020.

Assuming we raise at least our minimum goal of \$250k, we will be able to conduct a paying pilot with a single client in March/April of 2021 and start generating revenues in June/July. A large portion of the \$250K will be spent in customizing and enhancing our current product to conduct the pilot. In the six months (post-funding), we estimate that our revenues will total \$100k and expenses will total \$500k. These projections cannot be guaranteed.

Since \$250K will allow us to do only one pilot, we plan to raise additional capital in the next 4 months to support our sales efforts, conduct pilots with other clients and perform a broader roll out of our software across multiple clients.

To date, all funding has been provided by the founders. Besides the funding we are seeking on Wefunder, moving forward, revenues will also help us cover some of our expenses.
