The state legislatures and federal government are still creating and amending legislation that impacts how Bloomstack clients use our product. If a law were passed that made cannabis legal federally without regulation by the states or the feds it could negatively impact the demand for our software platform in the cannabis industry.

Our platform is still under development and will be in perpetuity. Businesses may choose to delay their buying decision in adopting Bloomstack until the features they care about most are available. If Bloomstack does not deliver them in a reasonable time frame it would negatively impact our sales and growth.

Our success depends on our ability to continue to sell and service new clients in numbers much higher than we currently have sold. The time it takes to recruit and train new implementers is a limiting factor.

As a FOSS (Free and Open Source Software) project we share a large majority of the platform software code under either MIT or GPLv3 software licenses. This means anyone with the knowledge and skill can reuse, repurpose and/or redistribute the software without our consent. They cannot, however, use our trademarked names such as Bloomstack™. If a very large competitor invested enough resources it is possible they could outpace even our own Team and develop a competitor to Bloomstack.

Due to ongoing prohibition of cannabis by the US Federal Government, legal challenges could arise from our association with certain companies that is beyond our control to foresee and could negatively impact our business in ways unknown. These cases can be very costly and/or our ability to do business in certain jurisdictions could negatively impact our business.

Bloomstack systems are designed and tested for cyber security vulnerabilities. However, as witnessed by many high profile cases of hacking, we can provide no assurance that a malicious party or simply a rogue employee could cause a data breach where Bloomstack may be held liable under certain conditions. Bloomstack does not currently maintain significant insurance policies and a serious breach could be very costly both financially and in reputation should a breach occur.

Our current expenses are greater than our income and without additional sales or fundraising, it could cause Bloomstack to layoff employees and otherwise cause a disruption in operations which could lead to company failure. At our current operational level we are losing nearly \$50,000 per month. This means we can only operate with our current resources at this level for 90 days and will need to reduce expenses within 45 days if we are unable to generate additional income through sales or fundraising.

Management believes it could drastically cut its workforce and be profitable but this would severely impact the growth and health of the company.

Nothing in this investment, our software, or our company is guaranteed and you could lose your entire investment. If you cannot afford to lose your entire investment you should not invest in this company.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

#### **Conversion and Repayment**

##### **(a) Conversion Upon Qualified Financing**

Conversion upon a Qualified Financing. In the event that the Company issues and sells its equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$1000000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per share for Equity Securities by the Investors in the Qualified Financing multiplied by 0.8, and (ii) the quotient resulting from dividing \$9500000 by the number of outstanding shares of common stock of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per share at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share dividend, which will be the same percentage of the Conversion Price as applied to determine the per share dividends of the Investors in the Qualified Financing relative to the purchase price paid by the Investors.

##### **(b) Conversion upon a Change of Control.**

If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof.

The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

**(c) Procedure for Conversion.** Procedure for Conversion.

In connection with any conversion of this Note into capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

**(d) Interest Accrual.** If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

**Senior Indebtedness**

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Bloomstack helps cannabis businesses by replacing several software platforms (i.e. - Quickbooks, Salesforce, Distru, Warefour, Cannix, etc.) with Bloomstack while saving time and money.

Cannabis companies are required by law to comply with "seed to sale" tracking and compliance laws. These companies are frustrated by the current software solutions for this rapidly growing industry. They often piece together 4-6 different software platforms, paper documents, and spreadsheets and suffer from it.

Bloomstack hopes to be THE cloud platform for Cannabis operators. Our AI assisted insights and tools keep them legal and growing on a single cloud solution.

In 2-3 years we hope to have moved on to other industries beyond cannabis and countries beyond the USA.

In 5 years, we hope to be a multi-billion dollar enterprise helping power thousands of ventures worldwide.

#### Historical Results of Operations

Our company was organized in July 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$379,732 compared to the year ended December 31, 2019, when the Company had revenues of \$54,989.
- *Assets.* As of December 31, 2020, the Company had total assets of \$140,069, including \$5,232 in cash. As of December 31, 2019, the Company had \$12,104 in total assets, including \$11,504 in cash.
- *Net Loss.* The Company has had net losses of \$561,479 and net losses of \$486,960 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$384,445 for the fiscal year ended December 31, 2020 and \$100,000 for the fiscal year ended December 31, 2019.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$1,200,000 in convertible notes, \$725,000 in SAFEs, and \$188,501 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Bloom Stack Corp. cash in hand is \$184,695.31, as of February 2021. Over the last three months, revenues have averaged \$42,515/month, cost of goods sold has averaged \$3,500/month, and operational expenses have averaged \$84,467/month, for an average burn rate of \$45,452 per month. Our intent is to be profitable in 12 months.

Since the date of our financials, we have raised an additional \$200,000 from our first Safe round investors. Investors and technology partners, Extrapreneurs, have extended an offer to self fund additional engineering resources through the end of 2021 to help insure we stay financially stable as we scale.

Over the next 3-6 months as we begin selling we expect to book 4-8 new client contracts with an estimated ACV \$110,000 each or \$440K - \$880K. We expect our current expenses to increase by 50-100% by the end of this 6 months period. With our current growth rate and plans, we aim to eventually reach break-even with \$250k-\$400k in capital. These projections cannot be guaranteed.

For additional capital, our Founder & CEO, Eric B. Delisle, has not only committed significant capital to Bloomstack to date, he is prepared to provide additional capital as needed from his personal assets to keep moving the company forward in the case of a cashflow shortage. Additionally, Bloomstack may be eligible for non-dilutive revenue financing from sources as we generate more contract SaaS revenue to invest in growth. There are a growing number of capital sources who will fund growth capital based on our long term monthly contracts.
