Major disruptions in global supply chains could have a negative impact on our business and make it extremely difficult to manage inventory and cash flow. We will need to rely on many products being available on an as needed basis and, in particular, large quantities of coffee beans need to be sourced and shipped consistently on a regular basis in perpetuity.

The timing and certainty of a subsequent financing round or liquidity event is uncertain and a delayed event could erode the internal rate of return of your investment over time. While markets are currently long with cash, liquidity and the appetite for private investments may diminish over time.

We are projecting an aggressive 5 year plan. While we feel that there are currently many positive factors that can contribute to our expected growth, there are market forces out of our control, such as the strength of both the US economy and real estate market and the cost of goods domestic and abroad, that could slow our projected rate of progress.

Recruiting good, productive employees can be a challenge for any company. While we will hire team members who embrace our vision and culture, and compensate them above market rates, there are factors beyond our control that could reduce the talent pool. For example, generous Government unemployment packages made available during the COVID-19 pandemic demotivated workers to look for and find full-time employment.

Our revenue model is based on numerous assumptions, with the primary

drivers being user behavior and spending patterns. Actual results could vary depending on user traction and length of visit. Also, the long term revenue model could be altered from the original based on our early learnings, which could cause our overall revenue to be different from our projections.

The Company is established as a C-Corporation and its earnings may be subject to U.S. income taxes. Also, it must remain compliant with various employment and federal laws. Therefore, changes in the U.S. tax code, the cost of unemployment insurance, payroll taxes, and the minimum wage could have a negative impact on earnings. Additionally, the rising cost of health insurance could affect the bottom line relatively significantly as we would, at some point, need to offer acceptable employee benefits in order to be competitive in the job market.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

VEL is a premium utopian tech forward work cafe.

Our CEO was, like millions of people in America, regularly working out of a local coffee shop. His home office was inadequate to support consistent good quality work. The typical clunky and noisy coffee shop experience finally got the best of him. VEL was born in 2020.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended June 30, 2024, the Company had revenues of \$53,720 compared to the year ended June 30, 2023, when the Company had revenues of \$55,412.27. Our gross margin was 75.28% in fiscal year 2024, and 83.14% in 2023.
- *Assets.* As of June 30, 2024, the Company had total assets of \$1,618,858, including \$321,183.67 in cash. As of June 30, 2023, the Company had \$1,303,995 in total assets, including \$76,080.85 in cash.
- *Net Loss.* The Company has had net losses of \$2,660,567.65 and net losses of \$1,113,158.77 for the fiscal years ended June 30, 2024 and June 30, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$35,433.44 for the fiscal year ended June 30, 2024 and \$474,000 for the fiscal year ended June 30, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$3,117,641 in equity, \$475,000 in convertibles, and \$500,001 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 5 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Space 3, Inc. cash in hand is \$212,000, as of October 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$70,000/month, for an average burn rate of \$70,000 per month. Our intent is to be profitable in 9 months. As we navigated the difficult fundraising environment, to preserve cash and extend our runway we right-sized the company and are now running very lean compared to a year ago. We expect & project that we will require a further \$1,000,000 to become revenue generating.

We are not profitable at this time. We are currently raising \$2 million. We should reach 5-6 units towards the middle of 2026, at which time we

should be profitable.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either

leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
