The business operates in a saturated market with well-funded competitors. We can provide no assurance that our current or potential competitors will not provide products or services comparable or superior to those provided by us or adapt more quickly than we do to evolving industry or market trends. Increased competition may result in price reductions, reduced gross margins and loss of market share, any of which would materially and adversely affect our business, prospects, financial condition or results of operations. We cannot assure investors that we will be able to compete effectively against current and future competitors.

The Company relies on third-party suppliers and manufacturers for the production of their products. Any disruption to the supply chain could negatively impact the Company and its ability to produce and sell said products.

The effect of COVID-19's on the economy could cause a negative impact to the skincare product industry due to a decrease in consumer spending.

The Company's success depends in large part on its ability to maintain consumer confidence in the safety and quality of all its products. The Company has rigorous product safety and quality standards. However, if products taken to market are or become contaminated or adulterated, the Company may be required to conduct costly product recalls and may become subject to product liability claims and negative publicity, which would cause its business to suffer.

Listener Brands Inc. is offering up to 1,519,756 shares of Preferred Series Seed Plus stock, at a price per share of \$3.29.

The campaign maximum is \$4,999,997.24 and the campaign minimum is \$100,006.13.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferee or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Preferred Series Seed Plus are non-voting shares and shareholders shall not be entitled to vote on any matter that is submitted to a vote or submitted for the consent of the shareholders of the Company.

Preferred Series Seed Plus shareholders shall have no information or inspection rights, except with respect to such rights deemed not waivable by laws.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, the **shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the **shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The **shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$5,559,807 compared to the year ended December 31, 2019, when the Company had revenues of \$5,326,590. Our gross margin was 71.97% in fiscal year 2020, compared to 66.98% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$1,038,352, including \$252,687 in cash. As of December 31, 2019, the Company had \$910,833 in total assets, including \$442,628 in cash.
- *Net Loss.* The Company has had net losses of \$898,954 and net losses of \$1,048,399 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

Liquidity & Capital Resources

To-date, the company has been financed with \$2,101,800 in debt, \$1,210,000 in equity, and \$225,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 2 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Listener Brands Inc. cash in hand is \$83,845.39, as of July 2021. Over the last three months, revenues have averaged \$474,050/month, cost of goods sold has averaged \$97,316.82/month, and operational expenses have averaged \$345,766/month, for an average net margin of \$30,967.18 per month. Our intent is to be profitable in 24 months.

Since the date our financials cover, we've earned approximately \$3.1M in revenue YTD (in 2021) and are projecting \$6M - \$7M in annual revenue this year (not guaranteed). Last year was an anomaly for e-commerce as more people were shopping online due to the pandemic. The fact that we are on par with revenue from last year is phenomenal.

Subscription revenue has nearly doubled and is up 82%. Last year we did \$467,000 in subscription revenue and this year we have done \$851,000 in subscription revenue YTD. We are on-trend for our highest-grossing year ever (not guaranteed).

We plan to put an emphasis on subscription revenue moving forward. Companies with strong subscription-based revenue often see higher valuations.

Our goal is to leverage the \$5M raised from crowdfunding towards reaching \$15M or more in revenue next year. We are projecting that revenue will be \$6M - \$7M for the year 2021. We project that our COGS will make up 20% of Revenue, Expenses/Advertising 40%, Team 30%, and 10% Other. These projections cannot be guaranteed.

We plan to invest in the rebrand CurlMix, the growth of 4C ONLY, and the acquisition of other brands in hopes of becoming a Direct to Consumer conglomerate similar to Procter & Gamble.

With these investments, we plan to become profitable within the next 2 years (not guaranteed).

Outside of funds raised in this offering, our plan is to leverage the funding to access larger sources of short-term, non-equity, non-dilutive capital. We plan to utilize this funding to get a line of credit with favorable terms to expand our capital resources. These two strategies combined will allow us to grow faster and further while also maintaining a strong runway, which in turn protects and strengthens your equity investment if and when we pursue later rounds of funding.
