Manufacturing delays and shut downs are always our biggest risk. We experienced this in 2020 with the pandemic, but do not expect to experience it again any time soon as our factory has completely recovered.

We have an ongoing federal lawsuit that we have been dismissed from, but our founder is still involved with an upcoming deposition taking place sometime in April, 2021. Having previously been dismissed from the suit, we do not expect it to impact us beyond acquiring legal fees for our founders continued involvement.

Knockoffs are a risk we have taken a lot of precautions to avoid. We signed a licensing agreement with a larger company to produce a lower-end version of the

Sash that has us involved and receiving a royalty. Most knockoffs that have popped up have been shut down by our community within days, sometimes hours. There is currently one knockoff on Amazon competing with Sash. We do have a design patent and have sent a cease and desist.

We currently have a very small team after having to lay several people off during the pandemic year. We will need to recruit some skilled customer service representatives and team members to carry our growth strategy forward.

We currently have only one manufacturer. This is because every other factory we have worked with could not compete with the price and produce the same quality. This does limit our options if something should happen to our manufacturer.

Sash bags are a complicated pattern and difficult to sew. This can make it a challenge to scale as price breaks have not been offered to us for larger production.

Elizabeth Stone is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$250,000**

Use of Proceeds: 93.5% will go toward production of Sash bags. 6.5% will go toward the Wefunder intermediary fee.

If we raise: **\$1,000,000**

Use of Proceeds: 70.5% of funds will go toward production of Sash bags. 10% will go toward marketing. 13% will go toward payroll. 6.5% will go toward the Wefunder intermediary fee.

THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

- i. the total value of the Investor's investment, divided by
 - a. the price of Preferred Stock issued to new Investors multiplied by
 - b. the **discount rate (90%)**, or
- ii. if the valuation for the company is more than **\$10,000,000.00 (the "Valuation Cap")**, the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the **first \$250,000.00** of the securities, investors will receive a **valuation cap of \$9,000,000.00**.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Stock, Investors will receive proceeds equal to the greater of

- i. the Purchase Amount (the "Cash-Out Amount") or
- ii. the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the

- iii. Senior to payments for other series any or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

- i. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
- ii. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

- i. the purchase price of the securities, and
- ii. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

- b. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and

Investors in this Offering would receive preferred stock if the SAFE converts. Preferred stock has liquidation preferences over common stock.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional stock, an Investor's interest will typically also be diluted.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

Among the factors we may consider in determining the price of **Preferred Stock** are prevailing market conditions, our financial information, market valuations of other companies that we believe to be comparable to us, estimates of our business potential, the present state of our development and other factors deemed relevant.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. Issuer repurchases of securities. A sale of the issuer or of assets of the issuer. As a minority owner of the Company, the Investor will have limited or no ability to influence a potential sale of the Company or a substantial portion of its assets. Thus, the Investor will rely upon the executive management of the Company and the Board of Directors of the Company to manage the Company so as to maximize value for shareholders. Accordingly, the success of the Investor's investment in the Company will depend in large part upon the skill and expertise of the executive management of the Company and the Board of Directors of the Company. By acquiring an interest in the Company, the Investor will be deemed to have acknowledged the existence of any such actual or potential conflicts of interest and to have waived any claim with respect to any liability arising from the existence of any such conflict of interest.

We manufacture and sell Sash bags. The Sash bag has a patented, stacked, 10-pocket design that takes the contents of a woman's purse and organizes it all in an ergonomic and stylish way, such that the person wearing it can barely tell they are wearing anything at all. Yet, all of their belongings are magically at their fingertips. Essentially, we are selling freedom and liberation from purses. Yes, you can take that annoying purse and throw it in the trash forever.

We would like to be a global brand with world-wide distribution. We are modeling our potential and our roadmap after the Uggs brand, which disrupted the entire footwear industry and currently makes over \$2B per year. We see a similar path, having already proven that women who try a Sash bag prefer it to carrying a traditional purse. In five years, we hope millions of women will experience the enhanced lifestyle available by not lugging around a giant purse. These projections cannot be guaranteed.

Milestones

Sash Group, Inc. was incorporated in the State of California in October 2012.

Since then, we have:

- We have a patented product that serves a direct market need and have already made \$14M in revenue.
- Our current challenge is limited resources preventing us from meeting the demand of our customers.
- Our product is highly coveted with a community of 70,000 fans creating a demand for production.
- We are backed by Uggs Founder, Brian Smith, who firmly believes Sash is the next Ugg.
- We have our marketing down to a science, and a loyal customer base, giving us reliable projections.
- We have a skilled and tested manufacturing partner ready to scale his and our business with funding.
- Plainly stated: We know how to sell a lot of Sash bags.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$2,069,377 compared to the year ended December 31, 2019, when the Company had revenues of \$3,269,528. Our gross margin was 44.89% in fiscal year 2020, compared to 52.97% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$842,889, including \$32,358 in cash. As of December 31, 2019, the Company had \$1,045,763 in total assets, including \$59,059 in cash.
- *Net Loss.* The Company has had net losses of \$123,411 and net losses of \$63,457 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,114,365 for the fiscal year ended December 31, 2020 and \$1,191,828 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$1,323,847 in debt and \$100,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 36 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Sash Group, Inc. cash in hand is \$30,105.73, as of March 2021. Over the last three months, revenues have averaged \$140,563.26/month, cost of goods sold has averaged \$52,614.63/month, and operational expenses have averaged \$76,834.15/month, for an average net margin of \$11,114.48 per month. Our intent is to be profitable in 4 months.

There are no notable changes or trends in the first quarter of 2021 that impact the summary of our financial statements from 2019 and 2020. In 2020, our factor was shut down due to COVID, which is why our revenues dipped from 2019 to 2020.

We are getting inventory delivered in early April, so we expect our revenue to increase toward our normal revenue patterns and project to make between \$500,000-\$1,000,000 in revenue in the next three to six months with approximately \$120,000 in monthly expenses. These projections cannot be guaranteed.

For additional capital outside of this offering, we are securing a letter of credit to get a head start on production so that we aren't relying on the WeFunder investments to get production started back up.

As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities. Investors will receive disclosure regarding all fees that may be received by the Lead Investor. In addition to the fees described above, the Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a special purpose vehicle ("SPV") for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that SPV (and as a supervised person of Wefunder Advisors) and may be compensated through that role. Although the Lead Investor may act in multiple roles and be compensated from multiple parties, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of the Company's securities. As a result, the Lead Investor's interests should always be aligned with those of the Investors.

The XX arrangement also is intended to benefit Investors by providing the services of an

experienced Lead Investor (acting on behalf of XX Team) who is expected to make value-maximizing decisions regarding Investors' securities. XX Team (acting through the Lead Investor) may further benefit both the Company and Investors by providing consulting services to the Company that are intended to maximize both the value of the Company's business and also the value of its securities.
