By its nature, the restaurant business is risky. Under the best circumstances, the profit margins are slim, leaving little room for error. Competition for customers and talent is fierce. The regulatory landscape of New York City adds to the financial burden of restaurateurs with costly fines, permits, and licenses. Much of the dining public is interested primarily in new restaurants, contributing to a high churn rate in the market.

The restaurant business is highly competitive. We face competition from other restaurants in our niche. Consumers have many choices in the food industry and may not opt to dine at Fort Defiance.

The restaurant business is notoriously difficult — competition is fierce, customers are fickle, finding and retaining staff is challenging, and profit margins are small. Unexpected expenses can significantly affect a restaurant's bottom line.

Fort Defiance has struggled in the past to show a profit. Our new location is bigger and better than our current space, but no guarantee that this trend will change.

Our new business model is unusual — a combination restaurant/grocery. There are a few but not many examples of this business model in New York City. One of the reasons is that it presents permitting and licensing challenges, and coordination between the state government's State Liquor Authority and Department of Agriculture and Markets, and the city's Department of Health and Mental Hygiene. It is not certain that a business with this model can succeed.

Restaurants in Red Hook, Brooklyn will always rely on "destination diners," i.e. customers who travel to Red Hook from other New York City neighborhoods — the small resident population cannot support these businesses on its own. In order to succeed, Fort Defiance must consistently attract these destination diners. The lack of a subway stop in the neighborhood makes this challenging.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use 2.5% of its gross revenues to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received 1.25x their principal investment (the repayment amount) , provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the net revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The unitholders have the right to redeem their securities at any time. unitholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFEs, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be negatively affected.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The value of the promissory notes will be determined by the Company's senior management in accordance with U.S. generally accepted accounting principles. For example, the notes may be valued based on principal plus anticipated interest payments over the course of the term of the note.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the promissory notes holds no position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its management, and the Investor will have no independent right to name or remove an officer or member of the management of the Company.

23. What are the risks to purchasers associated with corporate actions, including additional issuances of securities, issuer repurchases of securities, a sale of the issuer or of assets of the issuer or transactions with related parties?

**Additional issuances of securities.** Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured. The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. The declining of an opportunity or the inability of the Investor to make a follow-on investment, or the lack of an opportunity to make such a follow-on investment, may result in substantial dilution of the Investor's interest in the Company.

**Issuer repurchases of securities.** The Company may have authority to repurchase its securities from unitholders, which may serve to decrease any liquidity in the market for such securities, decrease the percentage interests held by other similarly situated investors to the Investor, and create pressure on the Investor to sell its securities to the Company concurrently.

**A sale of the issuer or of assets of the issuer.** As a minority owner of the Company, the Investor will have limited or no ability to influence a potential sale of the Company or a substantial portion of its assets. Thus, the Investor will rely upon the executive management of the Company to manage the Company so as to maximize value for unitholders. Accordingly, the success of the Investor's investment in the Company will depend in large part upon the skill and expertise of the executive management of the Company. If the Management of the Company authorizes a sale of all or a part of the Company, or a disposition of a substantial portion of the Company's assets, there can be no guarantee that the value received by the Investor, together with the fair market estimate of the value remaining in the Company, will be equal to or exceed the value of the Investor's initial investment in the Company.

In 5 years, we want our Red Hook location to thrive, and to open stores in 2 additional Brooklyn neighborhoods. These projections cannot be guaranteed.

#### Milestones

Radio Free Red Hook LLC was incorporated in the State of New York in June 2007.

Since then, we have:

- 🍽️ New location has 2x square footage, 2x production space, and space for 40-person outdoor seating

#### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$901,709.19 compared to the year ended December 31, 2019, when the Company had revenues of \$1,530,652.77. Our gross margin was 49.35% in fiscal year 2020, compared to 60.92% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$38,222.53, including -\$14,731.10 in cash. As of December 31, 2019, the Company had \$93,774.09 in total assets, including \$36,979.94 in cash.
- *Net Loss.* The Company has had net losses of \$365,518.50 and net losses of \$1,433.77 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$531,391.66 for the fiscal year ended December 31, 2020 and \$207,125.59 for the fiscal year ended December 31, 2019.

## Liquidity & Capital Resources

To-date, the company has been financed with \$421,770 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 0 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

## Runway & Short/Mid Term Expenses

Radio Free Red Hook LLC cash in hand is \$21,297, as of March 2021. Over the last three months, revenues have averaged \$78,297/month, cost of goods sold has averaged \$36,714/month, and operational expenses have averaged \$63,382/month, for an average burn rate of \$21,799 per month. Our intent is to be profitable in 12 months.

Since the date our financials cover, COVID-19 restrictions have eased in New York City, allowing for indoor seating. In general, there is a big uptick in financial activity in the restaurant sector since vaccines have become available.

Over the next 3-6 months, we plan to open our new location (in June), and expect revenue for June - August 2021 to be \$340,000 and expenses to be around \$265,000 for the same time period. We plan to cover short term burn with the second PPP loan that we recently received.

Outside of this raise, according to our calculations, we are eligible to receive \$228,484 in funding from the Restaurant Revitalization Fund. It's not guaranteed that we will receive this funding.
