Our technology is cutting edge and it is priced to reflect that. It is possible that our sales numbers will be lessened because it is a premium product. We however have no such concerns that it will not sell because people purchase premium products every day.

Our business depends on the change in the mindset of those that have rain capture systems to drink the water. In the Caribbean alone there are over 500,000 cisterns, yet most of the people consume bottled water. This has been occurring for over a decade, and the people having been told repeatedly the cistern water is unsafe, which is true, until now.

There is a risk that a major company will purchase one of our units, reverse engineer our patented technology, and begin selling very similar systems at dramatically reduced prices, in order to take over the marketplace and push us out.

There is a risk that some of our suppliers will suddenly have to backorder parts for months, which are critical to our providing timely delivery of orders. This could cause our company to have a bad reputation as being unreliable, causing us to lose customers.

There is a risk that if we do not control our growth, that we take on too many customers because of a desire to grow, that it will dramatically impact our ability to provide products within a reasonable time.

COVID-19 can materially impact our business.

It is unclear how long the COVID-19 pandemic will last and to what degree it could hurt our ability to generate revenues.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Jon Simpson is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Interest Rate: 5%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

Conversion and Repayment

a) Conversion upon a Qualified Financing. In the event that the Company issues and sells shares of its equity securities ("Equity Securities") to investors (the "investors") on or before the Maturity Date in an equity financing with total proceeds to the Company of not less than \$500,000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the cash price paid per share for Equity Securities by the investors in the Qualified Financing multiplied by 0.8, and (ii) the quotient resulting from dividing \$3,000,000 by the number of outstanding shares of Common Stock of the Company as of the date of the Note (assuming conversion of all securities

convertible into Common Stock and exercise of all outstanding options and warrants, including all shares of Common Stock reserved and available for future grant under any equity incentive or similar plan of the Company, and/or any equity incentive or similar plan to be created or increased in connection with the Qualified Financing, but excluding the shares of equity securities of the Company issuable upon the conversion of Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing.

(b) Optional Conversion on Non-Qualified Financing. In the event that the Company issues and sells equity securities to Investors on or before the Maturity Date in a financing with total proceeds to the Company of less than \$500,000 (excluding the conversion of this Note) (a "Non-Qualified Financing"), then Holder may elect to convert the outstanding principal amount of the Note, together with any accrued but unpaid interest, into such equity securities issued in such Non-Qualified Financing at a conversion price equal to eighty percent (80%) of the price paid by the Investors purchasing the equity securities in such Non-Qualified Financing. The Company shall provide written notice of any Non-Qualified Financing at least thirty (30) days prior to the closing thereof, and Holder shall provide prior written notice of its intent to convert under this Section 1.(b) to the Company at least ten (10) days prior to such closing date. Other than the method of payment for such equity securities (i.e., by conversion of the Note), the sale and offering of such equity securities to Holder shall be on the same terms and conditions as given to the Investors in such Non-Qualified Financing. In the event of a conversion pursuant to this Section 1.(b), Holder will execute and be bound by, and receive the benefits of, the terms and conditions on any documents or agreements being entered into by the Investors in the Non-Qualified Financing.

(c) Change of Control. If the Company consummates a Change of Control (as defined below) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal; provided, however, that upon the written election of the Holder made not less than five days prior to the Change of Control, the Company shall convert the outstanding principal balance of this Note and any unpaid accrued interest into shares of the Company's Common Stock at a conversion price equal to the quotient resulting from dividing \$3,000,000 by the number of outstanding shares of Common Stock of the Company as of the date of the Note (assuming conversion of all securities convertible into Common Stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

(d) Procedure for Conversion. In connection with any conversion of this Note into capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

(e) Interest Accrual. If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

Senior Indebtedness

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Overview

We manufacture a line of what we believe to be the most advanced point-of-entry water purifications anywhere. Called Caripur H2O, our ultrafiltration based purifiers are designed to purify water as it enters your home or building. They use almost no energy and will run from solar energy. They remove harmful elements from water including bacteria, viruses, parasites, pesticides, chlorine. A minicomputer monitors the system, the water, and controls purging. We believe they operate 5-7 years before requiring minor maintenance.

By year five we expect to sell a minimum of 25,000 units annually. This will net us approx. \$99,333,000.00 annually. We are the only such technology in this space, with the exception of Reverse Osmosis, which owns a very small part of the residential and commercial marketplace. These projections are not guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Caribbean Water Technologies Inc. was incorporated in the U.S. Virgin Islands in March 2021. CWT is a newly formed company that builds advanced rainwater purification technology. CWT is a wholly owned subsidiary of Bondurant Technologies International, Inc.

Since then, we have:

- 1 awarded, 2 derivative patents pending for intelligent home & commercial water purification. The patent is held by the founder, Nimon Bondurant.
- Passive drinking water purification technology, self-cleaning, 7+ year operation, minimal maintenance
- Scalable technology allows us to introduce lightweight backpack, boat, and RV systems, in Q3 2021
- Removes waterborne bacteria, viruses, cysts, bad taste, chlorine, and heavy metals, and chemicals
- Energy-efficient, install-and-forget technology that can run on A/C, DC, or Solar power
- Water quality, Early Warning System with miniature multispectral water analysis technology.
- Internet of Things with streaming real-time reporting via iOS or Android phone app

Historical Results of Operations

Our company was organized in March 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- **Revenues & Gross Margin.** For the period ended March 12, 2021, the Company had revenues of \$0.
- **Assets.** As of March 12, 2021, the Company had total assets of \$20, including \$0 in cash.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Caribbean Water Technologies Inc. cash in hand is \$0, as of March 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$0/month, for an average burn rate of \$0 per month. Our intent is to be profitable in 8 months.

Since the date of our financials, March 2021, there have been no material trends or changes in our finances. We are a startup looking to raise funding for the manufacture of our devices.

Six months following our Wefunder raise, we hope to achieve \$100K to \$200K in sales of our hardware and data to both consumer and commercial interests, with accompanying expenses of \$58,000. This is in total over that time period.

This projection is based on the assumption that we only need to sell 46 units to make \$200K and we are already getting requests for preorders that exceed that number dramatically. Additionally, we will be doing demand manufacturing and we already have a company lined up that will manufacture our units. We need around \$100K in funding to reach these projections, and \$158K in funding to reach a breakeven point. These projections are not guaranteed.

As far as other sources of capital, we have additional investors that are interested in funding for debt in future rounds after this funding raise.
