2020 Financial Footnotes

Revenue - The company is currently pre-revenue and in development of its first consumer viable product

Financing - The company has received \$58,230 for Research and Development as well as general operating activity's by the founder and CEO David Valverde Vargas since inception to date that has been the only capital provided to Pranos Inc.

Equity - The company has 10 million shares of common stock authorized. 8,229,000 shares have been issued/outstanding. As seen on the cap table 2,102,045 of those issued shares are on 4 year vesting schedules. Every team member is under a comprehensive NDA and IP assignment agreement.

Compensation - Cofounders - Contractors and other team members have only been compensated with restricted stock agreements and on a 4 year vesting schedules. Since the company is still in the start up phase and is pre-revenue and pre-financing, there are no salaries to be accounted for. The Founder and CEO (David Valverde Vargas) has his stock fully vested and has also not received any cash compensation to date.

Patents - Pranos Inc has filed a provisional patent application to the USPTO and an International PCT application with the Korean Intellectual Property Office designed as the international search authority.

Commitments & Contingencies - The Company is not currently involved with and does not know of any pending or threatening litigation against the Company or it's members.
