Financial Risk - The primary risk to the company is financial, requiring either achieving breakeven or securing follow on funding to continue to grow until the company is profitable or is sold. Until breakeven is achieved, the company will be dependent on some amount of third party financing.

Execution Risk - The company must execute on its strategy and will need the services of a capable team. The inability to attract or retain talent is a risk for early stage companies with limited resources.

Competitive Risk - There is always the possibility that larger players could enter the market and compete on the basis of capital. Market entry by larger players could take place via acquisition, however, providing an opportunity to get acquired as the current market leader.

Similar Risk - The company relies on a technology license for key components of

Intellectual Property Risk - The Company's success will be substantially dependent on its proprietary technology and its software. A loss of access to the licensed technology would jeopardize the ability of the company to continue to offer its services. The company has the legal right to buy-out the licensed technology to avoid this potential liability altogether for \$1 million. The company will need the financial resources to exercise this buy-out. The technology provider is a shareholder in the company which provides them with an interest in the success of the company.

Pandemic Risk - Rayyan has been used by research teams around the world to study COVID-19 and in an effort to support those efforts Rayyan hosts a copy of the COVID-19 open research data set which consists of 1M studies. Despite this, the effects of COVID-19 on businesses is unpredictable and therefore may pose a risk to any business. Any such pandemics is likely to drive use of the platform as evidenced by COVID-19, but this is not guaranteed.

SAFE risk - The Company may not receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

Ownership and Capital Structure

THE OFFERING

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**,

investors will receive a number of shares of preferred stock calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the investor's investment, divided by
 - a. the price of **preferred stock** issued to new investors multiplied by
 - b. the **discount rate** (80%), or
- ii. if the valuation for the company is more than **\$17,500,000.00** (the pre-money "Valuation Cap"), the amount invested by the investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all (i) issued and outstanding Options and (ii) Promised Options;
- Excludes all Converting Securities;
- Includes the Unissued Option Pool; and
- Excludes, notwithstanding the foregoing, any increases to the Unissued Option Pool (except to the extent necessary to cover Promised Options that exceed the Unissued Option Pool) in connection with the Equity Financing.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving **preferred stock**, investors will receive:

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount").

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

i. the Investor or

ii. the majority-in-interest of all then-outstanding Safes with the same "Pre-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):

A. the Purchase Amount may not be amended, waived or modified in this manner;

B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained); and

C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

The company has not yet authorized preferred stock, which investors in this offering would receive if the SAFE converts as part of an equity financing event. Preferred stock has a liquidation preference over common stock.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Overview

The company was organized to accelerate scientific and medical discoveries to benefit human health through evidence-based medicine.

Rayyan helps researchers quickly extract and synthesize valuable data from research papers to accelerate scientific discovery and support evidence-based medicine.

In 5 years, the company hopes to grow to 10 million+ researchers and generate \$100 million in annual recurring revenue and will be the largest community of practice of its kind for researchers who create and exchange value. Future projections cannot be guaranteed.

Milestones

Rayvan Systems Inc. was incorporated in the State of Delaware in December

2020.

Since then, we have:

- 300,000+ researchers from 15k+ organizations across 180 countries use Rayyan to conduct research
- 700+ million research studies have been reviewed using Rayyan
- 600K+ research projects have been started on Rayyan with an average of 500 new ones started per day
- 15+ million annotations to data are made in a single 30 day period.
- 12000+ researchers are signing up monthly by word of mouth alone
- Revenue generating with sufficient scale to achieve projected profitability

Historical Results of Operations

Our company was organized in December 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- **Revenue & Gross Margin.** For the period ended December 31, 2022, the Company had revenues of \$31,268 compared to the year ended December 31, 2021, when the Company had revenues of \$1,469. Our gross margin was 89.88% in fiscal year 2022, compared to 81.42% in 2021.
- **Assets.** As of December 31, 2022, the Company had total assets of \$100,032, including \$28,295 in cash. As of December 31, 2021, the Company had \$245,552 in total assets, including \$198,104 in cash.
- **Net Loss.** The Company has had net losses of \$621,924 and net losses of \$463,092 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- **Liabilities.** The Company's liabilities totaled \$477,683 for the fiscal year ended December 31, 2022 and \$464,902 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$377 in debt, \$120,000 in convertibles, and \$1,244,650 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Rayyan Systems Inc. cash in hand is \$111,122.46, as of June 2023. Over the last three months, revenues have averaged \$12,000/month, cost of goods sold has averaged \$3,600/month, and operational expenses have averaged \$55,000/month, for an average burn rate of \$46,600 per month. Our intent is to be profitable in 6 months.

Since the date of our financials, we have a number of sales-related initiatives including partnerships to help sell Rayyan globally. We hired a salesperson to focus on the Americas where the majority of our user base is located. We have begun reducing costs of our infrastructure to make scaling even more economical. We also have released the initial beta of an entirely new user interface that will soon include the upgrade triggers that freemium businesses rely upon.

We expect to close the year with \$479,000 in sales by end of year while incurring approximately the same in expenses.

We are not yet profitable. We believe the initiatives we have in place will enable us to become profitable within the next 6 to 12 months. We anticipate needing between \$360,000 and \$600,000 to reach profitability. We have several sales related initiatives to help us achieve higher rates of conversion. We are working on extending the workflow covered by our solution which will also extend the average contract length and increase the average revenue per customer as well as the lifetime value. We are already at a scale of use that provides us with enough users to reach profitability with a reasonable expectation on the percentage converting to paid subscription and we continue to grow month over month without advertising. With the effects of advertising we expect to be able to bend the growth curve upwards and using scale as one way to achieve profitability. The other way is through our sales initiatives, including B2B sales.

Aside from Wefunder, we are in discussions with our existing investors and new investors about investing in this round outside of Wefunder. So, Wefunder is not the only source of financing for the company. We are also taking on additional angel investors on a rolling basis to help cover short-term burn.

All projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor may receive compensation if, in the future, Wefunder Advisers LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisers) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not

revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, audio or other means not able to be reflected in text or portable document format, the issuer should include:
(a) a description of the material content of such information;
(b) a description of the format in which such disclosure is presented; and

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(5), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
