Hardware with Software (aka Deep Tech) ventures are capital intensive. Although we intend to raise an adequate amount of capital, undercapitalization is a potential risk.

Our drones land at their destination. Therefore, drones could be stolen, broken into or damaged. All drones will be insured and have a comprehensive list of safety features to mitigate this risk.

Public acceptance has already started to shift in our favour but we are still vulnerable to bad PR. Currently, some online shoppers are anxious about privacy and safety regarding delivery drone operations.

Corruption exists at the government level in some developing countries. For example, bribes could allow our competitors to win business opportunities over Skycart.

Skycart has never operated in Africa. Therefore, we have an operational knowledge gap which we have to fill. To get a head-start on this we have been regularly speaking to potential customers in Africa to plan how we can effectively integrate our operations.

We are pioneering multi-packaged delivery drones. Therefore, we have not verified the benefits of multi-drop drone technology. For example, we have not verified the per km cost savings of Skycart vs drone competitors.

Although we have patents to protect our Intellectual Property, big players like Amazon could infringe on our patent. We might not have the resources to litigate against them.

Drones have only recently extended their reach to Africa. This means that we will be recruiting from a small pool of qualified drone pilots and drone maintenance engineers. We will likely have to invest time and money into training our personnel.

Bad weather can affect drone operations. Large air movements can send small drones bumping into buildings or fall from the sky; hail storms can damage drones. However with such adverse weather conditions, drone flights are usually cancelled.

Although we have contracts which are signed by our customers pertaining to our current orders, these orders have not yet been paid to Skycart. We cannot guarantee that our current orders will generate revenue for Skycart.

Our profit margins may change in the future - we cannot guarantee that our margins will stay the same.

Actual drone appearance may slightly change from what is seen on our write up and video pitch.

COVID-19 can materially impact our business.

It is unclear how long the COVID-19 pandemic will last and to what degree it could hurt our ability to generate revenues

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never

undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Stephen Enright is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**,

Investors will receive a number of shares of preferred stock calculated using the method that results in the greater number of **preferred stock**:

1. the total value of the investor's investment, divided by
 1. the price of **preferred stock** issued to new investors multiplied by
 2. the **discount rate** (85%), or
2. if the valuation for the company is more than **\$19,000,000** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$200,000** of the securities, investors will receive a valuation cap of **\$18,000,000** and a discount rate of 80%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving **preferred stock**, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

1. the Purchase Amount may not be amended, waived or modified in this manner,

2. the consent of the investor and each holder of such Safes must be solicited (even if not obtained), and

3. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

- Currently there is only one class of common stock. All common stock holders have the same rights.

If these SAFE holders convert, they will convert to Preferred stock with liquidation preference over Common stock holders.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Skycart is a growing provider of drone-enabled delivery solutions that reduces the cost of the expensive last mile delivery process. We leverage our proprietary technology, deep expertise, supplier and vendor relationships to improve patient access to crucial medical supplies in partnership with the Ministries of Health, National Health Service Organizations, International/Non-Governmental Health Care Organizations, Third Party Logistics Service Providers, Pharmaceutical manufacturers and specialized medicine supply organizations in developing countries.

We plan to generate revenue by leasing our delivery drones to our customers, or by charging our customers per mile of delivery. In addition, we plan to collect monthly subscription fees for drone management software in the cloud for every drone our customers deploy. Drone usage fees and cloud subscription fees are our primary sources of revenue. Other sources of revenue include consultation, technical support, and training.

These solutions consist primarily of our Unmanned aerial vehicle, or 'drone'-based logistic offerings that automate the ability to deliver life-saving materials to restock essential medicines and supplies. Our 'drone'-based technology does this by executing preflight safety checks, communicating with Civil Aviation air traffic management systems to get flight approval, programming drone delivery flight and rerouting through our cloud service, tracking deliveries and logging them, detecting and avoiding collisions during flight, detecting abnormal drone system function and executing built in failsafes to ensure safety is always priority, and flying to GPS locations autonomously to deliver packages.

As drone usage and cloud subscriptions are our primary sources of revenue. Over the last several years the need for drone delivery has increased due to consumer demand for faster and faster delivery times as evident from data collected from the ecommerce industry. In addition, delivery drones have been envisioned to serve different market verticals and have been widely tested as having great

benefit to increasing delivery speed as well as to reduce delivery costs. As a result, delivery drones have been getting great interest and are becoming more widely used in different market verticals. This has led to a pent up demand for our delivery drones and it's supporting services each year. However, not all market verticals make delivery drones viable due to the high cost of the system. We expect that the cost of the system will eventually go down over time and most businesses would be able to afford such a system. Through customer engagement and market analysis of market verticals that our drones can service, we have determined that two verticals stand out in terms of viability, medical deliveries and firefighting deliveries. We chose to focus on medical deliveries because it is where we can make the biggest impact for ourselves and for the public.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Our business was founded around the creation of a new express delivery service, on January 14, 2015, that promises to deliver items in 30 minutes or less using drones. Because drone technology and its supporting software systems did not exist for our purposes at that time, we had to design and develop them ourselves. We have achieved the following milestones towards our vision:

- * Revenue traction: \$200K revenue (generated between 2015 and 2018)
- * Revenue traction: Secured \$4M in purchase orders for drones once production is complete (expected in fall 2021)
- * Investment traction: Secured more than \$210K in investments
- * IP traction: 2 Patents in autonomous delivery pickup and multi-delivery technologies. The Company owns the patent on the Autonomous Pickup System; Simon Yuen currently owns the patent on the Multi-delivery System that will be transferred to the Company.
- * IP traction: Designed, manufactured, and operated our short and long range delivery drones that maximizes delivery efficiency versus population density
- * IP traction: Designed the first four package delivery drone in the world
- * Biz Dev traction: Partnered with Swiss Post to expand delivery drone services in Switzerland beginning with medical deliveries
- * Biz Dev traction: Secured signed Letter of Intent with Busia County, Kenya to perform medical deliveries that serve major and minor hospitals, and their communities
- * Regulatory traction: Successfully undergone Swiss regulatory approval processes that is adopted around the world for drone delivery

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$0 compared to the year ended December 31, 2019, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2020, the Company had total assets of \$98,794, including \$733 in cash. As of December 31, 2019, the Company had \$76,932 in total assets, including \$1,060 in cash.
- *Net Loss.* The Company has had net losses of \$12,630 and net losses of \$12,659 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$233,404 for the fiscal year ended December 31, 2020 and \$198,916 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$129,265 in debt, \$130,000 in SAFEs and \$158,853 in additional paid in capital from the founders.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Skycart Inc. cash in hand is \$27.77, as of July 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$435/month, for an average burn rate of \$435 per month. Our intent is to be profitable in 24 months.

Our financials do not reflect our generated revenues. Between 2015 and 2018, we generated around \$200k through projects with partners. In 2019 and throughout 2020, we pivoted from our original plan and paused operations in order to focus on R&D on our four package delivery drone. We are wrapping up R&D and plan to send our drone to manufacturing in August 2021 and believe it will be ready in October 2021 to begin operations.

In the next 3-6 months, our expenses will increase due to manufacturing of drones and an increase in operations as we prepare for revenue generating operations in a collaborative partnership with the Kenyan government. When we begin operations in Oct 2021, we expect to generate monthly revenues of \$83,333 with accompanying expenses of \$66,667, though this is not guaranteed. We also have secured approximately \$4,000,000 in purchase orders from two other vendors for their drone once production is complete.

In terms of other sources of capital, we have our founder's savings, and we will take out bank loans if needed to cover short-term burn.

As described above, each investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to investors before investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include: (a) a description of the material content of such information; (b) a description of the format in which such disclosure is presented; and (c) in the case of disclosure in video, audio or other dynamic media or format, a transcript or description of such disclosure.

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

The issuer must continue to comply with the ongoing reporting requirements until:

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
