An investment in the Offering is extremely speculative and there can be no assurance of any return on any such investment.

The Company is a development-stage company, which makes it difficult to evaluate its prospects.

COVID-19. Our first program, the Brazen Fellowship, is an in-person fellowship where we provide laboratory and housing facilities to selected founders. Measures taken to prevent and contain the spread of the virus will follow recommendations by Cal/OSHA. The Cal/OSHA Emergency Temporary Standards (ETS) released November 2020 are still in effect and may impact our ability to run the proposed fellowship as planned.

If we do not develop successful new services or improve existing ones, our business will suffer. Our ability to engage, retain, and increase our user base and to generate our revenue will depend heavily on our ability to successfully create or improve services both independently and together with third parties. We may introduce significant changes to our existing services or develop and introduce new and unproven services, including technologies with which we have little or no prior development or operating experience.

If the Maximum Offering amount is not raised, it may increase the amount of long-term debt or the amount of additional equity we need to raise. The Company will have broad discretion in using the proceeds from the offering.

The Company will need significant additional capital to operate the business and execute our business strategy as currently contemplated and have not identified significant alternative sources of funding should this offering be unsuccessful. Unless additional financing is obtained beyond this financing, the Company will need to slow its progress, reduce its scope or close its operations.

We have little operating history and expect to incur losses for the foreseeable future and may never achieve profitability.

We may not be able to hire, train or maintain the personnel required for operations, development, partnering or marketing as planned.

The Company currently has no marketing organization and has no experience in marketing biotechnology services. If the Company is unable to establish marketing capabilities or fails to enter into agreements with third parties to market offerings, the Company may not be able to effectively recruit and generate revenue.

The Company relies on its scientific advisers and consultants, and cancellation by or conflict with its advisors or consultants could harm its business.

Any cancellation by or conflicts with collaborators or contractors could harm the Company's business.

Intellectual Property may be challenged resulting in a limitation of the claims of the patents or the patent(s) to be found invalid with the possible impact of reducing the valuation of the Company and affecting Company returns.

Competitors may develop and implement a superior offering for the Company's target areas of focus potentially reducing or eliminating the Company's commercial opportunity.

Litigation or third-party claims of intellectual property infringement could reduce or eliminate the Company's commercial opportunity and adversely affect its ability to operate.

The Company may use hazardous chemicals and radioactive and biological materials and any disputes relating to improper handling, storage or disposal of these materials could be time consuming and costly.

The Company operates in the healthcare industry that is subject to complex government regulations. Consequentially, the inadvertent or unintentional failure to comply with the complex government regulations could impact the Company's revenue and adversely affect its reputation.

The Company may be subject to certain government regulatory requirements relating to genetically modified organisms.

No public market exists and no trading market may ever develop for the Company's Common Stock. The Company does not intend to pay dividends in the foreseeable future.

Raising additional funds by issuing securities or through licensing or lending arrangements may cause dilution to Brazen Bio's existing stockholders, restrict its operations or require it to relinquish proprietary rights.

The Company may issue additional shares of capital stock that may dilute shareholder ownership interest.

There is a risk the Company might be deemed an investment company under the Investment Company Act of 1940, as amended. If the Company is deemed to be an investment company under such Act the Company would become subject to a host of regulations and filing requirements that would be extremely burdensome and would negatively affect our financial condition, operations, and prospects. The Company expects to acquire only controlling interests in the subsidiaries that we operate. If, however, for any reason, we acquire less than a controlling interest and 40% or more of our assets are deemed to be investments in investment



and 1792 of the Securities Act. If the Securities are deemed to be investment securities, then we may be deemed an investment company under such Act.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the Investor's investment, divided by the price of **preferred stock** issued to new Investors, or
- ii. for investors up to the first **\$250,000** of the securities, investors will receive a **discount of 20%**.

*"MFN" Amendment Provision*" If the Company issues any Subsequent Convertible Securities prior to termination of this Safe, the Company will promptly provide the Investor with written notice thereof, together with a copy of all documentation relating to such Subsequent Convertible Securities and, upon written request of the Investor, any additional information related to such Subsequent Convertible Securities as may be reasonably requested by the Investor. In the event the Investor determines that the terms of the Subsequent Convertible Securities are preferable to the terms of this instrument, the Investor will notify the Company in writing. Promptly after receipt of such written notice from the Investor, the Company agrees to amend and restate this instrument to be identical to the instrument(s) evidencing the Subsequent Convertible Securities

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and

- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferee or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

#### Milestones

Brazen Bio Inc. was incorporated in the State of Delaware in May 2021.

Since then, we have:

- Built a diverse team of senior advisors called the Senior Fellowship
- We have been granted membership at BioLabs LA at the Lundquist Institute, a state-of-the-art laboratory space with access to over \$1.5M in equipment.
- Began building the operations team for the Brazen Fellowship
- Began outreach to recruit founders for the Brazen Fellowship

#### Historical Results of Operations

Our company was organized in May 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended June 11, 2021, the Company had revenues of \$0.
- *Assets.* As of June 11, 2021, the Company had total assets of \$90, including \$90 in cash.
- *Net Income.* The Company has had net income of \$0 for 2021.
- *Liabilities.* The Company's liabilities totaled \$0 for 2021.

#### Liquidity & Capital Resources

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 9 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. #### Runway & Short/Mid Term Expenses

Brazen Bio Inc. cash in hand is \$90, as of June 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$0/month, for an average burn rate of \$0 per month. Our intent is to be profitable in 60 months.

There have been no material changes or trends since the date of our financials.

Beyond the current raise, we expect approximately \$50K in revenues in the next 3-6 months from sponsorships. We expect to incur \$120k-\$200k in expenses in the same period. We expect to raise a total of \$750k through this offering and/or subsequent offerings in order to eventually reach a revenue-generating point by 2023/2024. These projections cannot be guaranteed.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

*INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:*

## ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
