Changes to Chilean pisco regulations, protected designation of origin geographic restrictions, production methods, grape varieties, export procedures, or other specifications could require production changes or limit export capabilities. Failure to comply may prohibit use of the pisco designation.

Variations in United States federal, state, or municipal regulations surrounding alcohol sale, distribution, labeling, trade practice, shipping, and taxation may restrict or eliminate certain sales channels, restrict shipping abilities, or increase production and sales costs. We may fail to comply with varied regulations across thousands of jurisdictional authorities.

Trade partnerships between governments, including withdrawal from existing agreements or failure to enact new arrangements, may introduce export/import tariffs, quotas, or duties that raise production costs and market access barriers.

Reliance on fair trade certified grape growers in the Ovalle region creates concentration risk; climate change, water scarcity, fires, crop disease, soil depletion, natural disasters, or labor shortages could significantly limit grape supply. Grape costs may rise materially.

Input materials including glass, closures, labeling, and packaging originate from single providers with limited alternate sourcing capabilities. Inability to source these materials may prevent product delivery.

Global economic disruption, port congestion, shipping capacity reduction, fuel costs and price increases may negatively influence transport expenses and margin.

Over 400 existing pisco brands and low barriers to entry could enable new entrants to erode Catan's market share. First mover advantage may provide outsized resources for early category leaders to invest in brand awareness and loyalty programs, making it difficult for Catan to capture shelf space and consumer adoption.

Pricing pressure from other spirit categories like vodka and tequila may hamper sales goals or require reduction of pricing levels below break-even profitability.

Consolidation among distributors or retailers may concentrate purchasing decisions to a smaller set of buyers, increasing relevance of bulk orders from a few major retail chains. Loss of any such key account could significantly reduce revenue.

As a recently launched brand, Catan Pisco has no operating history to effectively evaluate business prospects. Sales may substantially differ from projections. Management may prove incapable of scaling operations as expected.

Working capital constraints may negatively influence inventory levels, marketing capability, new market expansion, staffing, consumer discounts and allowances, and supplier payment flexibility. Access to future financing is not guaranteed.

Results can fluctuate seasonally based on tourism, holidays, agricultural harvests, and distributor/retailer inventory adjustments. Weather events, arrived damaged product, production downtime, and other inconsistencies may influence intraperiod results.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

## Ownership and Capital Structure

### THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Units** in the Company ("**Preferred Units**"), when and if the Company sponsors an equity offering that involves **Preferred Units**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving Preferred Units,

Investors will receive a number of Preferred Units calculated using the method that results in the greater number of Preferred Units:

- i. the total value of the Investor's investment, divided by the price of Preferred Units issued to new Investors, or
- ii. if the valuation for the company is more than **\$5,000,000.00 (the "Valuation Cap")**, the amount invested by the Investor divided by the quotient of
  - a. the Valuation Cap divided by
  - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the **first \$100,000.00** of the securities, investors will receive a **valuation cap of \$5,000,000.00**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

**Additional Terms of the Valuation Cap.** For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Units basis):

- Includes all shares of Capital Units issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and

- 1: the Purchase Amount (the "Cash-Out Amount") or
- 2: the amount payable on the number of shares of Common Units equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

**Liquidity Priority.** In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Units. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Units);
2. On par with payments for other Safes and/or Preferred Units, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Units, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Unit in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Units.

**Irrevocable Proxy.** The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

**Repurchase.** If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(a) or 15(d) thereof, the Company

shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

#### VIP Bonus

Catan Pisco will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The company has not yet authorized preferred units which investors in this offering would receive if the SAFE converts as part of an equity financing event. Preferred units have a liquidation preference over common units. Class A Units are capital units (common units) in the LLC. Class A Members have voting rights on certain matters in accordance with the terms of the Operating Agreement. Class B Units are designated as profits interests. They carry no voting rights and are subject to a profits interest hurdle.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the operating agreement

for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

**The unitholders** have the right to redeem their securities at any time.

**Unitholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The initial amount invested in a SAFE is determined by the investor, and we do not guarantee that the SAFE will be converted into any particular number of **units**. In the future, we will perform valuations of our **units** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Management, and the Investor will have no independent right to name or remove an officer or member of the Management of the Company.

By acquiring an interest in the Company, the Investor will be deemed to have acknowledged the existence of any such actual or potential conflicts of interest and to have waived any claim with respect to any liability arising from the existence of any such conflict of

interest.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

#### **Historical Results of Operations**

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$75,536 compared to the year ended December 31, 2022, when the Company had revenues of \$54,825. Our gross margin was 52.69% in fiscal year 2023, compared to 38.27% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$119,329, including \$7,054 in cash. As of December 31, 2022, the Company had \$114,467 in total assets, including \$51,579 in cash.
- *Net Loss.* The Company has had net losses of \$29,599 and net losses of \$47,238 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$39,381 for the fiscal year ended December 31, 2023 and \$15,045 for the fiscal year ended December 31, 2022.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$33,600 in debt. We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not



possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Catan Pisco & Co, LLC cash in hand is \$10,000, as of February 2024. Over the last three months, revenues have averaged \$6,000/month, cost of goods sold has averaged \$3,100/month, and operational expenses have averaged \$5,000/month, for an average burn rate of \$2,700 per month. Our intent is to be profitable in 36 months.

Since the date of our financials, we have imported our largest production of over 1,200 cases in a FCL (full container load) which was very expensive. Our first true year out of the pandemic was 2023 and founder (and only full time employee) delivered her second son which delayed sales operations for short time.

In the next 3-6 months, we expect to incur \$12,500 in monthly expenses, and perhaps \$10-12k in monthly revenue.

We are not yet profitable. We believe we'll need approximately \$300-500k in capital to hire more sales support and grow in profitability.

For additional sources of capital outside of this offering, we could solicit a loan from the SBA, and take out additional credit card capital if absolutely necessary.

All projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities. Investors will receive disclosure regarding all fees that may be received by the Lead Investor.
