Technical Risks: Pirouette's auto-injectors involve complex design and manufacturing processes. The product's performance relies heavily on meeting essential performance requirements (EPRs) such as extended needle length, injection time, and delivered dose. Any deviation in these performance metrics can significantly impact the reliability and effectiveness of the auto-injectors.

Regulatory Risks: There is a risk that Pirouette may not achieve regulatory approval for its products. The regulatory pathway involves specific testing and compliance with standards, which presents challenges in meeting the requirements set by regulatory bodies like the FDA.

Commercialization Risks (Distribution + Pricing/Reimbursement): Pirouette faces challenges in commercializing its epinephrine and naloxone auto-injectors. Success depends on effective distribution

injectors. Success depends on effective distribution, pricing, reimbursement strategies, and gaining market acceptance against established competitors.

Commercialization Risks (Intellectual Property): Pirouette relies on its patented technology for the novel auto-injector, form factor, and internal mechanisms. There is a risk associated with protecting these patents and maintaining their competitive advantage in various international markets.

Market Acceptance Risk: There is a risk that the market may not readily accept Pirouette's new auto-injector technology. Market trends and consumer preferences can be unpredictable and may not align with the company's expectations.

Supply Chain and Manufacturing Risk: Given the custom design of Pirouette's auto-injectors, there is a risk in maintaining a consistent and reliable supply chain and manufacturing processes. Any disruptions or inefficiencies can impact product availability and quality.

Competitive Landscape Risk: Pirouette operates in a highly competitive market with established players. The company faces the risk of intense competition which may affect its market share and profitability.

Technology Obsolescence Risk: As Pirouette's products are technology-driven, there is a risk of the technology becoming obsolete due to rapid advancements in the field or the introduction of superior technologies by competitors.

Financial Sustainability Risk: Pirouette may face challenges in ensuring long-term financial sustainability, especially given the significant costs associated with R&D, manufacturing, and marketing in a competitive and regulated market.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. The main terms of the SAFEs are provided below.

The Discount Rate is 80.00%.

The Pre-Money Valuation Cap is \$55,000,000.00.

We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion in a Qualified Financing

In the event that the Company issues and sells Preferred Stock in a bona fide transaction or series of transactions with the principal purpose of raising capital for aggregate proceeds of at least US\$10,000,000 at a fixed valuation, including but not limited to, a pre-money or post-money valuation (a "Qualified Financing") before the termination of this SAFE, this SAFE will automatically convert into the number of shares of SAFE Preferred Stock equal to the Purchase Amount divided by the lower of (1) the Cap Price or (2) the Discount Price (the "Conversion Price") upon the occurrence of such Qualified Financing.

Optional Conversion in Nonqualified Financing

If the Company issues and sells Preferred Stock in an equity financing that does not constitute a Qualified Financing, then the Majority Holders shall have the option to treat such equity financing as a Qualified Financing on the same terms set forth herein.

Liquidity Event

If there is a Change of Control, a Direct Listing or an Initial Public Offering (a "Liquidity Event") before the termination of this SAFE, this SAFE will automatically be entitled (subject to the liquidation priority set forth in Section 5 below) to receive a portion of Proceeds, due and payable

to the Investor immediately prior to, or concurrent with, the consummation of such Liquidity Event, equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount"). If any of the Company's securityholders are given a choice as to the form and amount of Proceeds to be received in a Liquidity Event, the Investor will be given the same choice, provided that the Investor may not choose to receive a form of consideration that the Investor would be ineligible to receive as a result of the Investor's failure to satisfy any requirement or limitation generally applicable to the Company's securityholders, or under any applicable laws.

Dissolution Event

If there is a (i) a voluntary termination of operations, (ii) a general assignment for the benefit of the Company's creditors or (iii) any other liquidation, dissolution or winding up of the Company (excluding a Liquidity Event), whether voluntary or involuntary (a "Dissolution Event"), before the termination of this SAFE, the Investor will automatically be entitled (subject to the liquidation priority set forth in Section 5 of the attached SAFE) to receive a portion of Proceeds equal to the Cash-Out Amount, due and payable to the Investor immediately prior to the consummation of the Dissolution Event.

Liquidation Priority

In a Liquidity Event or Dissolution Event, this SAFE is intended to operate like standard non-participating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

(i) Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);

(ii) On par with payments for other SAFEs and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other SAFEs and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other SAFEs and/or Preferred Stock in proportion to the full payments that would otherwise be due; and

(iii) Senior to payments for Common Stock

(iii) senior to payments for common stock.

The Investor's right to receive its Conversion Amount is (A) on par with payments for Common Stock and other SAFEs and/or Preferred Stock who are also receiving Conversion Amounts or Proceeds on a similar as-converted to Common Stock basis, and (B) junior to payments described in clauses (i) and (ii) above (in the latter case, to the extent such payments are Cash-Out Amounts or similar liquidation preferences).

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the

through a power of attorney granted by investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

 - a. the Purchase Amount may not be amended, waived or modified in this manner,
 - b. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - c. such amendment, waiver or modification treats all such

holders in the same manner. Overview

Convenient healthcare, anywhere.
The Company is a cutting-edge pharmaceutical company that is attempting to change the ways drugs are delivered and revolutionize healthcare accessibility. The Company plans to earn revenue by selling their innovative drug-delivery devices (drug-device) and associated products through various pathways such as in bulk to wholesale distributors or direct to consumers. Additional revenue pathways exist such as licensing the delivery system to drug manufacturers. The Company's customers will be located first in the United States (following FDA Approval) and then plan to spread to global markets, pending subsequent relevant regulatory approvals. Currently, the Company is in the design and development phases of their initial products, has not attained FDA approval, and is thus not revenue generating.

Milestones

Pirouette Medical Inc. was originally organized as an LLC in June 2017. Pirouette Medical was converted from an LLC to C-Corp on May 26, 2021 and retained the same EIN.

Since then, we have:

- Pirouette's founding team are former rocket scientists, innovating on behalf of patients.
- 93% of surveyed patients (n=918) want to switch to Pirouette's epinephrine auto-injector after seeing it in action!

- Conor Cullinane, CEO, received his PhD in Medical Engineering and Medical Physics from MIT/Harvard.
- Pirouette has 18 issued patents and owns all Intellectual Property for the Technology (patents owned by Pirouette Medical Inc.)
- Pirouette is manufacturing the devices in-house, in Portsmouth, NH in the US.
- 70% of surveyed prescribers (n=258) want to switch to prescribing Pirouette's epinephrine auto-injector after seeing it in action!
- Participated in the Summer 2021 batch at Y Combinator.
- Participated in Harvard Business School's Field-X course which is designed to enable students to develop and grow their businesses.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$0 compared to the year ended December 31, 2022, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2023, the Company had total assets of \$4,504,151, including \$2,094,498 in cash. As of December 31, 2022, the Company had \$7,057,533 in total assets, including \$6,212,307 in cash.
- *Net Loss.* The Company has had net losses of \$3,597,016 and net losses of \$2,934,376 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$4,461,895 for the fiscal year ended December 31, 2023 and \$3,418,263 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the company has been financed with \$5,403,482 in equity, \$10,916,200 in SAFEs, \$351,500 in grants, and \$121,779 in PPP loans.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 14 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the

proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 30 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Pirouette Medical Inc. cash in hand is \$2,094,498, as of December 2023. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$300,000/month, for an average burn rate of \$300,000 per month. Our intent is to be profitable in 48 months.

Since the date of its financials, the Company entered into numerous SAFE agreements (Simple Agreement for Future Equity) in 2023 with third parties totaling \$684,700. The SAFE agreements have no maturity date and bear no interest. The agreements provide the right of the investor to future equity in the Company during a qualified financing or change of control event at a 20% discount. Each agreement is subject to a valuation cap. The valuation caps of the agreements entered were \$55M. Between January 1, 2023, and December 15, 2023, the Company spent \$1,484,000 on research and development and prepaid assets.

Between January 1, 2023, and December 15, 2023, the Company spent \$625,000 on capital equipment, \$197,000 on Leasehold Improvements, and \$85,000 on a cleanroom to support short-term research and development as well as long-term commercial manufacturing.

In the next 6 months, we forecast Revenues to be \$0. Revenue generation is expected in October of 2027, and it will take a forecasted \$12.7M in capital. We expect to be incurring roughly \$340k/month in expenses six months from now.

We are not currently profitable. We expect to reach profitability in January of 2028, and it is forecasted to take \$14.0M to reach profitability.

Aside from Wefunder, we have private investment via accredited investors including angels and venture capital. Additionally, we have received an SBIR award from the NIH / National Institute on Drug Abuse to pair Naloxone with our innovative auto-injector for the life-saving treatment of opioid overdose.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the “Proxy”). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors’ behalf.

The Lead Investor is an experienced investor that is chosen

to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company.
