Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Engineurix Corporation is a corporation organized on June 8, 2021, under the laws of Delaware. The Company is developing a consumer health device designed to slow the effects of cognitive decline due to natural aging. Intellihat®, a product which the company is working on developing, is a consumer health device designed to slow the effects of cognitive decline due to natural aging. Intellihat utilized TES and tDCS technology to gently stimulate and target the Dorsal Lateral Prefrontal Cortex (DLPFC), the part of the brain associated with cognitive function. This is wearable technology for the aging brain. Intellihat was designed to deliver powerful technology in a discrete but yet comfortable and fashionable look. The casual design packs years of data-driven science in a stylish high-quality sports cap. Intellihat has specially designed electrodes to gently deliver stimulus to the brain. It has safe conductors for the current to be delivered to the specific region that can reduce cognitive decline. Our patented head worn brain stimulation device uses transcranial electrical stimulation (TES) and transcranial direct current stimulation (tDCS) to gently stimulate and target the dorsolateral prefrontal cortex (DLPFC). The part of the brain most typically associated with cognitive function. Intellihat uses stimulation levels below 1 mA (milliamp) which by FDA regulations does not need to be classified as a medical device. There are over 4500 studies showing that TES and tDCS are safe and can be effective. Electrodes gently stimulate targeted areas of the brain with low-level electric fields. The electrodes deliver a pulse with the intent to slow down the process by which the brain loses “plasticity” – the ability to: Learn, Adapt and Grow. What is Unique About Intellihat Transcranial electrical stimulation (TES) gives our brain circuitry a gentle boost that restores activity toward its level when we were younger. The strength of TES is so low it doesn't cause brain activity itself. The product has reached a stage of a working prototype but needs further development to be mass produced and marketed.

Engineurix Corporation currently has 10 employees.

1. Risks from Pandemics We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities

could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.

2. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
3. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
4. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
7. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.

8. You may only receive limited disclosure. While the company must disclose certain information, since the company is at an early-stage they may only be able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The company may also only be obligated to file information periodically regarding its business, including financial statements. 15. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic

interests in the Company.

18. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The Offering

Engineurix Corporation ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$2,000,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Engineurix Corporation must agree that a transfer agent, which keeps records of our outstanding NetCapital Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). The product has reached a stage of a working prototype but needs further development to be mass produced and marketed. Engineerix Corporation is a pre-revenue company. So far all of our operations have been bootstrapped by our founders. As of inception we have \$1,680 in assets and have an accumulated deficit of \$78,616.
