Potential of future infringements of other streaming platform's patents. There are no known patents that are being used with our platform.

Not enough music professionals onboard on our platform and therefore do not generate enough interest from Fans to buy merchandise, purchase their music or engage on our platform in order to sustain the business model.

Use of Proceeds: 40% towards Staffing/Operating Costs, 25% towards Software Development and hosting expenses, 24% towards Marketing (Social media advertising), 4.5% towards building our Market Share Pool for Streaming payouts, 6.5% towards Wefunder Fees.

If we raise: **\$1,070,000**

Use of Proceeds: 30% towards Staffing/Operating Costs, 25% towards Software Development and hosting expenses as well as bringing some development in house, 25% towards Marketing (Social media advertising), 13.5% towards building our Market Share Pool for Streaming payouts, 6.5% towards Wefunder Fees.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. Vocana, Inc. is offering up to 793,484 shares of Common Stock, at a price per share of \$1.37.

Investors in the first \$149,999.73 of the offering will receive stocks at a price per share of \$1.23, and a pre-money valuation of \$8,983,920.

The campaign maximum is \$1,069,999.94 and the campaign minimum is \$100,000.23.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. 20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common stock;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;
10. the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
11. industry trends and competitive environment;
12. trends in consumer spending, including consumer confidence;
13. overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
14. the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

On Vocana, Music Professionals can interactively upload audio, create a digital storefront, customized profiles, receive real-time analytics, accounting and more. We allow Artists to go directly to their fans and cut out costly middlemen that take away from their earnings.

In 5 years, we intend to be THE platform where Music Professionals including Bands, Musicians, Singers, Songwriters, Producers, Session Musicians, and others choose to release all of their Music, Video, Merchandising content and more to engage with their fanbase and collaborate with others to monetize their talent. These are forward looking projections and are not guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Vocana, Inc., formerly known as U4IA Holdings, Inc, was incorporated in the State of Delaware in January 2021. The Company changed its name from U4IA Holdings, Inc to Vocana, Inc subsequent to January 31, 2021.

Since then, we have:

- Vocana is a desperately needed business tool for Music Professionals to easily promote their brand

Historical Results of Operations

Our company was organized in January 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended January 31, 2021, the Company had revenues of \$0
- *Assets.* As of January 31, 2021, the Company had total assets of \$265,649, including \$23,149 in cash.
- *Net Loss.* The Company has had net losses of \$1,851 for 2021.
- *Liabilities.* The Company's liabilities totaled \$167,500 for 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$1,185,000 in equity and \$600,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Runway & Short/Mid Term Expenses

Vocana, Inc. cash in hand is \$18,883, as of August 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$15,000/month, for an average burn rate of \$15,000 per month. Our intent is to be profitable in 24 months.

We are now at the Beta Launch phase of our application and require funds to continue to operate the business as well as cover Marketing expenses, Additional Development costs and Artists incentives. Since the date of our financial review, additional shares were converted from Notes, lowering the amount of Convertible Notes outstanding from \$675K to \$600K. We also sold approximately \$1,185,000 worth of common stock since the date of our financials.

Revenues are projected to be \$10,000 over the next 6 months. Expenses are estimated at \$200,000 over the next 6 months. We expect to need \$1m to \$1.5m in order to reach profitability, and expect to reach that point in 24 months. These are forward looking projections and are not guaranteed.
