Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

GZI Hub, Inc. provides AI backtested data. We were launched at Founder Institute and are an FI Select portfolio company, which includes the top 2% of their 5,000 companies. Products/Services: GZI aims to deliver alternative data to users in search of higher returns and less volatility. Alternative data utilizes a combination of AI-backtesting and untraditional factors to help investors get more accurate, faster, and granular insights/metrics. We combine traditional financial AI (backtesting, variance weighting, pairing, exchange rates, commodities values, etc.), elements of biotech specific data (regulatory science, molecular pharmacology), time-zones across the 16 countries the data pertains to, and advanced fundamental analysis (decision trees trained on key financial ratios, modified into sector breakdowns). Utilizing AI-backtested pairing strategies in combination with time zones and exchange rates (EST 0:00-16:00) keeps a portfolio systematically running roughly 120 hours a week while the exchange rates balance out minor price fluctuations. Market: Currently, there is about \$4.07 trillion being managed by hedge funds worldwide, giving us a sizable top-down total addressable market (TAM). While 52% of the 129 million US households have investments, only 1.1 million people trade stocks internationally. Distribution Channels: We aim to license our data to brokerages and investment firms around the world whose Assets Under Management (AUM) are between \$1M-\$1B, charge \$10k/mo, which is less than a thousandth of their AUM. GZI Hub, Inc. plans to leverage the networks of some of the world's leading tech accelerators and utilizes a combination of referrals to hedge funds and family offices with social media marketing and targeted ads. The Offering

GZI HUB, INC. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$250,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Professional services for editing company and investor materials.; Cloud Services (Software): AWS, Digital Ocean, Go Daddy. Primarily goes towards web hosting for the app and website.; Legal and Accounting Expenses: Audits, amendments to company documents, tax filings, SEC filings, and sporadic fees associated with managing a company.; Office Space: Rental office space to work out of.; Salaries and Manager Compensation: Includes expenses for a contract workforce and services that act as an extension of your managerial team.; Marketing: Graphic designers for videos, marketing agencies like DNA that assist with crowdfunding.; Insurance: We plan to spend funds on business insurance.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and GZI HUB, INC. must agree that a transfer agent, which keeps records of our outstanding Class B Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

"Common Stock": GZI uses a "Class F" stock structure created by the Founder Institute and the law firm Wilson Sonsini. This new class of common stock protects founders. The stock offers Founders a suite of protective provisions, 2:1 Board votes per Founder versus normal Board Members, and 10:1 share votes as compared to normal common. Participating Class F shares vest monthly without a cliff to act as compensation for founding teams, and "single trigger acceleration" allows one Founder to leave without hurting co-Founders.

"Class B Common Stock": One vote per share. Class B Common Stock does not include the same terms for Board votes, acceleration, and vesting as Class F since these shares were issued at the request of Netcapital specifically for the purpose of a Reg CF offering. If any warrants or options are exercised your ownership in the Company will be diluted.

The Company has granted a perpetual waiver of the transfer restrictions listed in the Bylaws of GZI, INC. for all Securities sold in this Offering.

GZI, LLC a Maryland entity that was initially started in September of 2019 by Sean Adler, the CEO of GZI HUB, INC., is the predecessor company to GZI HUB, INC. GZI, LLC operated in Maryland for about a year and incurred a net loss of \$2,946. All of the funds were provided by the founder and used to finance the initial startup costs. On December 18, 2020, as one of the requirements to attend the Founders Fund program, GZI, LLC was dissolved and GZI HUB, INC. was created in Delaware. GZI HUB, INC. is still pre-revenue. Our average monthly burn rate is approximately \$300, with an average allocation of 90% towards start-up costs and 10% to taxes and licenses. We currently have metrics around the user base. With this raise, we plan to allocate a higher percentage to compensation for managers, staff, and contractors, legal expenses, software subscriptions, insurance, and marketing expenses. We will continue to keep a tight rein on expenses in order to keep a secure runway for the duration of the time it will take to raise this round. Our expenses for the year ended on December 31, 2020, amounted to \$3,138, which resulted in a \$3,138 net loss. Subsequent to December 31, 2020, the company received a PPP loan in the amount of \$18,750. The Company also issued 166,196 warrant securities to Kiwitech and 477,815 warrant securities to Founder Institute.
