#### Purpose of This Form

A company that wants to raise money using Regulation Crowdfunding must give certain information to prospective investors, so investors will have a basis for making an informed decision. The Securities and Exchange Commission, or SEC, has issued regulations at 17 CFR §227.201 listing the information companies must provide. This form – Form C – is the form used to provide that information.

West Milford Grocery Company is engaged in the operations of retail grocery stores in the New Jersey market. A second entity, Shopwell Supermarkets Inc. was established in 2020 to operate a supermarket in Mt. Olive, New Jersey. The company is exploring other opportunities to acquire and consolidate smaller grocery stores in New Jersey. The company's website is *HighlandsMarkets.com*

In addition, Mr. Manzo has extensive experience in food, consumer products and retail grocery operations. Mr. Manzo is president of Manor House Coffee Company a position he has held since March, 2010. Manor House Coffee Company is engaged in the marketing of coffee in consumer sizes for retail stores. Its website is *ManorHouseCoffee.com*

Mr. Manzo brings experience in bring companies public through SEC procedures, and in the operations of a small-cap publicly traded companies. Mr. Manzo was president of Aventura Equities, Inc. (formerly Winsted Holdings, Inc.), a publicly-traded company ("AVNE"), a position he held from June, 2007 until sold in February, 2010. Mr. Manzo acquired Aventura Equities to assist in its reporting obligations under the SEC rules.

From 1985 to 2009, Mr. Manzo was president of Byers Food Company which marketed and imported consumer foods. Byers Food was sold to other individuals.in 2009.

(D) The Company's Business and Business Plan

The History

We are pleased to announce the revival of the Drewrys brand. We are just a small group compared to the several hundred strong company that once was, with an initial focus on distribution to Indiana, Michigan and Illinois. We're bringing it all back... the great beer everyone remembers, the logos and clever marketing, the flavors, the memories, and the good times. For many people in the US – not just South Bend – nothing conjures up good feelings like a delicious regional premium lager.

- Muessel Brewery was founded in 1852 in South Bend IN, as soon as Christoph Muessel came over from Arzberg Germany. Originally located where the former College Football Hall of Fame now stands, the Muessel family built what later became the Drewrys Brewery at the site on Elwood Ave in 1868.
- The South Bend Drewrys story really begins where the Muessel story ends. Having contract-brewed his beers in Evansville for 3 years, E.L. Drewry bought Muessel in 1936 and eventually moved everything there in 1940, the same year he passed away. The company flourished in this new environment, producing dozens of varieties of in-house and contract brands.
- We need to get back to the days where we can drink our beer with some degree of pride.

Our Story

Up until 30 years ago, everyone knew Drewrys beer. Our history goes back to the 19th century, and we're proud of our distinguished brewing heritage. We're back, and we're making the Drewrys label even better-known and well-regarded than it was before.

- After a successful relaunch through contract brewing, we're bringing Drewrys back to South Bend.
- We aren't like most "vintage" beers currently on the market which are "contract brewed" by big macro breweries (you know who they are).
- We're brushing off the legacy recipes and producing with quality, midwest ingredients and the care and attention to detail synonymous with the craft brewing process.

- Investors may cancel an investment commitment until 48 hours prior to the Offering Deadline.
- MainVest will notify investors when and if the Target Offering Amount has been raised.
- If the Company reaches the Target Offering Amount before the Offering Deadline, it may close the offering early if it provides notice about the new Offering Deadline at least five business days before such new Offering Deadline, absent a material change that would require an extension of the offering and reconfirmation of the investment commitment.
- If an investor does not cancel an investment commitment before the 48-hour period before the Offering Deadline, the funds will be released to the Company upon closing of the offering and the investor will receive securities in exchange for his or her investment.

#### (K) Material Changes

In the event the issuer undergoes a material change, the Investor will be notified of such change. The investor will have five (5) business days from the receipt of such notice to reconfirm their investment. IF AN INVESTOR DOES NOT RECONFIRM HIS OR HER INVESTMENT COMMITMENT WITHIN FIVE (5) DAYS OF THE NOTICE OF MATERIAL CHANGE BEING SENT, THE INVESTOR'S INVESTMENT COMMITMENT WILL BE CANCELLED, THE COMMITTED FUNDS WILL BE RETURNED, AND THE INVESTOR WILL NOT BE ISSUED ANY OF THE SECURITIES REFERENCED IN THIS OFFERING.

### Explanation

A “material change” means a change that an average, careful investor would want to know about before making an investment decision. If a material change occurs after you make an investment commitment but before the Offering closes, then the Company will notify you and ask whether you want to invest anyway. If you do not affirmatively choose to invest, then your commitment will be cancelled, your funds will be returned to you, and you will not receive any securities.

### (L) Price of the Securities

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as “Notes.” The Notes are being offered at their face amount. For example, you will pay \$1,000 for a Note with a face amount of \$1,000.

## (M) Terms of the Securities

### Overview

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as the “Notes.” The Terms of the Notes are set forth in the Revenue Share Agreement accompanying this Form C in Appendix A. Copies of the Note and Revenue Sharing Agreement are attached to this Form C.

<sup>2</sup> The rate of revenue sharing is calculated on a linear scale with a minimum rate of 2.0% and a maximum rate of 10.0% and is rounded to the nearest 1/10th percent. The final rate is based on the amount raised and is calculated after the offering has successfully closed. As the amount raised in the offering increases, the rate of revenue sharing increases. For example, a hypothetical offering could result in the following revenue sharing percentages, depending on the amount raised:

### Your Right to Payments under the Note

Your right to payments under the Note is set forth in the Note, together with a separate document

called the Revenue Sharing Agreement. Copies of the Note and Revenue Sharing Agreement are attached to this Form C. Additionally, general terms are outlined below and in the Company's offering page.

#### Obligation to Contribute Capital

Once you pay for your Note, you will have no obligation to contribute more money to the Company, and you will not be personally obligated for any debts of the Company. However, under some circumstances you could be required by law to return some or all of a distribution you receive from the Company.

#### No Right to Transfer

You should plan to hold the Notes until maturity. The Notes will be illiquid (meaning you might not be able to sell them) for at least four reasons:

- The Revenue Sharing Agreement prohibits the sale or other transfer of Notes without the Company's consent.
- If you want to sell your Note the Company will have the first right of refusal to buy it, which could make it harder to find a buyer.
- Even if a sale were permitted, there is no ready market for Notes, as there would be for a publicly-traded stock.
- By law, for a period of one year you won't be allowed to transfer the Investor Shares except (i) to the Company itself, (ii) to an "accredited" investor, (iii) to a family or trust, or (iii) in a public offering of the Company's shares.

#### Security

The Notes are not secured by any assets of the Company or any assets of persons associated with the Company.

#### Modification of Terms of Notes

The terms of the Notes and the Revenue Sharing Agreement may be modified or amended with the consent of Investors holding 50% of the Notes, measured by the total amount outstanding under each Note.

### Dilution of Rights

The Company has the right to create additional classes of securities, both equity securities and debt securities (e.g., other classes of promissory notes). Some of these additional classes of securities could have rights that are superior to those of the Notes. For example, the Company could issue promissory notes that are secured by specific property of the Company.

### How the Exercise of Voting Rights Could Affect You

You will receive payments with respect to your Note only if the Company makes enough money to pay you, or, if the Company does not make enough money to pay you, if there is enough value in the collateral the Company pledged as security for the Notes.

The people with voting rights control the Company and make all the decisions about running its business. If they make good business decisions, it is more likely you will be paid. If they make poor business decisions, it is less likely you will be paid. For example, if they hire too many people and/or try to expand too quickly, the business could be harmed. The people with voting rights could also decide to file for bankruptcy protection, making it more difficult for you to be paid.

### How the Notes are Being Valued

The Notes are being valued at their face value. We don't anticipate that we'll ever need to place a value on the Notes in the future.

### (N) The Funding Portal

The Company is offering its securities through MainVest, Inc., which is a "Funding Portal" licensed by the Securities and Exchange Commission and FINRA. MainVest Inc.'s Central Index Key (CIK) number is 0001746059, their SEC File number is 007-00162, and their Central Registration Depository (CRD) number is 298384.

### (O) Compensation of the Funding Portal

MainVest will be paid 6.0% of the final offering amount, upon the successful completion of the offering. MainVest does not receive compensation if the offering does not succeed. MainVest, Inc. owns no interest in the Company, directly or indirectly, and will not acquire an interest as part of the Offering, nor is there any arrangement for MainVest to acquire an interest.

### (P) Indebtedness of the Company

The Company has no indebtedness outside of the debt the Company is expecting to raise through regulation crowdfunding on MainVest.

### (Q) Other Offerings of Securities within the Last Three Years

The Company has not made any offerings with other third-party regulation crowdfunding companies in the past three years.

**(R) Transactions Between the Company and “Insiders”**

The majority shareholder has advanced fund to the Company to fund operations as need in excess of new revenues.
