Competition. It is possible that competitors could offer superior products to those of the Company, even if the Company is able to develop its products as currently anticipated.

Competitors may also be able to develop comparable products at a lesser price than that offered by the Company. The existence of significant competition in this market could result in a lack of consumer demand for the Company's products, and thereby insufficient revenues for the Company to continue its operations.

Possible Reduction in Consumer Demand for Craft Beers. A limited or general decline in consumption in one or more of Company's product categories could occur in the future due to a variety of factors, including: a general decline in economic conditions; changes in consumer spending habits; increased concern about the health consequences of consuming alcoholic beverage products and about drinking and driving; a trend toward a healthier diet including lighter, lower calorie beverages such as diet soft drinks, juices and water products; the increased activity of anti-alcohol consumer groups; and increased federal, state or foreign excise and other taxes on alcoholic beverage products. Reductions in demand and revenues would reduce profitability and cash flows.

External Events. Adverse macroeconomic conditions, such as a general recession, high inflation or high interest rates, or some combination thereof or other adverse conditions, could lead to less consumer demand for the Company's products, and therefore less ability for the Company to attract customers and generate revenues. Past and potential acts of God, such as natural disasters, or man-made events such as terrorist attacks and the subsequent military actions taken by the U.S. have caused significant uncertainty in the global financial markets in the past and could also have a material adverse effect on general economic conditions, consumer confidence and market liquidity. This may also impair the Company's ability to attract customers and generate revenues.

Product Offerings and Microbrewery Still Under Development. The Company's microbrewery has not been constructed as yet and will require significant capital funding, expertise, time and effort in order to complete. In addition, the Company's product offerings continue to undergo development, which requires further capital, time and expertise. The Company may have to make changes to the specifications and/or design of the planned microbrewery and its product offerings for any number of legitimate reasons or the Company may be unable to develop the microbrewery or product offerings in certain ways as currently anticipated, such deviations which are impossible to predict. Furthermore, the product offerings made by the Company may not meet prospective customer expectations, resulting in sales that do not meet current expectations by a significant degree. The Company will use the proceeds of this Offering to make significant investments to develop and launch the microbrewery and product offerings in an effort to build strong brand recognition and product sales. The Company may not be able, despite its best efforts, to develop recognition and sales sufficient to achieve a market advantage. If the Company is not successful in its efforts to develop product offerings that attract consumer demand, there may not be sufficient revenues for the Company to continue. As a result, investors may lose a significant portion or all of their investment.

Reserves; Limited Resources. The Company may establish working capital reserves to meet the Company's obligations. The Company's ability to establish reserves or provide operating capital for the business is limited by its ability to generate monies, all of which is subject to numerous factors outside the Company's control. To the extent that such reserves prove inadequate to defray Company costs and expenses or unanticipated costs and expenses, it could be necessary for the Company to attempt to borrow additional funds. In the event such financing is not available on acceptable terms, the Company could be required to dissolve in certain cases.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 92.5% towards loan down payment and working capital, 7.5% towards Wefunder fees.

If we raise: **\$124,000**

Use of Proceeds: 80% towards loan down payment for construction of the microbrewery and taproom, 12.5% towards working capital, 7.5% towards Wefunder fees.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use 10% of its gross revenues to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received 2.0x their principal investment (the repayment amount), provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Investors who fund the first \$50,000.00 of the fundraise will receive 2.5x their principal.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

The notes do not provide investors with any voting rights in the company.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a

successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The main difference between preferred and common units is that preferred units gives no voting rights to unitholders while common units do. Preferred unitholders have priority over a company's income, meaning they are paid dividends before common unitholders. Common unitholders are last in line when it comes to company assets, which means they will be paid out after creditors, bondholders, and preferred unitholders.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the gross revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.
