Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

XSurgical is developing a universal surgical robotic platform, capable of addressing multiple procedures, organs and tissues, reducing cost per patient/procedure, making it ideal for regional hospitals (90% of the current market). We are also developing one of the first solutions deployable in open field critical missions, targeting both military operations and civilian emergencies. Current surgical robots are very expensive and perform only a few procedures, making them productive only with the largest 5,000 hospitals of the world. There are more than 45,000 regional hospitals which today are not served and require a much more flexible platform. XSurgical is developing a surgical robot with a modular approach, capable of taking military specs to the civilian world. We enable operations in the open field, based on an open platform. These features enable costs reductions up to 50% and offers more procedures, making it ideal for regional hospitals, military operations and civilian emergencies. We are aiming at being competitive with other companies that develop, manufacture and market robotic products designed to provide minimally invasive surgery and improve surgical results. These similar solutions target the top 5,000 hospitals of the world and

unique regional hospitals (> 45,000) and open field applications (> 1,000 unit potential) for an overall estimated addressable market of \$15 billion in the civilian hospitals and \$1 billion in the open field applications. 1. Time to market: The timing required to achieve a scale-up and a massive adoption is uncertain and speculative.
2. The risk from Pandemics: We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain-related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. 15. You may only receive limited ongoing disclosure. While the Company must disclose certain information, since the Company is at an early stage, it is only able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The Company may also only be obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events — through continuing disclosure that you can use to evaluate the status of your investment.
16. Future fundraising may affect the rights of investors. The Company is raising funds to finance its expansion plans, and may raise additional funds in the future, either through offerings of securities or borrowing from banks or other lending sources. The terms of future capital raises or loan agreements may include covenants that give security holders or creditors greater control over the Company's ability to raise additional funds and use of its assets.
17. *The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.*

18. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 19. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

21. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

24. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

26. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. XSurgical Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9%

of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$540,000 through an offering under Regulation CF. XSurgical has been funded by the Italian controlling company Surgica Robotica srl and will continue to be supported in this way until new equity funds are received. Results of Operations: The Company is currently in its pre-revenue stage. Operating expenses for the year ended December 31, 2022 increased by \$24,028 to \$57,835, as compared to \$33,807 reported for the year ended December 31, 2021. The following is the transcript of the video found on the Company's offering page: One of the biggest limitations of surgical robotics today is that there is really a limited number of products on the market and most of them can perform only a very limited number of procedures. What that means is that if you don't have a volume of patients that undergo that specific procedure you cannot afford another system that is sitting there operating with very few different patients. What we are attempting at XSurgical is designing a completely new concept of a surgical product that is a more robotic platform, universal, so it can perform laparoscopy as well as orthopedics and can be used for a constantly growing number of procedures. We are trying to combine in a single platform the capability of operating on all kinds of tissues - from soft tissues such as in the abdomen to hard tissues such as bones for the neurosurgery or orthopedics. The way we accomplish this is adopting an open architecture, enabling third parties to implement their own version of surgical procedures tools and instrumentation through a development kit. Lastly our system is capable of operating reliably in various settings such as mobile operating rooms, truck trailers, or containers that can be deployed when it's needed.
