Kunduz's initial market has strong revenue with high profitability and low CAC. This keeps Kunduz financially scalable. Our new markets will require applying our growth playbook with certain modifications needed. This is an evolving process

Kunduz recently launched into the United States expert Q&A/homework helping sector of edtech, which is a very competitive space, with one large competitor, Chegg, dominating the space.

Launching and operating in a new market may create potential unforeseen variability (different student user behaviors, preferences, expectations, etc.) compared to our initial market, Turkey.

Kunduz is headquartered in the US, however, a large majority of our team is based in Istanbul, Turkey. Recently, Turkey's economy has been volatile and the Turkish lira has experienced significant value fluctuations.

Kunduz has a small operations team in India. Recently India's business and financial laws have made it increasingly difficult to operate and invest in startup companies in India (especially those operating with foreign investment and international business models).

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 56% towards US college market expansion needs (marketing, product development, scaling ops team), 39% maintaining and scaling Turkey product and operations (mostly hiring engineers, PMs, and ops team members), 5% Wefunder Fee

If we raise: **\$124,000**

Use of Proceeds: 56% towards US college market expansion needs (marketing, product development, scaling ops team), 39% maintaining and scaling Turkey product and operations (mostly hiring engineers, PMs, and ops team members), 5% Wefunder Fee

By hitting our maximum target, we will further invest in our MVP and its sales in B2B version of our product in the US. The B2B channel has been proven effective in Turkey and is expected to provide half of our revenue projection next school year 2023-24. Post-covid, districts in the US have started allocating budget for affordable online tutoring for their students and it's become an emerging market. One of the founders will be responsible for the first sales to a partner in the US. The budget created from the difference from hitting the maximum will be sufficient for this experimentation.

3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to Investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

We had numerous SAFE notes with varying valuation caps convert during our Series Seed round, resulting in multiple classes of Series Seed shares grouped by the conversion (and issuance and liquidation price) price per share.

Investors in this offering will receive preferred stock if the SAFE converts as part of an equity financing event. Preferred stock has a liquidation preference over common stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

As holders of a majority-in-interest of voting rights in the Company, the **shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the **shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The **shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The **shareholders** have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under

our equity compensation plans, an investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the investor's securities will decrease, which could also diminish the investor's voting and/or economic rights. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The initial amount invested in a SAFE is determined by the investor, and we do not guarantee that the SAFE will be converted into any particular number of shares of Preferred Stock. As discussed in Question 13, when we engage in an offering of equity interests involving Preferred Stock, investors may receive a number of shares of Preferred Stock calculated as either (i) the total value of the investor's investment, divided by the price of the Preferred Stock being issued to new investors, or (ii) if the valuation for the company is more than the Valuation Cap, the amount invested divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time.

Because there will likely be no public market for our securities prior to an initial public offering or similar liquidity event, the price of the Preferred Stock that investors will receive, and/or the total value of the Company's capitalization, will be determined by our board of directors. Among the factors we may consider in determining the price of Preferred Stock are prevailing market conditions, our financial information, market valuations of other companies that we believe to be comparable to us, estimates of our business potential, the present state of our development and other factors deemed relevant.

In the future, we will perform valuations of our stock (including both common stock and Preferred Stock) that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

Overview

We are three lifelong friends who started Kunduz because we saw a global need for affordable education services. The most successful students rely upon expensive private tutors to get into college. Kunduz is the pursuit of sharing that high-quality educational experience.

Kunduz provides instant and personalized help to students from middle school to college by its extensive tutor network and use of AI. We operate in Turkey, India, and, now, the US.

Milestones

Kunduz, Inc. was incorporated in the State of Delaware in January 2018.

Since the date of our financials, we have:

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$13,972.23 compared to the year ended December 31, 2021, when the Company had revenues of \$1,298.73.
- *Assets.* As of December 31, 2022, the Company had total assets of \$1,809,906.73, including \$62,598.58 in cash. As of December 31, 2021, the Company had \$2,139,111.34 in total assets, including \$387,733.08 in cash.
- *Net Losses.* The Company has had net losses of \$749,363.20 and net losses of \$1,674,710.46 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.

Liquidity & Capital Resources

To-date, the company has been financed with \$2,565,000 in equity and \$2,938,992 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 36 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Kunduz, Inc. cash in hand is \$76,168.95, as of April 2023. Over the last three months, revenues have averaged \$191,000/month, cost of goods sold has averaged \$46,000/month, and operational expenses have averaged \$203,000/month, for an average burn rate of \$58,000 per month. Our intent is to be profitable in 6 months.

Since the date of our financials, we had a delay in converting 70% of the school base we can cover through our partnership with the franchises they are partnering with. Based on our learnings, we dedicated a team that onboards each of their branches and expect to have a much higher coverage. Based on our past relationships and the brand trust of Kunduz built among school chains, we are also making new deals with large chains.

We expect expenses and revenues to be stable until September 2023. Starting from September with Back to School, we expect a drastic increase in our revenue without an increase in expenses. In B2B, the deals we have been signing start generating revenue then. We've already signed deals that commit 3x YoY growth in B2B deals, which will bring \$1.5-2.5M revenue with a 78% gross margin itself. In B2C, Turkey business will transform into an all-in-one learning app, which will increase our services extensively with the content we have created in the past and the product expansion we are currently building. That expansion will unlock a large market and an opportunity to increase our basket size which is around \$10 / month right now. In the US, we have rebuilt our website to capitalize on the SEO opportunity. With 0 CAC, we are currently growing at health rates. Given the nature of our SEO model, we project that to have its J curve as we solve more questions and have them indexed on Google organically.

We need \$1M to raise until September in order to reach profitability. \$500K of this \$1M has been already committed. We are still raising for the remaining \$500K.

We have limited cash in hand. In addition to fundraising, we are speaking with brands in Turkey for brand partnerships with the power of platforms. We have above 100K monthly active users, half of which are active daily. We plan to capitalize on that. Additionally, our existing investors are willing to support our burn, until we reach profitability in September.
