Like any investment, an investment in Corvidane involves risk. The primary risk of any drug in development is Regulatory approval (e.g. FDA). Two leading causes of failure are safety and efficacy.

Safety plays a major role in regulatory approval. To minimize safety risks, Corvida™ uses molecules that are Generally Regarded As Safe (GRAS) by the FDA. These molecules are well tolerated in humans with minimal side effects as supported by a number of independent, peer-review, published studies.

Corvida™ must demonstrate efficacy to support regulatory approval. While Corvida™ has demonstrated efficacy in rodents, this has not as yet been demonstrated in humans.

Scale-up of commercial product may be insufficient for commercial viability to supply the market.

It is possible that competitors may attempt to challenge Corvidane's intellectual property.

There may be competition from companies promoting generic versions of Corvidane's drug Corvida™.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Corvidane is developing a novel, safe drug to prevent heart attacks, strokes, and liver transplants from NASH.

Milestones

Burke and Boyer, Inc. was incorporated in the State of New York in July 2014.

Since then, we have:

- CEO designed trials for Vascepa[®], which reduces heart attack and stroke risk for high triglycerides.
- Awarded ~\$700k from Dutch government to perform more studies on our drug Corvida[™]'s potential.
- Results of Corvida[™]'s effect on LDLr^{-/-} mouse and genes associated with atherosclerosis due in 2023
- Funds raised will lead to PreIND meetings with the FDA to ensure acceptability of human trials.
- Corvida[™]'s components are designated GRAS (Generally Regarded as Safe) by the FDA.
- Corvida[™] is protected by patents in the US and Japan and are owned by the company.
- This is an opportunity to impact global health and potentially realize significant financial gains.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$0 compared to the year ended December 31, 2021, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2022, the Company had total assets of \$287,265, including \$58,779 in cash. As of December 31, 2021, the Company had \$200,058 in total assets, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$182,267 and net losses of \$94,859 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$549,807 for the fiscal year ended December 31, 2022 and \$289,392 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$19,075 in debt, \$366,884 in SAFEs, and \$25,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 10 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Burke and Boyer, Inc. cash in hand is \$2,000, as of June 2023. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$15,000/month, for an average burn rate of \$15,000 per month. Our intent is to be profitable in 36 months.

Prior to our previous RegCF raise, we received two loans totaling \$19,075 from our former accelerator partner BusStim Consultants. One loan for \$10,075 was repaid immediately following the close of the RegCF. In 2023 we received Convertible Note for \$25,000 from an investor.

It may take 48 months and additional rounds of funding before Corvidane becomes profitable through the sale/license of our drug Corvida[™].

We expect that monthly expenses to increase upwards of \$50k - \$75k/month.

We need to raise \$20M total to take us through Phase 1 Human studies (30 months), and a total of up to \$65M to take us through two (2) Phase 2 Human studies.

We intend to use WeFunder investments exclusively to cover short-term burn and expenses. We are actively seeking other channels of investment (institutional).

All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
