Investment in a commercial real estate investment platform is speculative and inherently risky.

Lack of operating history and the difficulties encountered by early-stage companies in new and rapidly evolving markets.

Risks relating to technology and digital assets. The ABC Platform, including the platform blockchain implementation, relies on software and programming that is complex, and if it contains undetected errors, the company could be adversely affected.

Development in the application of securities laws to security tokens is still evolving. The government is currently looking at ways to regulate cryptocurrencies, and although we are a regulated security token, it could be possible to impact in some way.

The ABC Companies may be subject to the regulatory oversight and anti-money-laundering regulations of the Financial Crimes Enforcement Network ("FinCEN"), a bureau of the U.S. Treasury Department, pursuant to the Bank Secrecy Act. Although highly effective, KYC/AML solutions are not guaranteed to be 100% accurate.

The forecasted financial information contained in the business plan is illustrative and represents subjective analysis on its possible future economic performance. There are numerous elements of uncertainty surrounding our economy including inflation which may impact us.

ABC FinTech operates in a regulated environment and is subject to supervision by several United States governmental regulatory agencies at the local, state and federal level. The company is vulnerable to future legislation and government policy, which could adversely affect commercial real estate development and/or investments, including the operations of ABC FinTech.

Cryptocurrency regulations being discussed could in some way result in more regulatory/compliance initiatives that would need to be addressed. The additional expense for the appropriate legal counsel could affect our bottom line negatively.

The ABC FinTech business plan is dependent upon the abilities and continued participation of the executive management team, specifically, Andelman and McCright. It would be difficult to replace the executive team at this early stage, and the loss by or unavailability of their services would likely have an adverse effect on the business, operations, and prospects of the company.

Risks associated with changes in fundamental economic factors, such as changes in market forces and factors directly related to this operation in the local, national or international economy may impact ABC FinTech's profitability. Negative economic conditions could have a material adverse effect on the ABC FinTech's business and earnings.

ABC FinTech intends to selectively acquire interests in the commercial real estate properties that are managed by other managers/sponsors and that are managed by the company. Acquisition, development and/or management of commercial real estate, either through the purchase of partnership interests through other sponsors or through ABC FinTech's direct efforts, entails risks that the investments will fail to perform in accordance with expectations.

Due to the fact that commercial real estate investments are relatively illiquid, ABC FinTech's ability to vary its portfolio promptly in response to economic or other conditions will be limited. In an economic collapse the crisis could significantly impact the Company and its ability to liquidate assets at desirable price points.

To the extent the ABC FinTech purchases investment interests in commercial real estate in such an environment, the company is subject to the risk that if the real estate market ceases to attract capital investment and/or the value of assets decreases, then the company returns will be lower and the value of our assets may not appreciate or may decrease significantly below the amount paid for or expended in the acquisition of such assets.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The campaign maximum is \$1,069,940.00 and the campaign minimum is \$100,000.00.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make



changes that affect the tax treatment or the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns. **The unitholders** have the right to redeem their securities at any time. Unitholders could decide to force the Company to **redeem** their **securities** at a time that is not favorable to the Investor and is damaging to the Company. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional units, an Investor's interest will typically also be diluted.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The ABC Token will be considered the gold standard in real estate crypto tokens, with over one million token-holders, ten million tokens in circulation, and a real estate portfolio of \$5,000,000,000. Forward-looking projections cannot be guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

ABC FinTech LLC cash in hand is \$8010.00, as of January 2022. Over the last three months, revenues have averaged \$100/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$9,300/month, for an average burn rate of \$9,200 per month. Our intent is to be profitable in 18 months.

Since the 12/31/2020 financials our asset holding company has acquired its first commercial real estate property and sold their first security tokens. Having assets under management is the revenue source for ABC FinTech. Being able to scale is a key to becoming profitable. Having capital to market our platform is a key to being able to scale. We have been able to deal source multiple properties now and have been able to successfully raise the money for several acquisitions with virtually no marketing budget. We are now stepping up our marketing efforts and reach. We are seeing week over week increases in website traffic, signups, and social media engagement. All of these are important to our growth strategy.

As we close on more properties it puts more assets under management which increases our revenue stream. We expect to do \$30,000/month in revenue & \$60,000/month in expenses in the next 3-6 months.

As mentioned previously it should take us about 18 months to get profitable. There is a balancing act between managing expenses, revenue being generated and capital being raised to bridge that shortfall. From a maximum growth perspective we would raise about \$3M in total to create that bridge. However, we can scale our marketing efforts back significantly if it were needed and we would just take longer to gain mass. Our desire to gain mass is driven by the opportunity to establish ourselves as the market leader quickly in a very undeveloped, highly fragmented space. As the market leader we will create barriers for entry for our competitors making it difficult for them gain market share,

We are currently in discussions with a number of venture capital firms and angel investors that have significant interest in what we are doing. It is important to us strategically to establish a base of unaccredited investors as a part of brand building. We intend to close a number of these potential investors after our CF round with Wefunder. We have boot strapped our efforts to date and can do so for an extended period of time if we need to. Bringing in outside investor capital allows us to accelerate our growth. We have spent the past eighteen months laying the foundation for where we are now. We needed to develop our tech stack, put our legal and regulatory framework in place, assemble the base of our team by making several key hires and assemble a rock star advisory board, build out our social media channels, source our first deals, sell our first tokens, get a



pipeline of deals in place, and begin to create brand awareness and buzz around what we are doing. This positions us to rapidly scale.
