This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. Scream Experiences, Inc. is offering up to 609,719 shares of Series Seed-3 Preferred Stock, at a price per share of \$1.6401.

The campaign maximum is \$1,000,000.13 and the campaign minimum is \$250,000.44.

### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The

Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

This Agreement constitutes the entire agreement between the parties hereto with respect to the subject matter hereof and may be amended only by a writing executed by all parties. Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents. To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management



of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common stock;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;
10. the likelihood of achieving a liquidity event, such as an

- initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. Scream Experiences, Inc. was incorporated in the State of Delaware in November 2021. The company was originally formed as Scream Truck, LLC in 2020. Scream Experiences, Inc is the 100% owner of Implse, LLC.

Since then, we have:

- Over 70,000 households have signed up for Scream Truck's



reserved routes. Our CAC has been \$0.

- The company was launched in September, 2020. Lifetime revenue is just under \$6MM (217% CAGR)
- Projecting over \$5MM revenue in 2024, 21% truck profit, and 88% YoY growth (not guaranteed)
- NYC morning radio icon Elvis Duran invested in Scream Truck and will help accelerate our growth
- Scream Truck is powered by Implse, our proprietary software platform, key to our business model
- Scream Truck has over 500 five-star reviews across Google and Facebook, with an overall 4.9 rating.
- Scream Truck is laying the groundwork for other brands to utilize our impulse driven delivery model
- Scream Truck is creating experiential marketing oppty's for complimentary brands starting in 2024

### **Historical Results of Operations**

Our company was organized in November 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$3,007,857 compared to the year ended December 31, 2022, when the Company had revenues of \$1,881,817. Our gross margin was -0.39% in fiscal year 2023, compared to 17.05% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$4,718,743, including \$313,956 in cash. As of December 31, 2022, the Company had \$4,978,706 in total assets, including \$1,972,992 in cash.
- *Net Loss.* The Company has had net losses of \$2,624,052 and net losses of \$1,725,456 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$3,338,479 for the fiscal year ended December 31, 2023 and \$1,799,385 for the fiscal year ended December 31, 2022.

### **Liquidity & Capital Resources**

To-date, the company has been financed with \$4,059,863 in debt, \$5,109,977 in equity and \$959,717 in contributed capital.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do

not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

Scream Experiences, Inc. cash in hand is \$675,639, as of March 2024. Over the last three months, revenues have averaged \$252,328/month, cost of goods sold has averaged \$73,006/month, and operational expenses have averaged \$300,153/month, for an average burn rate of \$120,831 per month. Our business is somewhat seasonal, and we see additional pickup in the warmer months. Our intent is to be profitable in 12 months.

Since the end of 2023, we've issued additional equity and Member Loans.

We expect revenues in the next 6 months to be \$3MM and operational expenses to be \$3.4MM based on our 2024 projections.

We are profitable within the 4 walls of our trucks. We expect to be profitable at the net company level including all operational expenses by Q2 2025. We don't believe we need to raise additional capital to get to that point.

We have multiple interested existing and prospective investors that could provide additional capital to the company, if needed. We are also negotiating a line of credit with a regional bank to provide additional working capital flexibility.

All projections in the above narrative are forward-looking and not guaranteed.

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

The issuer must continue to comply with the ongoing reporting requirements until:

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
