## **Business and Anticipated Business Plan**

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Take control of the way your organization acquires solutions and talent. Neublai's mission is to bridge the digital siloes happening in the current technology industry on which talent platforms, solution marketplaces, investor networks, and customer challenges remain to be disconnected and without a single ecosystem where they can all meet and do business seamlessly. Transacting online is a risky business, to that effect traditional marketplaces have previously used different techniques and methods to reduce risks, including reputation systems, payment gateways, identity verification systems, among others. Nebulai proposes a new and better way of transacting technology solutions and talent. This new way is via a decentralized marketplace that allows organizations to search, find, and procure solutions

and talent needed to digitize their business without having to incur the risk of dealing with unknown parties or unverified providers and/or talent. The marketplace we propose aims to de-risk transactions by utilizing blockchain technology, smart contracts, decentralized identities, and a decentralized reputation system that allows for one to many or many to many contract arrangements. Nowadays, the business to business (B2B) buying journey isn't easy, companies looking to digitize their business are having a hard time finding the right technology provider for their business challenge and losing a lot of time trying to pick a provider that can work on their project; making sure that the provider can deliver on the project specifications on time and budget; having to deal with multiple contracts and high legal fees and complexity; paying high transaction fees when transferring funds to their vendors, and more often than not, creating Intellectual Property (IP) that does not get monetized. On the technology provider side, not getting paid on time; customers changing the scope of the contract; inability to find customers for their solutions; inability to get funding to develop new intellectual property; not having an ecosystem that can enable collaboration with other providers, and not having a platform that allows them to monetize their IP. We have a unique, multi-faceted vision for our Decentralized Solutions & Talent Marketplace (DSTM). We plan to use emerging technologies to develop the DSTM platform, a blockchain-based marketplace, which connects technology solution providers, talent, companies, and investors into a single ecosystem where they can do business collectively. The users of our platform are planned to be able to transact, contract, invest and monetize technology solutions and talent with lower transaction fees with increased security, transparency, and efficiency. The goal of the DSTM is to create a mechanism to automate technology contracting and funding by reducing friction, lowering legal costs, reducing counter-party risk, increasing time-to-value, allowing for faster solution development, more efficient talent contracting, and easier intellectual property monetization through smart contracts. The DSTM is planned to be a marketplace that is a collective intelligence ecosystem of technology-agnostic solutions, talent, composite architectures, and an intellectual property monetization platform that allows people and companies to do business in a single ecosystem. Furthermore, we are working towards a DSTM that seeks to enable new talent from universities, businesses, or disenfranchised individuals to participate in the digital economy by joining the platform and collaborating in the development of solutions and intellectual property. This could allow new talent to get experience in new technologies and have a path to the technology ecosystem while respecting their integrity and contribution. Our DSTM is planned to allow users of the platform to engage with talent through an Application Programming Interface (API) which abstracts talent skills into digital objects that can be transacted by companies, systems, and other platforms. We envision Nebulai's DSTM playing a key role in the emerging concept of the Metaverse by connecting technology solutions & talent to organizations looking to transact and interact on the Metaverse while allowing for people and businesses to connect through the DSTM as the main platform not only in the physical world but also in the Metaverse.

  - 1. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption.   - 2. Any valuation at this stage is difficult to assess. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.
