### Risks Related to the Company's Business and Industry

*The use of individually identifiable data by our business, our business associates and third parties is regulated at the state, federal and international levels.*

Costs associated with information security – such as investment in technology, the costs of compliance with consumer protection laws and costs resulting from consumer fraud – could cause our business and results of operations to suffer materially. Additionally, the success of our online operations depends upon the secure transmission of confidential information over public networks, including the use of cashless payments. The intentional or negligent actions of employees, business associates or third parties may undermine our security measures. As a result, unauthorized parties may obtain access to our data systems and misappropriate confidential data. There can be no assurance that advances in computer capabilities, new discoveries in the field of cryptography or other developments will prevent the compromise of our customer transaction processing capabilities and personal data. If any such compromise of our security or the security of information residing with our business associates or third parties were to occur, it could have a material adverse effect on our reputation, operating results and financial condition. Any compromise of our data security may materially increase the costs we incur to protect against such breaches and could subject us to additional legal risk.

We have never raised outside capital, we started in the dorm room of Grambling State University and have been boot-strapped since then. We have received non dilutive capital from: Grambling State University: \$2,500 Morgan Stanley: \$2,500 Nex Cubed (Silicon Valley Accelerator): \$10,000 Impact Ventures (Dallas Texas Accelerator): \$2,500 Our out there goal is to actually make our first million in sales this year as we have reached over \$100k since 2018, what gives us hope in that is we are expanding our offerings as a company, currently, we only charge admission offices whereas now we will be charging schools by the department. Admissions, Band, Athletics, and so on. Our projections have us hitting near \$400K in sales this year. A goal of ours last year was to actually create a revenue stream that brings in at least 2K per month in MRR, we did that with our Scholly partnership, which we still have today. That is a big emphasis of ours, to create a more repeatable revenue model. So yes we have our big-ticket data sales but we are also seeing revenue from affiliate marketing from our corporate clients. Affiliate marketing is a revenue stream we will be putting resources behind for its growth as it is a 2022 goal of ours to be making a minimum of \$7K per month from the said stream of revenue. One of our biggest pain points is cash flow in between contract drawdowns because we get paid a "large" (between \$6K - \$15K) sum at one time and have to budget that until our next drawdown, the expansion to monetize the advertisement side of the platform has helped with that pain point because we are paid monthly and based off of the traffic we pull in (\$2 per a lead).

The Company intends to achieve profitability in the next 12 months through the expansion in our business model which charges schools based on department also we are furthering a new stream of revenue in the space of affiliate marketing and overall driving traffic to programs posted by our corporate partners.

### **Liquidity and Capital Resources**

The proceeds will allow us to put our sales team on the road and pay for spots at conferences in order to present to large groups of educational stakeholders. We have never presented to more than 20 schools at once and not walked away with at least \$30,000 in contracts. Further, we will be carrying out our full road map throughout 2022 which includes some R&D around using the



platform as an E-learning tool for job readiness Lastly, we will be pouring heavily into PR, HBCUs are just too hot right now for this not to catch fire, lot's of resources will go into influencer marketing and TV News slots for overall better App/Brand awareness.

The Company does not have any additional sources of capital other than the proceeds from the Offering.

A big reason for that not always being the case is because we are/were bootstrapped so sometimes a bill or an expense would be paid directly from our Founders account and not from the business account, and that wouldn't be reflected within our book line items. We have changed this practice as we learn more and formalize the business more as a whole. So it still may be times when our Founder pays an expense but it is first transferred to the HBCU HUB bank account as an owner contribution and then paid for. Lastly, we need professional help in managing our taxes. \_\_\_\_\_ We aren't going to lie to you all in any way. That is the ugly side of our company. The good is our apps growth and

the fact our tech is built all in-house by a former IBM team, but the bad is we don't have 5-10 years of detailed bookkeeping with every single line item accounted for. We have our profit and loss, we have our cost of goods sold, we have the projected budget and actual budget for each client build, and so on. That is the "bad" of HBCU HUB, we have grown out of a dorm room to be ranked #92 out of 75,000 educational apps, but we could have been more detailed in our accounting along the way. That being said, we are now as diligent as possible in accounting for every line item and the use of a CPA is part of what these proceeds will be used for as well. We are using new internal systems such as Quick Books instead of WaveApps to help in automating some of those accounting tasks. Thank you all so much for this opportunity, we are not taking it lightly in any way and will be completely transparent through this whole process.
