This is a new area to be explored from an application of AI perspective. While many companies focus on vocal/NLP, our focus on in-call feedback via computer vision and body language is both a benefit (as it is relatively unique to our approach) and a challenge - given this is a new application.

We are an early startup and this is our pre-seed - all early startup investments are inherently risky. Specifically, our capital strategy is to start scrappy, prove out our product and PMF, and then do a larger raise.

We are a team that has only partially worked together in the past. Although our technical co-founder has worked with our lead front end developer and I have done projects with our data science advisor.

New tech and frothy space...there is a lot of uncertainty in how the future of work will pan out - however, therein lies the opportunity:)

Our GTM strategy is in the process of validation. This means we have not yet found a perfect Product Market Fit.

Apart from some early pilot revenue, we are only just now breaking into our recurring revenue strategy. In this sense, we are essentially pre-revenue, which presents an additional risk.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. Use of Proceeds: 75% Product Talent and Development - towards additional hours with our existing and trusted contractor, 15% Marketing (new website overhaul and launch), 5% Operations (subscription services + CFA fees), 5% - WeFunder fees

If we raise: **\$100,000**

Use of Proceeds: 55% Product Talent and Development - hire 2 additional FTE to focus on back end development + increase hours of our trusted contractors, 22% Founder compensation, 8% Marketing (new website overhaul and launch), 10% Operations (subscription services and CFA fees), 5% - WeFunder fees

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it

receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **capital stock** in the Company ("**Capital Stock**"), when and if the Company sponsors an equity offering that involves **Capital Stock**, on the standard terms offered to other investors.

Valuation Cap: \$4,000,000.00

Discount: 20%

Conversion to Equity.

Next Equity Financing Conversion. This SAFE will automatically convert into Conversion Shares upon the closing of the Next Equity Financing. The number of Conversion Shares the Company issues upon such conversion will equal the quotient (rounded down to the nearest whole Shares) obtained by dividing (x) the Investment Amount by (y) the applicable Conversion Price. At least five (5) days prior to the closing of the Next Equity Financing, the Company will notify the Holder in writing of the terms of the Equity Securities that are expected to be issued in such financing. The issuance of Conversion Shares pursuant to the conversion of this SAFE will be on, and subject to, the same terms and conditions applicable to the Equity Securities issued in the Next Equity Financing (except that, in the event the Equity Securities to be issued in the Next Equity Financing are Equity Securities with a liquidation preference, the Company may, at its election, issue Shadow Equity Securities to the Holder in lieu of such Equity Securities).

Acquisition Transaction Conversion. In the event of an Acquisition Transaction prior to the conversion of this SAFE pursuant to Section 2.1, at the closing of such Acquisition Transaction, the Holder may elect that either: (a) the Company will pay the Holder an amount equal to one times the Investment Amount; or (b) this SAFE will convert into that number of Conversion Shares equal to the quotient (rounded down to the nearest whole unit) obtained by dividing (x) the Investment Amount by (y) the applicable Conversion Price.

Mechanics of Conversion.

Financing Agreements. The Holder acknowledges that the conversion of this SAFE into Conversion Shares pursuant to Section 2.1 will require the Holder's execution of certain agreements relating to the purchase and sale of the Conversion Shares, as well as registration rights, rights of first refusal and co-sale, rights of first offer and voting rights, if any, relating to such securities, and the Company's then effective limited liability company agreement (collectively, the "Financing Agreements"). The Holder agrees to execute all of the Financing Agreements in connection with a Next Equity Financing.

Register. As promptly as practicable after the conversion of this SAFE and the issuance of the Conversion Shares, the Company will update its ownership register to reflect the Conversion Shares held by the Holder. The Company will not be required to issue the Conversion Shares until the Holder has surrendered this SAFE to the Company (or provided an instrument of cancellation or affidavit of loss). The conversion of this SAFE pursuant to Section 2.1 and Section 2.2 may be made contingent upon the closing of the Next Equity Financing and Acquisition Transaction, respectively.

Priority. In the event of a Dissolution while this SAFE is outstanding, the Company will pay the Holder an amount equal to the Investment Amount (the "Repayment") immediately prior to, or concurrently with, the consummation of the Dissolution. The Company's obligation to make the Repayment will rank senior in right of payment to the holders of the Company's outstanding Shares and pari passu with any convertible debt of the Company.

Most Favored Nation. While this SAFE is outstanding, if the Company sells or issues any convertible notes or other simple agreements for future equity ("Subsequent Convertible Instruments") on terms that differ from this SAFE, the Company will provide the Holder with written notice of such sale or issuance, including the terms of the Subsequent Convertible Instruments, no later than five (5) days after the closing date thereof. In the event the Holder determines, in its sole discretion, that any Subsequent Convertible Instrument contains terms more favorable to the holder(s) thereof than the terms set forth in the SAFE, the Holder may elect to exchange the SAFE for such Subsequent Convertible Instrument. If the Holder elects to exchange the SAFE for a Subsequent Convertible Instrument, the Company agrees to enter into a side letter with the Holder relating to such Subsequent Convertible Instrument, which side letter will have substantially the same terms as those set forth in this Section 4.

No Rights as a Stockholder. The Holder is not entitled by virtue of holding this SAFE to be deemed a stockholder (a "Stockholder") of the Company or the owner of any Stockholdership interest in the Company for any purpose, nor will anything contained in this SAFE be construed to confer on the Holder, as such, any of the rights of a Stockholder of the Company or any right to vote for the election of Directors or upon any matter submitted to Stockholders at any meeting thereof, or to give or withhold consent to any company action or to receive notice of meetings, or to receive subscription rights or otherwise until Conversion Shares have been issued upon the terms described in this SAFE.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

1. the Investor or
2. the majority-in-interest of all then-outstanding Safes with the same "Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 1. the Purchase Amount may not be amended, waived or modified in this manner,
 2. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 3. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

1. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
2. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Virtual Sapiens, Inc. cash in hand is \$100,333, as of January 2022. Over the last three months, revenues have averaged \$1,805/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$10,393/month, for an average burn rate of \$8,588 per month. Our intent is to be profitable in 12 months.

Since the date our financials cover, revenue has been generated from pilots and one-time assessment products. These are included in our testing and validation strategy. In the past couple of months, we have started to activate our first recurring revenue from our SaaS product which is a significant win.

our first recurring revenue from our SaaS product which is a significant win and will allow us to scale exponentially.

By the end of Q1 2022, we expect to have our first B2B contracts signed for our Sidekick product and revenues averaging \$5,000/month. We expect to see a slight dip as we convert from our more service oriented, ad hoc revenue from 2021 to a recurring model from here on out. Over the next 6 months, we expect to be averaging \$10,000/month

Our expenses during the next 3-6 months are still majority focused on product development and talent (R&D costs), averaging \$12,000 per month. We are keeping our overhead and admin costs at an absolute minimum and are not planning on paying the founders until our Seed round.

We are not yet profitable and apart from some early revenue from pilots and workshops, are pre-revenue.

With our current growth and hiring plan, we will be profitable at \$142,000/month starting January 2023. Our next raise will be in the \$1,500,000 range. This is based on our expectations of closing our first B2B contracts which will be accounted for on an annual basis.

Outside of funds raised in this offering, we have other individual angels who have invested according to the same terms included in this SAFE. These funds, in addition to our own founders' bootstrapping budgets provide us with the runway to complete this Vitalize/WeFunder campaign.
