Any valuation at this stage is difficult to assess.

The valuation for the offering was established by the Company. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment.

The transferability of the Units you are buying is limited.

Any Units purchased through this crowdfunding campaign are subject to SEC limitations of transfer. This means that the Units that you purchase cannot be resold for a period of one year. The exception to this rule is if you are transferring the stock back to the Company, to an "accredited investor," as part of an offering registered with the Commission, to a member of your family, trust created for the benefit of your family, or in connection with your death or divorce.

Your investment could be illiquid for a long time.

You should be prepared to hold this investment for several years or longer. For the 12 months following your investment there will be restrictions on how you can resell the securities you receive. More importantly, there is no established market for these securities and there may never be one. As a result, if you decide to sell these securities in the future, you may not be able to find a buyer. The Company may be acquired by an existing player in the brewery industry. However, that may never happen or it may happen at a price that results in you losing money on this investment.

The Company may never commence a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

We are entering into a scale of production which we have not done before. While we are very confident, we understand there could be challenges with production there are potential pitfalls and increased regulatory burdens to consider that can have negative impacts on the company's growth trajectory.

Regulation and Food Safety Could Adversely Affect the Company.

The Company is getting to a stage where it will be highly regulated in the United States by the federal, state and local governments. Additionally, the Company produces and distributes ingestible products and therefore is highly regulated by the FDA and other federal and state regulatory agencies. The regulations adopted by these authorities govern many parts of the Company's expected operations, including food processing, transportation of food, distributor relations and sales. The Company could be subject regulatory agency review and compliance, which could be very burdensome.

The Company's business is also routinely subject to new or amended laws and regulations with which the Company must comply. While operating the business, the Company may be subject to claims that the Company has not complied with existing laws and regulations, which could result in claims, fines and/or penalties which could adversely impact the Company. There can be no assurance that the Company will not incur material costs or liability in connection with compliance with applicable regulatory requirements, or that such regulation will not interfere with the Company's proposed business and any products the Company produces in the future.

Food Safety

The Company depends on its suppliers to provide safe and pure ingredients. In addition, the Company depends on its employees, distributors and retailers to follow safe production and handling procedures for its products. Problems and shortcomings in these areas could lead to unsafe product and product safety recalls which could damage the Company's reputation and ability to compete in the marketplace.

The food and beverage industry are highly competitive. We face competition from distributors of food, ethnic food, perishables, and natural products as well as specialty grocery and mass-market grocery distributors and retailers.

Consumers have many choices in the club or membership retailer industry, including Costco and Walmart Sam's Club. We also compete with national, regional, and local retailers of ethnic, gourmet and other specialty foods such as Whole Foods, Sprouts, and Trader Joe's. Other competitive forces include conventional retail grocery stores and major food delivery brands.

These competitors have been in business longer, have substantially greater financial and other resources, and may be better established in their markets.

We can provide no assurance that our current or potential competitors will not provide products or services comparable or superior to those provided by us or adapt more quickly than we do to evolving industry or market trends. Increased competition may result in price reductions, reduced gross margins and loss of market share, any of which would materially and adversely affect our business, prospects, financial condition, or results of operations.

We cannot assure investors that we will be able to compete effectively against current and future competitors. As a business with limited resources, attracting and retaining customers in this climate may be difficult or very expensive.

Any defects in the products we manufacture, whether caused by a raw produce, cooked products, manufacturing process may result in returns, claims, delayed shipments to customers or reduced or cancelled customer orders. If these defects occur, we will incur additional costs and if in large quantity or too frequent, we may sustain loss of business, loss of reputation and may incur liability.

An increase in the cost of raw materials or energy could affect the Company's profitability. Commodity and other price changes may result in unexpected increases in the cost of raw materials, produce from Nigeria, glass bottles, food packaging and other packaging materials used by the Company. The Company may also be adversely affected by shortages of raw materials or packaging materials. In addition, energy cost increases could result in higher transportation, freight and other operating costs. The Company may not be able to increase its prices to offset these increased costs without suffering reduced volume, sales and operating profit, and this could have an adverse effect on your investment.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor. If the Proxy (described below) is



in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she

Customers purchase their desired AllIDolsCook meals and products through the company website, and these products can be picked up curbside (Houston) or shipped directly to them (50 States in the USA). You can also find the condiments in grocery stores, and AllIDolsCook will list its products in restaurant supply stores.

In 5 years, AllIDolsCook hopes to be the household name and #1 resource for African food products across the globe.

#### **Milestones**

All I Do Is Cook LLC was incorporated in the State of Texas in January 2019.

Since then, we have:

- 🚚 Bootstrapped to \$1.5M in revenue with \$0 paid ads.
- 🍲 Cooked approximately 26,000 meals since 2019.
- 🏪 Listed products in Phonedicia Specialty Foods in Houston, Texas.
- 🏠 Built out a 2,600 sqft production facility in Houston, Texas.
- Utilizing production system to ensure consistent quality.
- Multiple new products launching soon in various channels including B2B.

#### **Historical Results of Operations**

Our company was organized in January 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$573,199.94 compared to the year ended December 31, 2020, when the Company had revenues of \$407,057.62. Our gross margin was 47.4% in fiscal year 2021, compared to 51.17% in 2020.
- *Assets.* As of December 31, 2021, the Company had total assets of \$78,884.61, including \$14,708.69 in cash. As of December 31, 2020, the Company had \$14,237.64 in total assets, including \$5,850.73 in cash.
- *Net Income.* The Company has had net income of \$896.91 and net income of \$19,581.22 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.
- *Liabilities.* The Company's liabilities totaled \$104,043.48 for the fiscal year ended December 31, 2021 and \$24,500 for the fiscal year ended December 31, 2020.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$260,300 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 8 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

All I Do Is Cook LLC cash in hand is \$2,200, as of April 2022. Over the last three months, revenues have averaged \$55,600/month, cost of goods sold has averaged \$27,000/month, and operational expenses have averaged \$20,000/month, for an average net margin of \$8,600 per month. Our intent is to be profitable in 0 months.

We have seen an uptick in Sales for the months of January and February. A 14% increase in monthly revenue and 20% increase in order numbers compared to this period last year.

In the next 3-6 months, we expect our expenses to go up by \$3,000 due to supply chain ripple effects, inflation and general increase in prices of raw materials.

However, we expect a monthly revenue increase of \$11,200 as this raise will be used to purchase necessary equipment to increase production output which means there would be an increase in capacity to meet more demand.

We are currently profitable. Our gross profit margin is an average of 52% company-wide. However, this figure varies per year due to cost of goods sold increasing over time.

Besides the funds raised from Wefunder, our other sources of capital are the current SBA Loan and our monthly revenue. We are also allocating a portion of our current round to accredited investors off the Wefunder platform, on identical terms via Reg D (506)c. We anticipate raising between \$100k - \$150k via this Reg D.
