The Fashion Industry is ruled by many large conglomerates who possess the majority of the market share

There could potentially be legal action by one of these companies in order to keep us from manufacturing and competing

We are essentially betting that a sizeable amount of the over 500,000+ people who have expressed interest will convert to buyers

Our design is based on durability and creating a product that is built to last, this means that the materials we will be using will be much higher cost than our fast-fashion competitors, our margins will be slimmer as a result

Covid-19 Effects supply chains and manufacturing ability significantly, and should there be another worldwide lockdown event, the timeline would be delayed.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no

rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

The slow fashion revolution giving function, fit, and quality back to the masses

After founder Kristian accidentally bought a pair of women's jeans at a thrift shop, it started a journey of discovery into how poorly made women's clothing has become. After noticing the problem and posting it on TikTok, Kristian began looking for a solution for the everyday problem that is affecting the lives of millions of people.

We create high-quality sustainable clothing that fits every body type, shape, and size, and is designed with function, durability, and style.

We want to have our clothes on the bodies of 1,000,000+ people around the world. Our goal is to make people feel more confident in their own skin and provide clothes that not only provide function but are built to last.

Milestones

Human Clothing Company Inc was incorporated in the State of Delaware in January 2022.

Since then, we have:

- 10+ Million Views on Tik-Tok in the first two weeks, 500+ media mentions, 150k site visits Week 1.
- Founder @kristianfrommntn gained 550k + Followers in less than 7 days with the idea
- 45.000+ People have joined our waitlist in the first 60 days
- Durability is a major issue with women's Jeans, causing massive amounts of environmental waste
- Backed by a founding team with fashion, marketing, and

social media expertise

- The Womens fashion market is a \$800b market that needs disrupting
- The Non-binary/Gender Neutral Fashion market is unbelievably underserved.

Historical Results of Operations

Our company was organized in January 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$528,969.49 compared to the year ended December 31, 2022, when the Company had revenues of \$348,391. Our gross margin was 22.55% in fiscal year 2023, compared to 53.97% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$56,646, including \$48,082.82 in cash. As of December 31, 2022, the Company had \$238,197 in total assets, including \$48,744 in cash.
- *Net Loss.* The Company has had net losses of \$226,886.42 and net losses of \$100,659 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$157,000 for the fiscal year ended December 31, 2023 and \$13,158 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the company has been financed with \$588 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement

our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Human Clothing Company Inc cash in hand is \$41,000, as of June 2024. Over the last three months, revenues have averaged \$92,000/month, cost of goods sold has averaged \$40,000/month, and operational expenses have averaged \$40,000/month, for an average net margin of \$12,000 per month. Our intent is to be profitable in 3 months.

We shifted the core manufacturing model of the business and as a result incurred much larger operational expenses. We moved from outsourcing manufacturing with 3rd Party producers to building and operating our own facility. This facility allows our model to operate a much more efficient level with significantly more autonomy, but as a result, did require some substantial upfront investment to begin operations. Our Cost of Goods Sold will continue to decrease substantially in the coming months as a result of this investment, and our month-to-month burn rate will stabilize, including variable spending.

Revenue is currently averaging approximately \$92,000/month over the last 3 months. We are currently 100% organic and have never spent any significant capital on advertising of any kind. As a result of this raise, we will begin an aggressive multi-channel marketing approach that we believe will bring revenue above \$250,000/month, as a result, we will need to expand internal operations and believe that expenses will scale to approximately \$100,000/month. The spring is a major season for denim and we are currently planning on launching this aggressive marketing strategy in the next two months.

We are not profitable currently, however had we not invested substantial capital into the development of our manufacturing facility we would have been, and was cash flow positive in Q4 2023. This investment was an incredibly important decision for the future of the company and the business model, and will lead to much faster long-term profitability in the future. We strongly believe that we can be profitable in the next six months as we do not have any significant outstanding debts, credits, or liabilities and have solved the core issue that prevented profitability in the past - manufacturing.

Our revenue is inconsistent as we typically operate on a launch model, however when live, we are generating approximately \$3,000/day via sales through our website that is paid out daily, and our net burn/revenue is approximately even. The primary purpose of this raise is to

ensure we can continue to invest in the model and fast track toward profitability and consistency.

All projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor. The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be

compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company.
