Supply chain issues may impact product deliveries. Given the slower, more expensive state of supply in industry due to Covid-19, we've had to redesign some of our systems on-the-fly and have been forced to pre-order significant materials. If this continues, each production build will require re-engineering, which eats into any profit margins on these builds. Further, we may find small variation in behavior between deliverable batches due to small changes in the designs.

While we have been able to find interested customers to date who are particularly interested in our mix of speed and quality, existing and future customers may go to competitors due to their established track record and/or name in industry. Penetrating an established industry, especially aerospace, ground and marine vehicles is difficult due to constraints in the industry. We leverage our experience and track record we have for ourselves, but it's possible this does not sway folks as they get closer to their production vehicles.

Presently, our manufacturing typically consists of batches of on-the-order of 30 units at a time, a few times per year. This has been sufficient to supply existing customer deliveries, but in order to reach the growth and profitability the company anticipates, manufacturing capability will need to scale tremendously, as tens become hundreds become thousands of units. Scaling to this magnitude will be a new challenge for this company, and the team. It will require hiring good individuals, from a limited pool of talent. This will be further complicated by the need to move to production standards such as ISO9001 and eventually FAA certification. We are hopeful that the excitement of our company, and the growth potential attracts such talent, but this is a risk we will need to manage.

A competitor or established player in the industry may introduce direct competitors to our products. This is always a risk entering an industry, as these companies may decide to attempt to compete with us in this niche. To date, customers prefer our products, tools and level of support, but there is risk here. However, the running theory here is that it would be cheaper for them to acquire us than to accomplish what we have at allocortech, which lends to our exit.

Long term success likely relies on us completing RTCA DO-160, DO-178, DO-254, or equivalent qualification activities, which will involve significant cost and effort, in order for our products to be components in aircraft certified by the FAA or other aviation regulatory agency. Successful completion will likely require Customers willing to work through this process with us, or additional external funding. This will present schedule, financial and organizational risks to the company as these processes are attempted to be integrated into the org, while also supporting new customer operations.

Our field of work requires hiring specialized engineering personnel, which are typically highly demanded. There is risk that our growth may be slowed due to the inability to hire new employees, as well as attrition.

As part of doing business, there is always risk of litigation within the company. These may include things like IP disputes, dissatisfied customers, and/or violation of law. We have retained counsel that regularly interacts with the company, and takes part in our board meetings, and some of our business discussions. Additionally, our counsel constructs our contract templates with appropriate terms for liability limitations, dispute resolution, etc. and reviews contracts sent to us from customers. In this respect, we try and limit potential issues with use of our counsel. Further, we carry insurance for various types of disputes that may arise, such that they would have limited financial burdening on the company.

One of the reasons we're successful in industry is because we have delivered successfully to our customers. These customers provide great reference for us to carry forward to new customers, and often even recommend us to new customers. If we fail to deliver, or have customers that are dissatisfied, it is possible they may tarnish our brand and make it more difficult to gain business. This could also be created by bad publicity due to a significant event with one of our customers (e.g. loss of aircraft).

A significant recall could be financially difficult for the company to deal with if we find a major safety issue with any of our products. This is not significant at this point in time, due to the limit in number of units we have fielded, but will become a larger risk as we grow more and more.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Amount to be Offered: The goal of the raise is \$50,000.00

Valuation Cap: \$18,000,000.00

Discount Rate: 80%

Maturity Date: 36 months from the Effective Date.

Interest Rate: 6.0%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

Conversion and Repayment

(a) Conversion Upon Qualified Financing Conversion upon a Qualified Financing. In the event that the Company issues and sells its equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$1000000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per share for Equity Securities by the Investors in the Qualified Financing multiplied by 0.8, and (ii) the quotient resulting from dividing \$18000000 by the number of outstanding shares of common stock of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per share at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share

ation protection, which will equal the Conversion Price, and (iv) the per share dividend, which will be the same percentage of the Conversion Price as applied to determine the per share dividends of the Investors in the Qualified Financing relative to the purchase price paid by the Investors.

(b) Conversion upon a Change of Control. If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

(c) Procedure for Conversion. Procedure for Conversion. In connection with any conversion of this Note into capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

(d) Interest Accrual. If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

Senior Indebtedness

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

To-date, the company has been financed with \$249,798 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

allocortech inc. cash in hand is \$206,643, as of April 2022. Over the last three months, revenues have averaged \$181,104/month, cost of goods sold has averaged \$21,716/month, and operational expenses have averaged \$134,728/month, for an average net margin of \$24,660 per month.

Since the date our financials cover, we have continued operations, and revenue has grown YoY. We have generated over \$685k in Q1 of 2022. Aside from this growth, nothing else has materially changed.

We expect to continue at our current revenue rate on our existing contracts over the next 3-6 months, averaging around \$180k/mo in revenue. In the next 3-6 months we anticipate remaining close to having a neutral operating revenue (an equal amount of expenses as revenues), or at a slight loss as we are investing in marketing, manufacturing and hiring for manufacturing personnel.

We have remained mainly revenue neutral over the life of the company by operating lean, and organically investing in R&D. To facilitate growth, we anticipate accruing slight losses over the next 1-2 quarters due to investment in marketing, manufacturing and team growth over the next two years to steepen our revenue growth curve. Our plan is that we'll spend around \$400k in the next 6-months to bring on new staff, add marketing, supplement our production, etc. Given our current plans, we'll likely start to be profitable again q2 2023, once our production ramp-up happens next spring.

Outside of funds raised in this Community Round, the company has working capital in cash assets and accounts receivable to cover the company operation through the campaign.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
