Components for building of our generators are susceptible to supplier delays. Although not currently seen as an issue supply chain inconsistencies can delay product launch.

Expansion of business may be effected by availability of suitable staffing with adequate experience.

The retail sales with major outlets are notoriously bad at paying within a timely manner, adequate operating funds are required to ensure overtrading is not experienced for "sellers" who exceed payment terms.

Bespoke components are currently received from USA & Canadian manufacturers, this is set to continue without additional tariffs, if demand out stripes local supply EFG will have to look at China or Europe to supplier specific items with will attract JIT issues in manufacturing and additional taxation related to imports.

Recent events in Russia and localities are impacting supplier chains of PCB components. The EFG manufacturer will attempt to secure current and future items to meet demand although delays may be experienced.

Multiple sales of the fuel cartridge is a difficult item to predict as this is a new consumer product without comparative activity. Market research has been carried out by an industry leading analyst to provide an indication of consumer buying habits but until actual sales are made forecasts are calculated on estimates from 3rd party knowledge only.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Andrew Singer and Paul Miller are part-time officers. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Continuous, zero emission electricity in a portable, easy-to-use generator.

We all depend on electricity to stay in touch, interact and work, and live. Unfortunately, industrial power grids are increasingly unreliable or inaccessible. Currently available generators require unacceptable tradeoffs for people and planet, or are simply impractical. We have the technology, ambition, and determination to overcome these problems.

We make the world's only emission-free, portable generators that provide continuous electricity during power outages and for off-grid living.

We are focused on becoming the leader in portable generators powered by hydrogen-on-demand, providing access to clean electricity where and when people want it, for as long as they need it.

Milestones

Emission Free Generators, Inc. was incorporated in the State of Delaware in March 2022.

Since then, we have progressed our technology:

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company can only project how much revenue it will receive in the future, estimated upon market projections from Ipsos, world renowned new product to market research company and industry knowledge in the \$7bn market.

Historical Results of Operations

Our company was organized in March 2022 and is still in a pre-revenue, start-up development mode and has limited operations upon which prospective investors

may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$0 compared to the year ended December 31, 2022, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2023, the Company had total assets of \$64,757, including \$29,072 in cash. As of December 31, 2022, the Company had \$20,045 in total assets, including \$20,045 in cash.
- *Net Income.* The Company has had net income of \$0 and net income of \$0 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$42,763 for the fiscal year ended December 31 2023, which related entirely to a loan from a director and \$3,767 for the fiscal year ended December 31, 2022.

Liquidity & Capital Resources

To-date, the company has been financed with \$123,000 direct investment, \$150,000 in convertibles and assistance as necessary from directors.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Emission Free Generators, Inc. cash in hand is \$19,600, as of March 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$8,200/month, for an average burn rate of \$8,200 per month. Our intent is to be profitable in 24 months.

EFG has won four business and innovation awards in 2024, these will assist EFG in securing our \$1.2million funding round in 2/3Q 2024.

In the next 3-6 months, we expect revenues to be \$0. The cost to run the company, before additional funding is secured, will continue to be \$8,300 per month which includes basic working capital, R&D carried out by the BOD and 3rd party expenditure. The Company is currently in negotiation to secure additional funding of \$1.2million which is expected to complete prior to 3Q 2024. Assuming we secure funding, Company operation costs for expansion will increase to \$64,500 month from month 7 through to month 12 of 2024. MVP's will be produced prior to EOY at a total development cost of \$600,000. Additional funding will be required to take EFG to revenue of \$3.3million which we intend to secure in 2Q 2025. With raised funds the Company has sufficient funds to operate for 12 months before additional capital is required. The main purpose of our seed raise is to build consumer compliant minimal viable products for trials and tests before full scale production. Upon achieving our raise target EFG will have sufficient funds to develop the product and company before the next funding round in 2Q 2025. Only after the 2025 funding round will EFG be at revenue. We have a revenue conservative 5 year business plan. Profitability is expected to be reached in second year of trading after the first to market product is launched, which is in approximately 15 months. Forward-looking projections cannot be guaranteed. The Founders have assisted financing the development to date and will continue to do so until appropriate funding is secured. All projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors.
