#### **1. ORGANIZATION AND PURPOSE**

Flux Hybrids I, a series of Wefunder SPV, LLC (the “Company”, “we”, “us”, or “our”) is a limited liability company organized on June 14, 2022 under the laws of Delaware.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the Company’s significant accounting policies applied in the preparation of the accompanying financial statements follows:

##### **a) Basis of Accounting**

###### **Nature of Operations**

Flux Hybrids I, a series of Wefunder SPV, LLC (the "Company") was formed as a special purpose entity to hold securities in Flux Hybrids, Inc in accordance with § 270.3a-9 for investors in the Regulation Crowdfunding offering(s) of Flux Hybrids, Inc. The Company's activities are limited to those necessary to accomplish its objectives, and it has no other significant assets or liabilities. The Company prepares its financial statements on an accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP). Under the accrual basis of accounting, revenues are recorded when earned and expenses are recorded at the time liabilities are incurred.

##### **b) Use of Estimates and Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### **c) Cash and Cash Equivalents**

Cash and cash equivalents include all cash balances, and highly liquid investments with maturities of three months or less when purchased.

##### **d) Legal Fees**

Legal fees consist of legal services provided for the creation of the Company and equity financing.
