#### **Overview**

A one-stop-shop to recruit and employ talent while keeping them happy. We created an ecosystem of talent, and tools to bridge the gap between organizations and job seekers, aiming to inspire and equip the next generation of founders to build great, meaningful companies. **Milestones**

Athyna, Inc. was incorporated in the State of Delaware in November 2019.

Since then, we have:

- Grown from \$50k of ARR to \$6M in four years

- Building the future of recruitment on OpenAI's LLM
- 73% growth in remote job listings
- \$627B TAM market opportunity
- 150k+ global talent pool, growing 22%+ MoM
- Built global team from ex-Amazon, Meta, WeWork, Uber, DiDi and more

### **Historical Results of Operations**

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$5,501,479 compared to the year ended December 31, 2022, when the Company had revenues of \$3,111,218. Our gross margin was 37.71% in fiscal year 2023, compared to 37.61% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$558,985, including \$308,238 in cash. As of December 31, 2022, the Company had \$158,718 in total assets, including \$115,755 in cash.
- *Net Loss.* The Company has had net losses of \$187,365 and net losses of \$497,748 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,693,827 for the fiscal year ended December 31, 2023 and \$1,106,195 for the fiscal year ended December 31, 2022.

### **Liquidity & Capital Resources**

To-date, the company has been financed with \$3,162,726 in debt, \$2,500,000 in RSUs, and \$309,925 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 2 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be

our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

Athyna, Inc. cash in hand is \$241,879, as of May 2024. Over the last three months, revenues have averaged \$508,995.75/month, cost of goods sold has averaged \$318,719/month, and operational expenses have averaged \$240,261/month, for an average burn rate of \$49,984.25 per month. Our intent is to be profitable in 3 months. There have been no significant changes on operations or finances since the date of our last financials. We expect an increase in revenue of 20% over the next 3-6 months. The Cost of Goods sold will increase in similar way, while operating expenses is expected to maintain steadily. We are not profitable at this moment, since we are investing in resources to develop our platform. Nevertheless, we could be profitable in 3-6 months time provided our current growth trajectory is maintained. Our existing cash reserves are anticipated to be sufficient for operations during this period. However, in the event of any unforeseen circumstances arising, an additional capital buffer of \$200,000 would be enough to ensure financial stability. Aside from Wefunder, our other main source of capital are the loans detailed on the financial section. All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed

by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company.
