**Pandemic Closure** - As we all know, restaurants took one of the biggest negative impacts from the COVID-19 pandemic. Restaurants require the presence of customers indoors to function at their best.

**Employee Shortage** - There is currently a staffing shortage in the hospitality industry. To counter this, I have budgeted higher than average pay for staff.

**Low Margins** - Restaurants operate on slimmer margins than most other industries

and margins. Reduced gross margins may result from increased competition and supply chain issues along with inflation will not help.

Poor Health Inspection - While it will always be our top priority to keep guests safe by properly handling food and maintaining a clean environment, there is a possibility of receiving a poor health inspection that will negatively impact business.

The Company will be subject to state “dram shop” laws, which generally allow a person to sue the Company if that person was injured by an intoxicated person who was wrongfully served alcoholic beverages at the Company’s establishment.

#### Dependence on Manager

~ The Manager has broad power to control the operations of the Company, subject only to the specific actions that require consent of the holders a majority of the Class A Units as specified in Section 7.2 of the Operating Agreement

~ The Manager has limited experience with complete operational control of a business

~ The Manager may leave the Company or become unable to manage the Company

The Company may need to raise more money in the future, potentially via debt or equity, if our projections on revenues and expenses are incorrect, and it may be unable to raise such funds. If we aren't able to raise enough funds we may be forced to create cuts to our team and budget.

We need to raise \$750k to be able to finish construction and ultimately open the restaurant by our anticipated April 2023 launch date. Failure to raise this amount will result in a delayed opening.

Investors have limited-to-no power over major company decisions, which are determined by the managing member and founder of the Company.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Use of Proceeds: 35% towards Kitchen and Bar Equipment, 16% towards Working Capital, 16% towards Furniture and Fixtures, 6% towards Marketing, Logo, and Menu, 4% towards opening Beverage Inventory, 4% towards Opening Payroll, 3% on Attorney, 2% towards Ceramics, Glassware and Flatware, and 9% towards POS Systems, Opening Food Inventory, Initial Insurance, Pots, Pans, and Cooking Utensils, Liquor License, and Utility Deposits, 5% towards WeFunder Fees.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. ## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

Profit Share:

The Company is offering to both accredited and non-accredited investors up to 717,000 Units of its Class A Units (each a "Class A Unit" and, collectively, the "Class A Units" or "Securities") at a purchase price of \$1.00 per Unit.

The minimum amount or target amount to be raised in the Offering is \$467,000.00 (the "Target Offering Amount") and the maximum is \$717,000.

The Company will not close the Offering unless it has received subscriptions for at least 467,000 Class A Units. The Company has already issued 283,000 Class A Units (the "Initial Units"), 250,000 for cash and 33,000 for services in lieu of cash.

The Company will also issue, for no cash consideration, 1 Class B Unit of membership interests (the "Class B Units") to the Manager and founder of Company, Alexander Burch, for every 3 Class A Units outstanding at the closing of the Offering (including the Initial Units).

Distributions by the Company will be distributed based on the number of Units owned (75% to holders of Class A Units and 25% to holders of Class B Units) until the initial investment in the Class A Units has been recouped in full. Once the initial investment is recouped, the number of Class B Units will be automatically increased by a factor of 9, so thereafter distributions will be 25% to the holders of Class A Units and 75% to the holders of Class B Units.

If the Offering is oversubscribed beyond the Target Offering Amount, the Company will sell Class A Units on a basis to be determined by the Company's management.

**Confidentiality.** Anything in this Agreement to the contrary notwithstanding, no Major investor by reason of this Agreement shall have access to any trade secrets or confidential information of the Company. The Company shall not be required to comply with any information rights in respect of any Major Investor whom the Company reasonably determines to be a competitor or an officer, employee, director or holder of ten percent (10%) or more of the equity interests of a competitor. Each Major Investor agrees that such Major Investor will keep confidential and will not disclose, divulge, or use for any purpose (other than to monitor its investment in the Company) any confidential information obtained from the Company pursuant to the terms of this Agreement other than to any of the Major Investor's attorneys, accountants, consultants, and other professionals, to the extent necessary to obtain their services in connection with monitoring the Major Investor's investment in the Company.

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

**The unitholders** have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional units, an Investor's interest will typically also be diluted.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our Class A Units that take into account factors such as the following:

- unrelated third party valuations of our Class A Units;
- the price at which we sell other securities, such as convertible debt or Class A Units, in light of the rights, preferences and privileges of our those securities relative to those of our Class A Units;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the lack of marketability of our Class A Units;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;

- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The restaurant will be wine and small plate focused. The Company has not begun operations and the only transactions incurred to date are the payment of initial organizational legal fees by the sole member of the Company.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

#### Milestones

Bad Idea LLC was incorporated in the State of Tennessee in May 2021.

- *Assets.* As of December 31, 2021, the Company had total assets of \$0, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$8,018 for 2021.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$283,000 in equity and \$8,018 in loans from the founder.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Bad Idea LLC cash in hand is \$236,511, as of September 2022. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$4,526.67/month, for an average burn rate of \$4,526.67 per month. Our intent is to be profitable in 8 months.

Since the date our financials cover, we received a \$250,000 investment to cover expenses before we initiate the WeFunder raise. We have also incurred the following expenses: \$10,000 paid as a deposit to S&S Property Management (Lease Deposit), \$525 to an accountant (Taxes and Consulting), \$320 to the State

of Tennessee, \$6,080 to EOA Architects, and \$7,500 to Lasso Studio (Branding).

In the next 3-6 months the Company expects no revenue since we have not yet opened. We need \$750,000 in capital total to become revenue-generating, and profitable, as we anticipate accruing this amount in expenses. We expect to have this funding completed by end of December 2022. As of April 2023 We expect to be generating approximately \$241,500 in revenue per month. These are forward-looking projections and can't be guaranteed.

We are not profitable, as we haven't opened yet. We need to raise a total of \$750,000 to open the restaurant and become profitable. We still have to obtain permitting and finish constructing the restaurant. We intend to be profitable starting the first month of opening, slated for April 2023.

Outside of funds raised on Wefunder, the founder has received \$250,000 of capital to cover short term burn.
