8. Discuss the material factors that make an investment in the issuer speculative or risky:

Limited operating history: Nepal Tea Collective was established in 2016 and as such has a limited operating history. Since the company is in its early phase of growth, there is only limited business data (operational and financial) available to base its future performance. As with any new business, there are the imminent risks of attracting and retaining customers, attracting and retaining qualified team members, and raising additional capital if/when needed.

Operating losses: The company has an operating loss for the year 2021 and we expect to incur net losses for the next three years as a result of our growth efforts until we can produce sufficient revenues to cover the expenses, which might never occur.

Negative cash flow: The company does not expect to be cash-flow positive during its growth phase. The company expects to invest heavily to scale the business which will require additional capital. In a scenario where the company is unable to obtain capital in favorable terms, it might have to eventually scale down and minimize its expansion plans

Intellectual property issues: Intellectual property is not the core focus of the company and as such any unauthorized parties may copy or develop similar products, services or businesses entirely. In such cases, the company might not be adequately prepared with financial and other resources to identify and prosecute the use of intellectual properties. Similarly, the company may be subject to intellectual property infringement and in such cases, the company cannot guarantee that its financial and other resources are going to be enough to defend itself during such scenarios.

Future business/operational uncertainty: The company cannot assure that it will be able to identify, manage and benefit from existing and potential market opportunities. The company can make no guarantee that its current systems, processes, and controls will be efficient, effective, and adequate to support its future growth and operations.

Similarly, ineffective budgeting, forecasting, and other business processes issues might affect the company's expansion plan and hurt the company's business, operations, and financials leading to increased costs decreased revenue and even closure of the business.

Reliance on the Founders and Managers: The founders and managers have complete control over the company currently and even after the successful completion of the seed round, they will have substantial control over the company and therefore, most if not all decisions for the company will rely on the best judgment of the founders and managers and any other officers that the company adds in the longer run.

General litigation risk: As with all businesses regardless of the industry, the company can be sued at any time. The company might be a party to legal claims and proceedings that might significantly hamper the company operations and sustainability/viability of the business and its entire operations.

Food safety and other laws & regulations: The food and beverage category in the US is highly regulated by federal, state and local institutions. The FDA regulates "tea" as almost any other food category and therefore, the rules and guidelines adopted by the agency give almost all part of the company's operations. The company's resources might sometimes not be adequate to the regulatory requirements which can delay the company's operations at large.

Furthermore, the company relies heavily on its farmer partners for the ingredients and final products and since they are located in Nepal, it might be quite difficult to monitor and maintain standard requirements applicable to the US. Moreover, the company depends on its staff and other

partners to follow safe handling practices, however, if problems arise in these systems, the company's reputation, business operations, and ability to stay competitive in the market might be lost.

Supply Inefficiencies: The company is heavily reliant on agricultural products for revenue generation. Production or supply-side risks stem from uncertain and unpredictable natural growth processes and systems of crops that are affected by climate, weather, pests and diseases, manpower, and so on. Therefore, any fluctuations in the production and supply chain will severely impact the company's ability to exist and grow the business substantially.

Technological Issues: The company's business model is heavily reliant on technology from the production, and packaging aspects to the marketing and selling aspects. A Significant portion of the communication and sales is carried out through online channels. While the systems are external, they are susceptible to interruptions due to factors beyond the control of the company including, but not limited to, natural disasters, telecommunications failures, computer viruses, or other security issues. These issues could potentially hamper the operations and financial viability of the company. While these security concerns are handled primarily by our e-commerce platform, if the company is not able to identify its growing needs on time and adapt to the changing environments, the company might be negatively affected and as such would restrict its growth potential.

Projections: The financial projections provided are based on assumptions, facts, events, forecasts and other factors the company may have no control over. Therefore, if the company is unable to achieve the growth that is forecasted, the returns might be severely affected, and or the company may eventually fail.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which

for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 45% towards hiring and retaining talent, 25% towards digital marketing, 22.5% towards product development, and 7.5% towards Wefunder fees.

If we raise: **\$600,000**

Use of Proceeds: 32.5% towards hiring and retaining talent, 20% towards digital marketing, 40% towards product development, and 7.5% towards Wefunder fees.

Raising 600K would completely ensure our sustainability for the next 16 months with the growth rate of 100% which will create a viable path for us to raise our Series A down the line. With the 50K, we will still be able to hit our yearly target of doubling our top-line revenue but would significantly slow our growth.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **preferred stock** issued to new Investors multiplied by
 - b. the **discount rate** (80%), or
- ii. if the valuation for the company is more than **\$5,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating

Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. This section

investor) takes the place of the Lead investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

We sell organic teas directly from the farmers in Nepal to the final consumers in the USA. With every purchase, we reinvest 1% of the revenue directly to the farmer to empower them to make better products and create sustainable livelihoods in the longer run. Similarly, with every purchase, we also plant one tea sapling that offsets carbon from the environment and also provides additional income for the farmers.

In five years, we will truly become global family farms with efficient and sustainable supply chains in at least 2 different countries and direct-to-consumer sales globally. We will have multiple product verticals ranging from teas, herbs, spices, essential oils, and so on. Similarly, we will have services and retail revenue streams through immersive tourism packages and franchise potential. Forward looking projections cannot be guaranteed.

Milestones

Nepal Tea Collective Public Benefit Corporation was incorporated in the State of Delaware in January 2022.

Nepal Tea LLC was converted from a New Jersey limited liability company into a Delaware public benefit corporation on Jan 1st, 2022, and, in connection therewith, the members of Nepal Tea LLC agreed to convert their membership interests in Nepal Tea LLC into equity interests of the Company in the same proportion as their ownership in Nepal Tea LLC; and holders have exchanged the Membership Interests and to receive 1,000 shares of Company's Common Stock, par value \$0.01 per share (the "Common Stock")

Our company was organized in January 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$403,885.96 compared to the year ended December 31, 2021, when the Company had revenues of \$251,605.05. Our gross margin was 48.84% in 2021, compared to the year 2020 when our gross margin was 43.99%.
- *Assets.* As of December 31, 2022, the Company had total assets of \$258,543.03, including \$77,408.97 in cash. As of December 31, 2021, the Company had \$166,201.52 in total assets, including \$56,948.94 in cash.
- *Net Income/Loss.* The Company has had a net income of \$746.04 and a net loss of \$18,084.17 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$247,852.45 for the fiscal year ended December 31, 2022 and \$158,942.98 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$89,500 in debt, \$10,000 in informal convertible debt from friends and family, and \$18,809 in contributions from the partners.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations

over the lifetime of the Company. We plan to raise capital in 16 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Nepal Tea Collective Public Benefit Corporation cash in hand is \$32,553, as of July 2022. Over the last three months, revenues have averaged \$17,788/month, cost of goods sold has averaged \$8,716/month, and operational expenses have averaged \$23,766/month, for an average burn rate of \$14,694 per month. Our intent is to be profitable in 36 months.

We have yet to book our largest wholesale orders for the year. They will be booked in the months of July/August. We are on track to doubling our growth this year by reaching our last year's annual revenue within August.

Revenue for the next 6 months is expected to be around \$350K with expenses of approx. 200K. Significant expenses will be towards product development, digital marketing, and hiring/retaining talent.

We are not profitable yet. However, we expect to be profitable by the end of 2024 or early 2025. We will require one more funding round (Series A for 3 million) to attain profitability by significantly scaling our sales and reaching economies of scale with reference to product development and supply chain.

We are currently covering our short-term burn through the SBA EIDL loan. We also have access to short-term revenue-based loans through shopify if the need be. Forward looking projections cannot be guaranteed.

No matters are required to be disclosed with respect to events relating to any affiliated issuer that occurred before the affiliation arose if the affiliated entity is not (i) in control of the issuer or (ii) under common control with the issuer by a third party that was in control of the affiliated entity at the time of such events.

OTHER MATERIAL INFORMATION

31. In addition to the information expressly required to be included in this Form, include:

- (1) any other material information presented to investors; and
- (2) such further material information, if any, as may be necessary to make the required statements, in the light of the circumstances under which they are made, not misleading.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the “Proxy”). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors’ behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund (“Fund”) for accredited investors for the purpose of

fund (Fund) for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
