We have a limited operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters.

We have a limited history upon which an evaluation of our prospects and future performance can be made. To date our operations have focused on developing technology. The likelihood of our success must be considered in light of the problems, expenses, difficulties, complications, and delays

frequently encountered in connection with the inception of a business, operation in a competitive industry, and the continued development of advertising, promotions, and a corresponding client base. There can be no assurances that we will ever operate profitably. You should consider the Company's business, operations and prospects in light of the risks, expenses and challenges faced as an early-stage company.

The amount of capital the Company is attempting to raise in this Offering is unlikely to sustain the Company's additional Phase of the business plan.

In order to achieve the Company's long-term goals, the Company must procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we will not be able to fully execute our business plan, our continued operations will be in jeopardy and we may be forced to cease operations and sell or otherwise transfer all or substantially all of our remaining assets, which could cause an Investor to lose all or a portion of his or her investment.

The development and commercialization of our products is highly competitive.

We face competition with respect to any products that we may seek to develop or commercialize in the future. Many of our competitors have significantly greater financial, technical and human resources than we have and superior expertise in research and development and marketing approved products and thus may be better equipped than us to develop and commercialize products. Accordingly, our competitors may commercialize products more rapidly or effectively than we are able to, which would adversely affect our competitive position, the likelihood that our products will achieve initial market acceptance and our ability to generate meaningful additional revenues from our products.

The current lack of patent protection for our technology may make it more difficult for us to enforce our rights and may make it easier for others to compete with us.

If we are unable to obtain, maintain and enforce patent protection for our current and future technology, or if the scope of the patent protection obtained is not sufficiently broad, our competitors or other third parties could develop and commercialize technologies similar or identical to ours and our ability to successfully develop and commercialize our technology may be adversely affected. We intend to file provisional patent applications with the United States Patent and Trademark Office covering proprietary intellectual property developed by us. However, filing provisional patent applications in no way guarantees that we will receive any issued patents, which may undermine our ability to successfully protect our intellectual property.

Changes to Federal Laws Pertaining to Hemp

Federal regulations under the 2018 Farm Bill were promulgated in the IFR on October 31, 2019. The IFR governs the domestic production of Hemp under the 2018 Farm Bill and also specifies the provisions that a state or tribal Hemp plan must contain to be in compliance with the 2018 Farm Bill. However, some states are continuing to operate under the 2014 Farm Bill through the 2021 growing season. The IFR, which expires November 1, 2021, was replaced by the USDA's Final Rule on the same topic and took effect March 22, 2021. Should the USDA's implementation of the permanent regulations adopted pursuant to the 2018 Farm Bill or other regulations result in stricter requirements on the Company or our customers than those of the 2014 or 2018 Farm Bills or the IFR, such changes could have a material adverse effect on the Company's business, financial condition and results of operations.

Our efficiency may be limited while our current employees and future employees are being integrated into our operations.

We may be unable to find and hire additional qualified management and professional personnel. There is competition for qualified personnel in the area of the Company's activities, and there can be no assurance that the Company will be able to attract and retain qualified personnel necessary for the development of our business. If this business cannot effectively hire employees to help the company grow, the business could be at risk.

We expect our expenses to grow as the Company grows.

Our expenses will increase as we build infrastructure to implement our business plan. For example, we may hire additional employees, expand our product offerings, purchase equipment and lease more space for our corporate offices.

We are taxed as a "pass-through" entity which means that income and losses must be recognized by you as an owner of the Company.

The Company, as a limited liability company, is taxed as a partnership or a "pass-through" entity. As such, each investor will be subject to various federal, state and local income taxes based on their pro rata share of the Company's income. The Company is under no obligation to pay and has no intention of paying, the amount of the taxable income, or the amount of tax due to be paid by you with respect thereto, and the tax must be paid by each member with cash sources other than the Company. No representation or warranty of any kind is made by the Company with respect to any tax consequences relating to the allocations of taxable income or loss to members, or any actions the Company might take or be in a position to take to make cash distributions to its members. Even if the Company seeks to distribute amounts to Unit holders each year sufficient to cover their income tax liabilities, the Company may be limited, by contractual or other legal limitations, in its ability to make such distributions. We are not subject to public company reporting regulations and lack the financial controls and safeguards required of



public companies.

We do not have the internal infrastructure necessary, and are not required, to complete an attestation about our financial controls that would be required under Section 404 of the Sarbanes Oxley Act of 2002. There can be no assurance that there are no significant deficiencies or material weaknesses in the quality of our financial controls. We expect to incur additional expenses and diversion of management's time if and when it becomes necessary to perform the system and process evaluation, testing and remediation required in order to comply with the management certification and auditor attestation requirements.

The Units will not be freely tradable until one year from the initial purchase date. Although the Units may be tradable under federal securities law, state securities regulations may apply and each Purchaser should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Units. A majority of the Company is owned by a single owner.

Prior to the Offering the Company's founder owner holds 100.0% of the Company, and after the Offering will hold 100.0% of the Company's outstanding voting units. Subject to any fiduciary duties owed to our other owners or investors under Minnesota law, the owner may be able to exercise significant influence over matters requiring owner approval, including the election of directors or managers and approval of significant Company transactions, and will have significant control over the Company's management and policies. The founder may have interests that are different from yours. For example, the owner may support proposals and actions with which you may disagree. The concentration of ownership could delay or prevent a change in control of the Company or otherwise discourage a potential acquirer from attempting to obtain control of the Company, which in turn could reduce the price potential investors are willing to pay for the Company. In addition, the owner could use their voting influence to maintain the Company's existing management, delay or prevent changes in control of the Company, or support or reject other management and board proposals that are subject to owner approval.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 9 months. We will begin with the Textile decorticator, then the Tensile strong fiber decorticator, then the Dual Purpose Dryer & a Hemp Combine. At a cost of \$3.5M, and estimated future additional Capital of \$10M projected revenue generating to begin the end of summer or fall 2024

We are not yet profitable. This is a start-up or seed operation. We are giving birth to a new industry with new technology to advance the industrial hemp industry. We have had many inquiries due to the problems facing farmers & processors with this new highly potential Industrial Hemp industry. We are optimistic we will create a sustainable cash flow within 3+ years to stay afloat with the inquiries we've received to date.

Aside from Wefunder, we have already raised capital which we have invested in our proprietary designs. For example we hired an engineering firm, hired an advertising firm, incurred lawyers fees, auditing costs, research & development.
