An identity confidence score is an unproven technology that may not be adopted quickly, at all, or at the necessary scale for certain products to be available (i.e. one login for most websites).

Unproven business model: The concept of identity agents is new and untested. It's unclear if there will be widespread consumer adoption or if the company will be able to generate significant revenue, even if the idea seems promising.

Regulatory risks: Handling sensitive personal data is subject to evolving data privacy regulations like GDPR, CCPA, etc. The company could face substantial compliance costs or penalties if regulations change or if data breaches occur. Regulatory barriers could slow growth.

Competition from tech giants: Large tech companies like Apple, Google, Microsoft etc. are also working on digital identity solutions and have vast resources. We could struggle to compete if big players move into this space aggressively.

Technical challenges: Building a secure, universal, AI-driven identity platform is a major technical undertaking. Unforeseen technical hurdles could lead to delays, cost overruns, or an inability to deliver on the vision. Security vulnerabilities could be catastrophic.

Long time horizon to profitability: Developing this novel technology and driving wide-scale consumer adoption will likely take many years. The company may need substantial capital and have a long path to positive cash flow. Later funding rounds could significantly dilute earlier investors.

Adoption challenges: The company's success hinges on convincing a critical mass of consumers to trust and use their identity agent. People may be hesitant to give a startup so much personal data. Building trust and changing engrained behaviors could prove difficult and costly.

Dependence on partnerships: The platform's value proposition depends on a robust marketplace of partners. But it could be challenging to integrate with many partners and offer a seamless experience across ecosystems. Some key partners may block interoperability to protect their own interests.

Founder risk: If a key founder departs, becomes incapacitated, or turns out to be unscrupulous, it could sink the venture.

Macroeconomic and market risks: A major economic downturn or stock market crash could make it much harder for the company to raise more funds or find an exit through IPO/acquisition.

Geopolitical risks: Digital identity solutions could face additional scrutiny due to national security concerns, especially if a private company ends up mediating identity on a massive scale. Foreign powers could even try to sabotage or infiltrate the platform to cause chaos.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead

Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents. To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. I started Grape ID out of personal frustration. In 2018, I was a victim of 5 data breaches & identity theft which taught me that businesses are in control of our data. They make money off our data AND put us at risk - I'm determined to change that.

The Grape ID Ad Marketplace allows advertisers to laser target prospects without accessing any of the prospect's data, thus protecting people's privacy.

It uses artificial intelligence, blockchain, omni-factor authentication, and other technology to protect user data from cybercriminals and advertisers, earn cash for its users, and eliminate 99% of email spam.

These are three rights each internet user has: 1) right to

privacy & security, 2) right to monetize their data, and 3) right to spam-free communication.

We aim to help at least 30 million people earn cash for and protect their data. We project being able to reach \$1+ billion in annual recurring revenue (ARR) and we're confident we'll reach that as long as we focus on delivering on our promises.

Milestones

The Boogie Badge, Inc. dba Grape ID was incorporated in the State of Delaware in May 2018.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

The Boogie Badge, Inc. dba Grape ID cash in hand is \$848, as of June 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$6,986/month, for an average burn rate of \$6,986 per month. Our intent is to be profitable in 48 months.

We expect revenue this year because in Jan 2024 we met with 20+ small businesses and 92% of them opted in to use our advertising service once it becomes available. We also received \$368.00 in deposits towards the services. The high opt-in rate with any amount of cash collected is a strong indicator that we'll have revenue within 90 days of our product being made available.

We have also seen our expenses increase as we raise more capital, bring staff into the company full-time, and continue

developing Grape ID products.

We expect roughly \$25,000+ in monthly revenue in 3 - 6 months from now. No funding is required to start generating revenue -- we are fundraising now to build and improve the product before executing on our sales pipeline. We expect we will require \$10 million to reach \$10 million in annual recurring revenue within 24 months. We'll incur a minimum total expense of approximately \$550,000 for those 6 months. This will increase should the business grow revenue or funding faster than expected.

We are not currently profitable. We do not expect to be profitable until two years after we receive \$10M in funding. We don't expect any funding necessary to reach profitability after that \$10M. While we may be able to reach profitability with \$5M, \$10M is more realistic.

We are also raising via Reg D investors, venture firms, and other venture partners. Short-term burn throughout the campaign will be funded via funds received in the campaign itself and therefore the rate at which we intake investment will likely increase as investment is received (since it'll be placed back into securing more investment).

All projections in the above narrative are forward-looking and not guaranteed.
