The biggest risk is producing a film project without distribution. That's why we're lucky that we already have Gravitas Ventures on board. Without distribution no one sees the movie.

Another risk is if the movie is done very badly. In that case it would not be seen and interest in it would be low.

Getting no name actors on board. The actors on board are very important in selling and marketing the movie. It is key to have the best names on board.

Not having enough money for marketing. Especially in the indie space marketing is extremely important to be seen. If you make a great movie and no one knows about it then it's not a success. Marketing is extremely important and something not enough indie filmmakers prioritize.

In terms of revenue, it could be that our financial projections are not accurate or

that it takes longer (if at all) to meet projections. If this is the case, our investors may experience a lengthy period on their rate of return or lack of return that is well below that of other investment opportunities. The film industry can never guarantee how much a movie will make, these are only projections.

The Company itself is in the organizational stage and is subject to all the risks incident to the creation and development of a new business. In order to prosper, the success of the Company's film will depend partly upon the ability of management to produce a film of exceptional quality at a lower cost that can compete in appeal with high-budgeted films of the same genre. In order to minimize this risk, management plans to participate as much as possible throughout the process and will aim to mitigate financial risks where possible. Fulfilling this goal depends on the timing of investor financing, the ability to obtain distribution contacts with satisfactory terms, and the continued participation of the current management.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: With this budget we can start principal photography and some post production. 6.9% towards Wefunder fee, 60% cast and crew, 33.1% Production.

If we raise: **\$124,000**

Use of Proceeds: With this budget we can do principal photography and post editing and marketing. We can also get a bigger name actor on board which will help in selling the movie. 40% cast and crew, 20% production, 15% post production, 6.9% Wefunder fee, 18.1% marketing.

Film Financing Agreement: 125% of principal + 50% of net profit (130% of principal for the first \$50,000 of investors).

Producer agrees to repay to Financier the Financing Amount, together with a twenty-five percent (25%) premium or thirty percent (30%) if an "early bird" investor thereon ("Financier Recoupment"), solely from Gross Receipts (if any).

Producer shall receive Fifty Percent (50%) of Net Receipts ("Producer's Net Receipts") and the other Fifty Percent (50%) of Net Receipts shall be "Financier's Net Receipts" including additional financiers investing outside of the Portal. Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the **unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the **unitholders** may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The **unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The **unitholders** have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional units, an Investor's interest will typically also be diluted.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common units that take into account factors such as the following:

- unrelated third party valuations of our common units;
- the price at which we sell other securities, such as convertible debt or preferred units, in light of the rights, preferences and privileges of our those securities relative to those of our common units;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the lack of marketability of our common units;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic

Four Doors Film LLC was incorporated in the State of California in August 2022.

- You want to support a feature with a diverse cast and team
- 1st Feature Film, The Willowbrook, by team yielded a distribution deal with Gravitass Ventures.
- Gravitass Ventures interested in distribution for Four Doors
- WGA writer Zach Koepp, numerous Netflix rewrites and polishes, feature sale, and TV show creator
- Genre that is highly profitable
- Already raised \$116k in previous round

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in August 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues.* For the period ended December 31, 2023, the Company had revenues of \$0 compared to the year ended December 31, 2022, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2023, the Company had total assets of \$103,339, including \$81,549 in cash. As of December 31, 2022, the Company had \$94,304 in total assets, including \$94,304 in cash.

Liquidity & Capital Resources

So far the Company has been funded with \$115,744 in investments through a film financing agreement.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Four Doors Film LLC cash in hand is \$81,549, as of March 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$0/month, for an average burn rate of \$0 per month. Our intent is to be profitable in 12 months.

We have set a date for starting production in April and expect to be done shooting in May. We then expect edit to be done and movie ready by end of year.

We expect expenses to be \$50k in the next 4 months. Then another \$30k after that. As well as an extra \$25k after that. This includes, production, post production, marketing and PR. We expect to start making revenue next year when it is released and we have a distribution deal set up.

We are not yet profitable. We need an extra \$100k ideally in funding to attach bigger names to the project that will help sell the project at a higher number to distributors. We expect to reach profit in 2025.

Besides funds raised through Wefunder, we have our own capital. During production, we plan to invest \$30k of producer money and another \$15k of director money as well. In total we will have \$45k invested of our own. We will only have costs when we start production.

All projections in the above narrative are forward-looking and not guaranteed.
