8. Discuss the material factors that make an investment in the issuer speculative or risky:

Zeek Bar operates in an extremely competitive market with hundreds of competing brands. It is my belief that the single biggest challenge to this business is cutting through the noise and standing out as a differentiated product. This will take time and money to do effectively. In addition, the threat of new product releases from large brands and emerging brands presents an ever changing competitive landscape that must be navigated with a close eye.

While we have existing customers and revenue, the fact is that most startups fail because customers simply don't love their product enough. Though we are committed to developing superior products vs the competition, it is entirely possible that despite our best efforts, customers do not see our products as value-add enough to drive our growth projections. Such a stall in growth creates ripple effects that can topple the business.

We will need to raise additional capital in subsequent fundraising rounds to achieve our vision and growth. There is no guarantee that we will be able to do so.

Our small business can be especially vulnerable to broader macroeconomic forces, such as recessions, wars, diseases, etc.

We are limited in our distribution channels currently as the majority of our sales occur through Whole Foods and Amazon. This represents risk if one of these channels is canceled or closed. For example, Whole Foods evaluates products every 6-9 months and Amazon has complete autonomy to suppress, hide, and cancel listings, which has happened to us in the past. This can reduce sales to zero overnight and take weeks, if not months to rectify. It is our priority to diversify distribution channels as soon as possible.

Supply chain interpretations such as natural disasters, ingredient or packaging shortages or delays, and warehousing failures always pose a threat to inventory and our ability to get product where it needs to be and when it needs to be there.

We rely on a manufacturing partner to make our products. This is the most important business relationship we have. Any risks that our manufacturing partner is exposed to, so are we. In addition, if there is a breakdown in this relationship, we could be extremely adversely affected. For example, if they manufacture poor quality or faulty product, knowingly or unknowingly, and are unwilling to replace it, we may lose substantial inventory and incur additional costs.

There is always a possibility of contamination leading to a food recall causing substantial loss of inventory and damage to our brand reputation.

Food products can also be vulnerable to lawsuits filed by consumers for causing bodily harm or illness.

We rely strongly on our intellectual property, namely the "Zeek" brand name and logo for consumer recognition. This IP can present a target to other companies that feel we are infringing on their marks. It is not uncommon for lawsuits to be filed simply to cause a disruption for a competing brand. Currently we have no pending allegations against us, but we have experienced Demand letters in the past and have had to adjust our branding marketing. Such alterations when required are expensive, whether or not they have merit.

It is possible that the Company will never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have

no private or public market, and the Company cannot be sure that one will develop in the foreseeable future, or if one develops, that it will be maintained. The Securities are offered and sold pursuant to one or more exemptions from registration under the Securities Act of 1933, as amended (the "Securities Act") and without qualification or registration under the securities laws of the various states.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, investors will receive a number of shares of **preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the investor's investment, divided by
 - a. the price of **preferred stock** issued to new investors multiplied by
 - b. the **discount rate** (80%), or
- ii. if the valuation for the company is more than **\$2,500,000.00** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the first **\$45,000.00** of the securities, investors will receive a valuation cap of **\$2,000,000.00** and a discount rate of 80.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving **preferred stock**, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor

investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

A. the Purchase Amount may not be amended, waived or modified in this manner,

B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and

C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

Overview

We're building a disruptive kids snack brand.

80% of parents regularly search for low or no sugar products (sugarwise.org).

There were +\$20B in "Low Sugar" claims across snack categories in 2021, but 95% of the \$1.4B granola bar category still contains more than 8g sugar per bar. That's more than 30% sugar by weight!

Zeek Bars are truly disruptive to the category with 50% less sugar vs the leading brands and 4-5x the protein.

We anticipate the "Low Sugar" share of the category to be a \$400M market by 2026 and we intend to be the leader.

Mature brands have failed to capture the attention of kids and we see a massive opportunity to leverage digital media to build the first brand, "For Kids, By Kids".

Think Red Bull meets Nickelodeon: we're bringing kids to the center of the brand - ambassadors, product development, social causes, events and activations - to break through as a challenger brand. Forward looking projections cannot be guaranteed.

Zeek Ventures Inc. was originally organized as an LLC in 2014 under the name Hero Ventures LLC. On 12/12/18, the company amended its name to Zeek Sports Fuel LLC. On October 19, 2021, Zeek Sports Fuel LLC converted to Zeek Ventures Inc., a Delaware corporation.

The financial statements provided cover the operating history of both Zeek Ventures Inc. and its predecessor, Zeek Sports Fuel LLC.

Our company was organized in July 2014 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended July 31, 2022, the Company had revenues of \$122,756.18. Our gross margin was 27.09%. For the period ended July 31, 2021, the Company had revenues of \$68,307.14. Our gross margin was 20.50%.

- *Assets.* As of July 31, 2022, the Company had total assets of \$84,409.79, including \$12,374.61 in cash. As of July 31, 2021, the Company had total assets of \$63,347.79, including \$3,827.99 in cash.

- *Net Loss.* The Company has had net losses of \$64,954.51 for the fiscal year ending July 31, 2022. The Company has had net losses of \$55,722.74 for the fiscal year ending July 31, 2021.

- *Liabilities.* The Company's liabilities totaled \$163,522.27 for the fiscal year ending July 31, 2022. The Company's liabilities totaled \$83,453.98 for the fiscal year ending July 31, 2021.

Liquidity & Capital Resources

To date, the company has been capitalized with \$151,631 in founder contributions and \$160,223 in debt.

After the completion of this Offering, operations will continue for the next

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 15 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Zeek Ventures, Inc cash in hand is \$29,746, as of September 2022. Over the last three months, revenues have averaged \$12,666/month, cost of goods sold has averaged \$7,840/month, and operational expenses have averaged \$7,477/month, for an average burn rate of \$2,651 per month. Our intent is to be profitable in 6 months.

We've had a particularly busy month of August and our main vendor UNFI has placed several large orders. Our accounts receivable has grown to \$22,441.02

We've used additional funds from our Fremont Bank Line of Credit to purchase more inventory to meet demand and at present do not have additional funds available from this source.

We anticipate our revenues will average \$15-\$18k over the next 3-6 months. Note there is some seasonality in this category namely, the back to school months of August and September are particularly busy followed by slower periods in the winter months.

Year to date our average monthly burn is \$3.5k. We plan to increase this burn to \$5-6k/mo in the next 3-6 months to invest in growth, namely increased Amazon ad spend, and costs related to launching in new stores. Given this burn rate, our runway is 12-15 months.

We anticipate that our expenses, including cost of goods sold, will be \$18-\$20k in the next 3-6 months. This is reflective of an increased investment in our primary sales channel, Amazon, (\$3k monthly advertising budget + \$1.5k monthly agency fee) and additional expenses related to planned retail expansion in 2023.

Our plan is to continue investing in growth activities while keeping our burn rate manageable to bridge us to our next fundraising round. It's important to understand that our vision is to build a national brand and sustaining a relatively high growth rate is key to this vision. While our main priority is not profitability, if we do not invest in growth activities at this same rate beyond the next 3-6 months, we break even around \$20k/mo in revenues. We anticipate we can reach profitability in 6 months.

If we prioritize profitability, we will breakeven around \$20k per month in revenue which will require no more than \$50K in total capital raised. However, it's important to understand that our vision is to build a national brand and sustaining a relatively high growth rate is key to this vision. In the next 9-12 months we anticipate a monthly burn of \$5-6k/mo. In order to achieve our growth plans we anticipate raising \$500k-\$1M in capital in 12-15 months to propel us to \$5-\$10M in sales and profitability.

We have access to multiple sources of debt financing if necessary. Our main source is a \$50k line of credit from Fremont Bank. We intend to increase this to \$75k during the campaign to provide additional funding if necessary.

We also have \$15k available to us through American Express' working capital program (loans are made with terms of net 30, 60, or 90 days).

The Lead Investor. As described above, each investor that has entered into the investor Agreement will grant a power of attorney to make voting decisions on behalf of that investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in

which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

If the Proxy is not revoked during this 5-day period, it will remain in effect.
