Fathom currently only supports Zoom. Should Zoom significantly lose market share we would be adversely affected

There are no other securities offered.

Should the market for Zoom calls (and meetings taken via Zoom calls) decrease, the need for our product may also decrease. In order to survive and grow we may need to iterate on new business lines.

We operate a tech business that is dependent on recruiting and retaining tech professionals. Those professionals include engineers, who can be difficult to hire and retain. Should we be unable to attract the appropriate talent our business will not be able to grow.

We transcribe and record sensitive data. While we take customer privacy seriously, a breach could negatively impact our business.

Our rapid growth means we continue to have to make changes to our core infrastructure in order to handle demand. The larger we get the harder it is to find engineering talent that has experience building systems at that scale especially with the real-time, and write-heavy nature of our product.

Operational costs (video recording, storage, and transcription) for the business are significant. We will need to continue to fine economies of scale as we grow to minimize operational costs of providing a free product.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

Fathom Video Inc. specializes in application technology that records, transcribes, and highlights key points from video conferencing, so individuals can focus on the conversation and not on taking notes.

Milestones

Fathom Video Inc. was incorporated in the State of Delaware in August 2020.

- 30% MoM usage growth last 6 months
- #1 Rated Product for SMB on G2 with a perfect 5.0
- Net Promoter Score of 85 (Apple's: 51, Airbnb's: 74)
- #2 AI app on Product Hunt for 2021
- Top App in the Zoom App Marketplace

Historical Results of Operations

Our company was organized in August 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended January 31, 2024, the Company had revenues of \$1,280,616 compared to the year ended January 31, 2023, when the Company had revenues of \$113,581. Our gross margin was -7.06% in fiscal year 2024, compared to 100.0% in 2023.
- *Assets.* As of January 31, 2024, the Company had total assets of \$4,860,936, including \$3,134,506 in cash. As of January 31, 2023, the Company had \$3,417,554 in total assets, including \$1,427,613 in cash.
- *Net Loss.* The Company has had net losses of \$3,603,467 and net losses of \$2,366,720 for the fiscal years ended January 31, 2024 and January 31, 2023, respectively.
- *Liabilities.*

The Company's liabilities totaled \$1,124,324 for the fiscal year ended January 31, 2024 and \$175,981 for the fiscal year ended January 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$18,943,505 in equity and \$6,861,348 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 48 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 5 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Fathom Video Inc.'s cash in hand is \$17,500,000, as of June 2024. Over the last three months, revenues have averaged \$500,000/month, the cost of goods sold has averaged \$350,000/month, and operational expenses have averaged \$350,000/month, for an average burn rate of \$200,000 per month. Our intent is to be profitable in 9 months.

Since the date our financials cover, the closing of the majority of our Series A has had a material impact on cash in the bank. We had a pretty big inflection in revenue growth starting in December. As AI has gotten better, our product has gotten better. We have also seen increased awareness of tools like ours.

By mid-2025, we're expecting to be at about \$15 million in annual revenue.

We have no immediate plans for profitability as we are focused on revenue growth. Our expectation is that we'll keep our monthly burn in the \$300k-\$400k range.

We may do another fundraising round at the end of 2025.

All projections in the above narrative are forward-looking and not guaranteed.

The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to investors before investors make a

final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
