The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 1350 to an Index Closing Level of 1485 on the first Review Date. Because the Index Closing Level on the first Review Date of 1485 is greater than the Call Level of 1350, the notes are automatically called, and the investor receives a single payment of \$1,080 per \$1,000 principal amount note.

Example 2: The level of the Index decreases from the Initial Index Level of 1350 to an Index Closing Level of 1348.65 on the first Review Date, 1282.50 on the second Review Date and 1215 on the final Review Date. Because (a) the Index Closing Level on each of the Review Dates (1348.65, 1282.50 and 1215) is less than the Call Level of 1350, and (b) the Ending Index Level has not declined by more than 10% from the Initial Index Level, the notes are not called and the payment at maturity is the principal amount of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index decreases from the Initial Index Level of 1350 to an Index Closing Level of 1348.65 on the first Review Date, 1215 on the second Review Date and 1080 on the final Review Date. Because (a) the Index Closing Level on each of the Review Dates (1348.65, 1215 and 1080) is less than the Call Level of 1350, and (b) the Ending Index Level is more than 10% below the Initial Index Level, the notes are not called and the investor will receive a payment that is less than the principal amount calculated as follows for each \$1,000 principal amount note:

\$1,000 + [\$1,000 x (-20% + 10%) x 1.1111] = \$888.89

Selected Purchase Considerations

- **APPRECIATION POTENTIAL** If the Index closing level is greater than or equal to the Call Level on a Review Date, your investment will yield a payment per note of \$1,000 plus: (i) at least 8.00%^{*} x \$1,000 if called on the first Review Date; (ii) at least 16.00%^{*} x \$1,000 if called on the second Review Date; or (iii) at least 24.00%^{*} x \$1,000 if called on the second Review Date; or (iii) at least 24.00%^{*} x \$1,000 if called on the second Review Date; or (iii) at least 24.00%^{*} x \$1,000 if called on the final Review Date. Because the notes are our senior unsecured obligations, payment of any amount if called or at maturity is subject to our ability to pay our obligations as they become due. *The actual percentage applicable to the Review Dates above will be determined on the pricing date but will be not be less than 8.00%, 16.00% and 24.00%, respectively.
- **POTENTIAL EARLY EXIT WITH APPRECIATION AS A RESULT OF AUTOMATIC CALL FEATURE** While the original term of the notes is just over three years, the notes will be called before maturity if the Index closing level is at or above the Call Level on a Review Date and you will be entitled to the applicable payment corresponding to that Review Date set forth on the cover of this term sheet.
- LIMITED PROTECTION AGAINST LOSS If the notes are not called and the Ending Index Level declines by no more than 10% as compared to the Initial Index Level, you will be entitled to receive the full principal amount of your notes at maturity. 
• YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS – If the notes are not called and the Ending Index Level declines by more than 10% compared to the Initial Index Level, you will lose 1.1111% of your principal amount for every 1% decline in the Ending Index Level compared to the Initial Index Level beyond the 10% buffer.

- LIMITED RETURN ON THE NOTES Your potential gain on the notes will be limited to the call premium applicable for a Review Date, as set forth on the cover of this term sheet, regardless of the appreciation in the Index, which may be significant.
