#### General

This term sheet no. 66-S relates to two (2) separate note offerings. Each issue of offered notes is linked to one, and only one, Reference Stock. You may participate in either of the two (2) note offerings or, at your election, in both of the offerings. This term sheet no. 66-S does not, however, allow you to purchase a note linked to a basket of both of the Reference Stocks described below.

The notes are designed for investors who seek an interest rate that is higher than the current dividend yield on the applicable Reference Stock or the yield on a conventional debt security with the same maturity issued by us or an issuer with a comparable credit rating. 
## NutriSystem, Inc. ("NutriSystem")

**Example 1: The lowest closing price of the Reference Stock during the Monitoring Period was \$28.50 but the Final Share Price is \$58.00.** Because the Final Share Price of \$58.00 is greater than the Initial Share Price of \$57.00, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 2: The lowest closing price of the Reference Stock during the Monitoring Period was \$28.50 and the Final Share Price is \$56.00. Because the Final Share Price of \$56.00 is less than the Initial Share Price of \$57.00 and the closing price of the Reference Stock declined by more than the Protection Amount on at least one day during the Monitoring Period, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$56.00, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$982.46.

Example 3: The closing price of the Reference Stock between the Pricing Date and before the Observation Date does not reflect a decline of more than the Protection Amount. However, the closing price of the Reference Stock on the Observation Date is \$28.50, a decline of more than the Protection Amount. Because the Final Share Price of \$28.50 is less than the Initial Share Price of \$57.00 and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$28.50, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$39.90 is less than the Initial Share Price of \$57.00 but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note, even though the Final Share Price of \$39.90 is less than the Initial Share Price of \$57.00.

Regardless of the performance of the Reference Stock or the payment you receive at maturity, you will receive interest payments, for each \$1,000 principal amount note, in the aggregate amount of approximately \$40.00 over the term of the notes. If we had priced the notes on September 7, 2007, you would have received 17 shares of the Reference Stock or, at our election, the Cash Value thereof, at maturity, provided the Final Share Price declined from the Initial Share Price and the closing price of the Reference Stock declined by more than the Protection Amount from the Initial Share Price on at least one day during the Monitoring Period. The actual number of shares of the Reference Stock, or the Cash Value thereof, you receive at maturity and the actual Protection Amount applicable to your notes may be more or less than the amounts displayed in this hypothetical and will depend in part on the closing price of the Reference Stock on the Pricing Date.



The following examples illustrate how the total value of payments received at maturity set forth in the table above are calculated.

**Example 1: The lowest closing price of the Reference Stock during the Monitoring Period was \$36.50 but the Final Share Price is \$74.00.** Because the Final Share Price of \$74.00 is greater than the Initial Share Price of \$73.00, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 2: The lowest closing price of the Reference Stock during the Monitoring Period was \$36.50 and the Final Share Price is \$72.00. Because the Final Share Price of \$72.00 is less than the Initial Share Price of \$73.00 and the closing price of the Reference Stock declined by more than the Protection Amount on at least one day during the Monitoring Period, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$72.00, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$986.30.

Example 3: The closing price of the Reference Stock between the Pricing Date and before the Observation Date does not reflect a decline of more than the Protection Amount. However, the closing price of the Reference Stock on the Observation Date is \$36.50, a decline of more than the Protection Amount. Because the Final Share Price of \$36.50 is less than the Initial Share Price of \$73.00 and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is \$36.50, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is \$500.

Example 4: The Final Share Price of \$58.40 is less than the Initial Share Price of \$73.00 but does not decline by more than the Protection Amount, and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of \$1,000 per \$1,000 principal amount note, even though the Final Share Price of \$58.40 is less than the Initial Share Price of \$73.00.

Regardless of the performance of the Reference Stock or the payment you receive at maturity, you will receive interest payments, for each \$1,000 principal amount note, in the aggregate amount of approximately \$37.50 over the term of the notes. If we had priced the notes on September 7, 2007, you would have received 13 shares of the Reference Stock or, at our election, the Cash Value thereof, at maturity, provided the Final Share Price declined from the Initial Share Price and the closing price of the Reference Stock declined by more than the Protection Amount from the Initial Share Price on at least one day during the Monitoring Period. The actual number of shares of the Reference Stock, or the Cash Value thereof, you receive at maturity and the actual Protection Amount applicable to your notes may be more or less than the amounts displayed in this hypothetical and will depend in part on the closing price of the Reference Stock on the Pricing Date.

# **Supplemental Underwriting Information**
