Notes Linked to a Weighted Basket of Three Buffered Return Enhanced Components, Consisting of the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index due January 5, 2009

General

- The notes are designed for investors who seek a return of twice the appreciation of each underlying in a weighted diversified basket of three international buffered return enhanced components, consisting of the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index, each of which is subject to a different maximum return as described below, at maturity. Investors should be willing to forgo interest and dividend payments and, if any Component Underlying declines by more than 10%, be willing to lose some or all of their principal.
- Senior unsecured obligations of JPMorgan Chase & Co. maturing January 5, 2009[†].
- Minimum denominations of \$50,000 and integral multiples of \$1,000 in excess thereof.
- The notes are expected to price on or about December 14, 2007^{††} and are expected to settle on or about December 19, 2007.

Key Terms

Basket/Basket Components: The notes are linked to a weighted basket consisting of three buffered return enhanced components (each a "Basket Component," and together, the "Basket Components", each linked to an international index (each a "Component Underlying," and together, the "Component Underlyings") as set forth below:

* The actual Maximum Return for each Basket Component will be set on the pricing date and will not be less than the applicable percentage set forth in the table above. The maximum payment at maturity, based on the percentages set forth above, is \$1,162.20 per \$1,000 principal amount note.

Payment at Maturity: The amount you will receive at maturity is based on the Basket Return, which in turn is based on the performance of the Basket Components. At maturity, your payment per \$1,000 principal amount note will be calculated as follows:
\$1,000 + (\$1,000 x Basket Return)

Basket Return: The sum of the products of (a) the Component Return of each Basket Component and (b) the Component Weighting of such Basket Component.

Component Return: With respect to each Basket Component, the Component Return will be calculated as follows:

Maximum Return: With respect to a Basket Component, a percentage that we will determine on the pricing date and that will not be less than the respective percentage set forth above under "Basket/Basket Components." For example, if the Underlying Return for the Dow Jones EURO STOXX 50[®] Index is more than 7.80%, the applicable Component Return will be equal to the applicable Maximum Return, or 15.60%*.

Underlying Return: With respect to each Component Underlying, the performance of the Component Underlying from the Starting Underlying Level to the Ending Underlying Level, calculated as follows:

$$\frac{\text{Ending Underlying Level} - \text{Starting Underlying Level}}{\text{Starting Underlying Level}}$$

Starting Underlying Level: With respect to each Component Underlying, the Index closing level on the pricing date.

Ending Underlying Level: With respect to each Component Underlying, the arithmetic average of the Index closing levels on each of the Ending Averaging Dates.

Ending Averaging Dates[†]: December 18, 2008, December 19, 2008, December 22, 2008, December 29, 2008 and December 30, 2008

Maturity Date[†]: January 5, 2009

What Is the Underlying Return for Each Component Underlying and the Corresponding Component Return for Each Basket Component Assuming a Range of Performance for Each Component Underlying?

The following table illustrates the hypothetical Underlying Return for each Component Underlying and the corresponding Component Return for each Basket Component. The hypothetical Underlying Returns and Component Returns set forth below assume a Starting Underlying Level of 4500, 6600 and 16000 for the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index, respectively, and a Maximum Return of 15.60%, 14.50% and 19.40% for the Basket Components linked to the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index, respectively. The hypothetical Underlying Returns and Component Returns set forth below are for illustrative purposes only and may not be the actual Underlying Returns and Component Returns applicable to a purchaser of the notes. The numbers appearing in the following table have been rounded for ease of analysis.

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the payment at maturity is calculated under various hypothetical circumstances. You should review the following examples in conjunction with the hypothetical table set forth on the previous page, including the underlying assumptions described on the previous page. The hypothetical payments at maturity set forth below are for illustrative purposes only and may not be the actual payment at maturity applicable to a purchaser of the notes. The numbers appearing in the following examples have been rounded for ease of analysis.

Example 1: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 4770, the FTSE™ 100 Index increases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 6930, and the level of the Nikkei 225 Index increases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 17280. Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and each of the Underlying Return of 6.00% for the Dow Jones EURO STOXX 50® Index, 5.00% for the FTSE™ 100 Index and 8.00% for the Nikkei 225 Index, each multiplied by 2, does not exceed the applicable Maximum Return of 15.60%, 14.50% and 19.40%, respectively, the Basket Return is calculated as follows:

$$[(6\% \times 2) \times 45\%] + [(5\% \times 2) \times 30\%] + [(8\% \times 2) \times 25\%] = 12.40\%$$

Accordingly, the investor receives a payment at maturity of \$1,124.00 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times 12.40\%) = \$1,124.00$$

Example 2: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 5400, the FTSE™ 100 Index increases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 8580, and the level of the Nikkei 225 Index increases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 22400. Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and each of the Underlying Return of 20.00% for the Dow Jones EURO STOXX 50® Index, 30.00% for the FTSE™ 100 Index and 40.00% for the Nikkei 225 Index, each multiplied by 2, exceeds the applicable Maximum Return of 15.60%, 14.50% and 19.40%, respectively, the Basket Return is calculated as follows:

$$(15.60\% \times 45\%) + (14.50\% \times 30\%) + (19.40\% \times 25\%) = 16.22\%$$

Accordingly, the investor receives a payment at maturity of \$1,162.20 per \$1,000 principal amount note, which reflects the maximum payment at maturity, calculated as follows:

$$\$1,000 + (\$1,000 \times 16.22\%) = \$1,162.20$$

Example 3: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 4950, the FTSE™ 100 Index increases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 6996, and the level of the Nikkei 225 Index increases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 17280. Because the Ending Underlying Level of each Component Underlying is greater than its Starting Underlying Level, and the Underlying Return of 10.00% for the Dow Jones EURO STOXX 50® Index multiplied by 2 exceeds the applicable Maximum Return of 15.60%, while each of the Underlying Return of 6.00% for the FTSE™ 100 Index and 8.00% for the Nikkei 225 Index, each multiplied by 2, does not exceed the applicable Maximum Return of 14.50% and 19.40%, respectively, the Basket Return is calculated as follows:

$$(15.60\% \times 45\%) + [(6\% \times 2) \times 30\%] + [(8\% \times 2) \times 25\%] = 14.62\%$$

Accordingly, the investor receives a payment at maturity of \$1,146.20 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times 14.62\%) = \$1,146.20$$

Example 4: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 4050, the FTSE™ 100 Index decreases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 5940, and the level of the Nikkei 225 Index decreases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 14400. Because the Ending Underlying Level of each Component Underlying is less than its Starting Underlying Level by not more than 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 5: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 3150, the FTSE™ 100 Index decreases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 5280, and the level of the Nikkei 225 Index decreases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 9600. Because the Ending Underlying Level of each Component Underlying is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 45\%\} + \{[(-20\% + 10\%) \times 1.1111] \times 30\%\} + \{[(-40\% + 10\%) \times 1.1111] \times 25\%\} = -21.666\%$$

Accordingly, the investor receives a payment at maturity of \$783.34 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -21.666\%) = \$783.34$$

Example 6: The level of the Dow Jones EURO STOXX 50® Index decreases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 3150, the FTSE™ 100 Index decreases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 5940, and the level of the Nikkei 225 Index decreases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 9600. Because the Ending Underlying Level of the FTSE™ 100 Index is less than its Starting Underlying Level by not more than 10% and the Ending Underlying Level of each of the other Component Underlyings is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 45\%\} + 0\% + \{[(-40\% + 10\%) \times 1.1111] \times 25\%\} = -18.333\%$$

Accordingly, the investor receives a payment at maturity of \$816.67 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -18.333\%) = \$816.67$$

Example 7: The level of the Dow Jones EURO STOXX 50® Index increases from a Starting Underlying Level of 4500 to an Ending Underlying Level of 4770, the FTSE™ 100 Index decreases from a Starting Underlying Level of 6600 to an Ending Underlying Level of 5280, and the level of the Nikkei 225 Index decreases from a Starting Underlying Level of 16000 to an Ending Underlying Level of 11200. Because the Ending Underlying Level of the Dow Jones EURO STOXX 50® Index is greater than its Starting Underlying Level, and the Underlying Return of 6.00% multiplied by 2 does not exceed the applicable Maximum Return of 15.60%, and the Ending Underlying Level of each of the other Component Underlyings is less than its Starting Underlying Level by more than 10%, the Basket Return is calculated as follows:

$$[(6\% \times 2) \times 45\%] + \{[(-20\% + 10\%) \times 1.1111] \times 30\%\} + \{[(-30\% + 10\%) \times 1.1111] \times 25\%\} = -3.489\%$$

Accordingly, the investor receives a payment at maturity of \$965.11 per \$1,000 principal amount note, calculated as follows:

$$\$1,000 + (\$1,000 \times -3.489\%) = \$965.11$$

Selected Purchase Considerations

- **APPRECIATION POTENTIAL** — The notes provide the opportunity to enhance equity returns by multiplying a positive Underlying Return for each Component Underlying by two, up to the Maximum Return of 15.60% for the Dow Jones EURO STOXX 50[®] Index, 14.50% for the FTSE[™] 100 Index and 19.40% for the Nikkei 225 Index. Accordingly, the maximum payment at maturity is \$1,162.20 for every \$1,000 principal amount note. The actual Maximum Total Return on the notes will be set on the pricing date and will not be less than 15.60%, 14.50% and 19.40%, respectively. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- **LIMITED PROTECTION AGAINST LOSS** — Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Underlying Level of each Component Underlying, as compared to the applicable Starting Underlying Level, of up to 10%. If the Ending Underlying Level of a Component Underlying declines by more than 10%, for every 1% decline of the Component Underlying beyond 10%, the Component Return for the Basket Component linked to such Component Underlying will be reduced by 1.111%.
- **DIVERSIFICATION AMONG THE COMPONENT UNDERLYINGS** — Because the Basket Component linked to the Dow Jones EURO STOXX 50[®] Index makes up 45% of the Basket, we expect that generally the market value of your notes and your payment at maturity will depend significantly on the performance of the Dow Jones EURO STOXX 50[®] Index.
The return on the notes is linked to a weighted basket consisting of three buffered return enhanced components, each linked to the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index, respectively. The Dow Jones EURO STOXX 50[®] Index consists of 50 component stocks of market sector leaders from within the Eurozone. The Dow Jones EURO STOXX 50[®] Index and STOXX[®] are the intellectual property (including registered trademarks) of STOXX Limited, Zurich, Switzerland, and/or Dow Jones & Company, Inc., a Delaware corporation, New York, USA (the “Licensors”), which are used under license. The notes are in no way sponsored, endorsed, sold or promoted by the Licensors and neither of the Licensors shall have any liability with respect thereto. The FTSE[™] 100 Index measures the composite price performance of stocks of the largest 100 companies (determined on the basis of market capitalization) traded on the London Stock Exchange. The Nikkei 225 Index consists of 225 stocks listed on the First Section of the Tokyo Stock Exchange and which, therefore, are among the most actively traded on that exchange. For additional information about each Component Underlying, see the information set forth under “The Dow Jones EURO STOXX 50[®] Index,” “The FTSE[™] 100 Index” and “The Nikkei 225 Index” of the accompanying product supplement no. 103-I.
- **CAPITAL GAINS TAX TREATMENT** — You should review carefully the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement no. 103-I. The pricing of the notes is subject to the delivery of an opinion of our special tax counsel, Davis Polk & Wardwell, that it is reasonable to treat your purchase and ownership of the notes as an “open transaction” for U.S. federal income tax purposes. The opinion will be subject to the limitations described in the section entitled “Certain U.S. Federal Income Tax Consequences” in product supplement no. 103-I and will be based on certain factual representations to be received from us on or prior to the pricing date. Assuming this characterization is respected, your gain or loss on the notes should be treated as long-term capital gain or loss if you hold the notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the “IRS”) or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. In particular, on December 7, 2007, Treasury and the IRS released a notice requesting comments on a number of possible U.S. federal income tax treatments for “prepaid forward contracts” and similar instruments. Any regulations or rulings promulgated after consideration of these issues might materially and adversely affect the tax consequences of an investment in the notes for both U.S. and Non-U.S. Holders, possibly retroactively. You should consult your tax adviser regarding the tax treatment of the notes, including possible alternative characterizations in general and the possible impact of this notice in particular.

An investment in the notes involves significant risks. 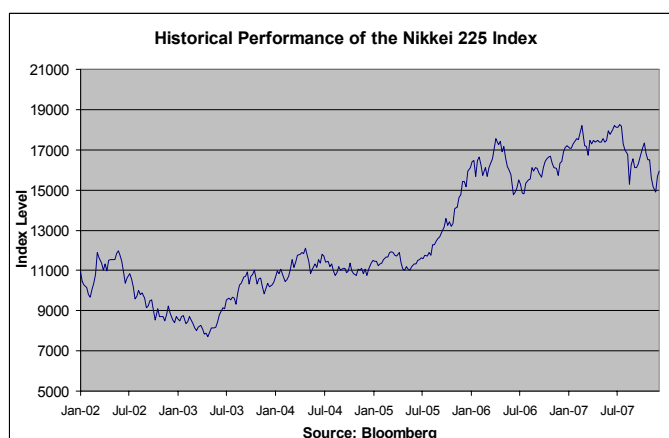
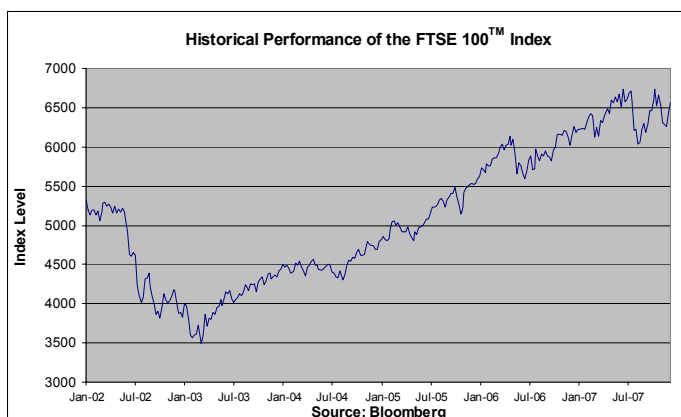
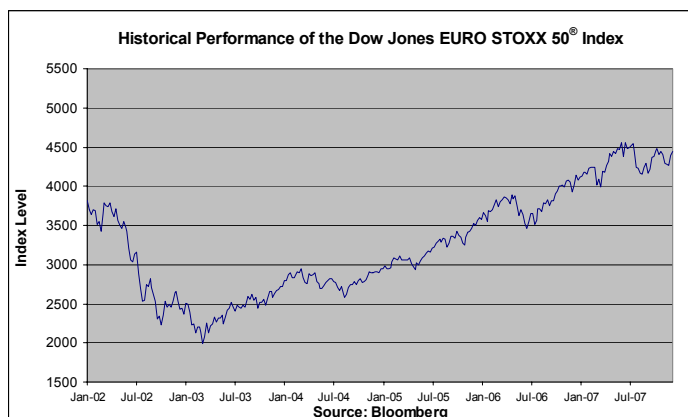
- **YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS** — The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Component Underlyings and will depend on whether, and the extent to which, the Underlying Return is positive or negative. Your investment will be exposed on a leveraged basis to any decline in the Ending Underlying Level for any Component Underlying beyond the 10% buffer as compared to the Starting Underlying Level.
- **THE COMPONENT RETURN FOR EACH BASKET COMPONENT IS LIMITED TO THE APPLICABLE MAXIMUM RETURN** — If the Ending Underlying Level of a Component Underlying is greater than its Starting Underlying Level, the Component Return for the Basket Component linked to such Component Underlying will not exceed a predetermined percentage, regardless of the appreciation in the Component Underlying, which may be significant. We refer to this percentage for each Basket Component as a Maximum Return, which will be set on the pricing date and will not be less than 15.60%, 14.50% and 19.40% for the Dow Jones EURO STOXX 50[®] Index, the FTSE[™] 100 Index and the Nikkei 225 Index, respectively. Assuming the Maximum Return for each Basket Component is equal to the applicable percentage set forth in the immediately preceding sentence, your payment at maturity will not exceed \$1,162.20 for each \$1,000 principal amount note.
- **CHANGES IN THE VALUES OF THE COMPONENT UNDERLYINGS MAY OFFSET EACH OTHER** — Price movements in the Component Underlyings may not correlate with each other. At a time when the value of one or more of the Component Underlyings increases, the value of the other Component Underlyings may not increase as much or may even decline. - **NO DIRECT EXPOSURE TO FLUCTUATIONS IN FOREIGN EXCHANGE RATES** — The value of your notes will not be adjusted for exchange rate fluctuations between the U.S. dollar and the currencies upon which the stocks underlying each Component Underlying are based, although any currency fluctuations could affect the performance of the Basket. Therefore, if the applicable currencies appreciate or depreciate relative to the U.S. dollar over the term of the notes, you will not receive any additional payment or incur any reduction in your payment at maturity.
- **LACK OF LIQUIDITY** — The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMSI is willing to buy the notes.

If our special tax counsel does not deliver this opinion prior to pricing, the offering of the notes will be terminated.
